CALLING OCCUPANTS We have done so many ground breaking shows, must listen to and ordinary shows, which has revealed so much on so many levels, that is difficult to grasp and understand for many. Often the gist behind the barrier to truth is, how far can a person go with it before the inevitable barrier raises it's ugly head, and the fear kicks in. This often then, leads to the receiver attacking and projecting at the messenger, and is a classic sign of being triggered by the truth, that is often hard to accept. All listening to our shows will have gone through several of those barriers at different intervals, but many of you have pushed on through them and come out of the other side, with a far clearer, if not pleasant at times, view of life and how things work on this planet. Some of the things we have covered are barely believable, some of the heinous acts done to and on us also, as peoples perception barrier of how bad the dark can be, where in all cases set too low, this is in essence a defense mechanism. The only way to overcome that defense is to keep listening, keep absorbing and keep connecting the dots. A common saying recently to me is, your shows enlighten me but also terrify me as if what your saying with your shows is, everything is a lie, the whole world view is a lie, politics and religion a lie, money a lie, and if that is the case that scares me shitless. That I get and understand, but no solutions can be provided to fix any situation, without knowing the full story and picture, that story and picture was denied to us for so long now, and has reduced us in terms of knowledge and dare I say it actions to the level of children. That is now being corrected and tonight I will present another deep topic, that strips bare much of the hidden world and knowledge denied to us all. This is not some made up story, this is an actual 100% bonafide proof document, all of it has been transcribed as not easy to read from giving it is an old document, and interjected with updated deeper levels of knowledge and background by myself. This is the real story of the Roswell incident and also the unknown crash that followed it, will all be revealed today and in a Part 2 to follow. WERE NOT ALONE

Before we begin the story and all the juicy details, one must go into the background of it all first, to then understand the flow of the narrative, and so we begin with the first topic of the classification of the security clearances. CLASSIFICATION The ULTRA-TOP SECRET classification utilized in this briefing paper is a Defense Intelligence Agency and Pentagon designation. Other agencies and/or departments of the various military and executive divisions will use another form of security level nomenclature. All accession is by Presidential Authority only and the following cross reference of departmental



designation is for the reader's information only. These are the clearance levels for each division. DEPT OF THE ARMY: Top secret, Red one (STA/R-1) DEPT OF THE AIR FORCE: Top secret SIOP/ESI or Top secret SCI DEPT OF THE NAVY: Top secret Ultra, level "S" or Code Four NAT. SECURITY AGENCY: Top secret Ultra or above top secret CIA: Top secret or red level alpha DEPT OF STATE: M.S Provision exempt/N.S.P.E Classified After the Eisenhower Presidency and his meetings in the early 1950's, with the off world entities on more than one occasion at Holloman Air Force base, the Presidents were all discounted after that and deemed too low in the security clearance to give them this level of information. Kennedy tried to change that in 1963 with an agreement with his Russian counterpart to release all ET and UFO related files down to government level. This in part was confirmed by the document signed by Kennedy one day later on November 12th 1963, to the Director of the CIA, requesting that the CIA release all of the files. It is also my understanding of why both JFK and Marilyn Monroe were killed. as her and JFK were taken to a base to view craft and bodies, and she began to talk about it too much. The Dept of Navy clearances were interesting, S and 4 are linked, the facility at Area 51 is known as S4 and referred to by Bob Lazar and others) Area 51 ceased as base of operations in 2013 following some interactions there, and operations moved to Area 52, known as Dugway, Utah. Tunnels exist between White Sands, Groom Lake, Dulce, Creede, Durango, Silverton and to Dugway all running under the Rocky Mountains have existed for a long time, Area 51 also links to Catalina Island, and is linked directly in to Atlanta also, which is then linked to the main shipping port in Georgia, which is Savannah. There are more miles of navigable tunnels below our feet than roads on the surface.

OBJECTIVES Operation Majestic 12 (majic12 or MJ 12 is a above top secret research and development/Intelligence operation, responsible directly and only to the President of the United States. Operations of the project are carried out under the control of the MAJIC 12 group, which was established by special classified executive order 092447 by President Truman on 24th September 1947, upon recommendation by Dr. Vannevar Bush and Secretary of Defense James Forrestal. Objectives of the Group includes the evaluation of risk, control and containment of the violation of United States air space, and of the national security by unknown and possibly hostile aliens, of one or more advanced races of beings presumed to have originated elsewhere than on planet Earth. The development of the effective countermeasures, and the application of any scientific or technical discoveries made during the operations, is also of the highest concern. The following are some established aspects of the situations. 1. Advanced beings of non



human nature are continuously being detected along with their flying disc craft in the controlled space of the US since 7th July 1947. 2. The remains of seven flying craft and the bodies of 27 deceased non human beings have been recovered as of this briefing date, and are at present being studied by MAJIC 12 scientists. 3. Three of the recovered craft are nearly intact and one such machine has maintained some of it's power since retrieval in 1948. 4. Since 1957, no additional alien craft have been available for study. The assessment is that these beings have adapted or perfected the machines to the conditions of our world, so as to avoid any further such revealing crashes. The reality is the truth got hidden deeper and deeper, as compartmentalization of the program reached epic proportions, out went the President and subsequently any congressional oversight view, and was taken over by the CIA, OSS, Paperclip crew and Zionist based scientists.

As for the history of the MAJIC-12 Group and it's membership and investigations, the complete records are available with proper clearance, through the Office of Counterintelligence of the Defense Intelligence Agency, and are on microfilm at this time. The written minutes, the transcript of all directorate meetings as well as a full record of all investigations in their original form, are located at the MJ-12HQ, codename of "bigger command" and situated at the decommissioned Mardon Air section at Flat Rock, Nevada. This site is now under the coveting authority of the Nuclear Regulatory Commission, the story having been circulated widely that this base is involved in, the long term monitoring of residual radiation levels that resulted from the A bomb testing nearby in the 1950's. With the exception of a monitoring task unit at Wright Patterson Air Force base, for the sending up of all sightings referred through the Dept of the Air Force, all gathering operations are now located at the Nevada site. Over a period of years, all recovered evidence from the crashed alien craft has been transported to underground storage at Flat Rock, making full use of the large complex of shelters built there starting in 1954. Scientific and technical research and analysis for MAJIC-12 is being conducted by aerosol planes around the country. Small monitoring task units remain in place within the command structure of certain other branches of the broad forces. These include NORAD in Colorado, and SAC in Nebraska and for reporting odd radar sightings, and SEACON in Virginia, and the command center in California for reporting of Naval encounters. The aeronautical research is being carried out by the Ardstone Arsenal in Alabama, and linguistic studies are conducted at NASA's Ames research center in California. A team from John Hopkins University and the National institute of Health, is deducing the biological and medical intelligence gathered by the project. Just as the title implies, MAJIC-12 is headed by a directorate of twelve persons chosen for life or until

retirement, six are military and/or administrative positions, and six are private sector scientists and engineers with long histories of governmental affiliations. All vacancies of the directorate are filled by a unanimous vote of tested directors. The President may recommend an appointment, but while all other questions arising lies with this office, membership on the MAJIC-12 directorate is exactly decided safely by that group. Such limitations of executive authority is a long standing historical decision based on the care of these positions, these twelve persons belong to a small family of highly skilled persons. Only from within such a family, is it possible to have a group of special clearance required, for this very specific type of work. It has been said by a former director of the group that a good understanding of alien minds, requires an alien mind. ORGANIZATION The organization structure of OPERATION MAJESTIC-12 is arranged into three tiers or levels, by order of a need to know information process, these are: DIRECTORATE: composed of twelve members sharing equal authority and complete access to all information. The President is accepted to be the thirteenth member of this body, as well as it's final authority. That ended after President Eisenhower. TASK UNITS: Composed of a variable number of scientific and information gathering groups and/or persons. The complete listing of current consultants in the sciences is available on request. Identities of Military monitoring units must be required through the directorate. ENFORCEMENT: Composed primarily of selected recruits from the Army Special Forces Command. These units are organized into Companies known as "Blue Berets", and are trained and supported by Air Cavalry units based out of DIGGER COMMAND in Flat Rock, Nevada. Purpose includes containment of tactical situations, control of public awareness, panic, evacuation etc. Originally created for the security of recovery sites during investigations and the transporting of sensitive evidence. The term Blue Berets is another confirmation that the ET disclosure and debunking program, was all under the color code program of Blue. Project Bluebook, Blue Beam, Blue Brethren group, Blue Avians, and so the color blue is designated as the program for off world entities, or in the case of those just mentioned distraction, lies and distortion of the facts, in particular the fake Blue Avian narrative pushed by paid operatives David Wilcock and Corey Goode. There is an Avian race more commonly associated with Thoth in the Egyptian hieroglyphs, they are Pleiadian's and the origin of the Nibiru planet and story, and no they were not good either, in terms of our interaction with them. So in respect of the term Blue Avian, is that blue is the color code for the ET program, and the Avians are one of the five groups that make up the Annunaki. For further evidence of alternative media misinformation program regarding Et's and UFO's, will be revealed in this next paragraph. Enforcement also includes a number of plain clothed operatives, whose



purpose is the spread of cover stories, to avoid public fears about the inability of the Government to control the situation, although quite why they always feel they need to control the situation is beyond me. These members also operate diversions for civilian investigators to discourage such efforts, so as to aid in control of public information and interest. The identities of the directorate, MAJIC-12 are held in strictest secrecy, they are known only to each other, and to the seated President of the United States. These names are to be never written down. The purpose and need for the highly covert and above top secret designation of this operation will become apparent with the study of the following reports, which led to the forming of OPERATION MAJESTIC 12. Since the time of these events, over forty years ago, the state of our sciences has advanced to the degree, that we may see a measure of short sightedness in the then, expedient actions of the administration. As a result of actions taken at that time, several sensitive developments have resulted which are of ever increasing concern to the National Security of the United States of America. National Security of the United States is a misnomer if ever there was one, and really it is a cover up act of covert and black budget operations by the CIA and others of their ilk, there is no national security for the people or the country. The National Security act just like the CIA formerly the OSS, was created due to the next chapter as you will all see. GROUND CONTROL TO MAJOR TOM OPERATION ROSWELL JULY 7TH 1947 On July 7th 1947 a secret operation was begun to assure recovery of the wreckage of an unidentified flying object, which had crashed at a remote site in New Mexico. The object was down approximately 75 miles northwest of Roswell Army Air Station, later renamed Walker Air Force base, and was reported to authorities there by a local rancher. During the recovery of the operation, aerial reconnaissance discovered that four alien like beings had apparently ejected from the craft at some time before it had exploded. These had fallen to earth about two miles away of the crash site where the wreckage was located. All of the four alien crew members were dead, and badly decomposed due to action of predators and exposure to the elements, during the approximately one week which had elapsed prior to their recovery. A special scientific team took charge of the removal of the bodies and the recovery of the wreckage of the craft. Civilian and Military witnesses in the area were debriefed, and any reporters were given the effective cover story, that a misguided weather balloon was responsible for the sighting. A cover analytical effort organized by General Nathan F Twining and Dr. Vannever Bush sitting on the direct orders of President Harry S Truman, resulted in a preliminary consensus on September 19th 1947, that the disc shaped craft was most likely a short range reconnaissance ship. This conclusion was based for the most part on the craft's size and the apparent lack of provisioning. A similar analysis of the four deceased



occupants was arranged by Dr. Detlev Bronk, it was the tentative conclusion of the group on November 30th 1947, that although these aliens are generally human like in appearance, the biological and evolutionary processes possible for their development, has apparently been quite different from those observed or postulated in homo-sapiens (earth humans). Dr Bronk has generated the term, since then widely applied, of Extra Terrestrial Biological entities, or EBE's for these creatures, until such time of a more definitive designation can be agreed upon. It was the opinions of the scientists involved in this investigation, that this craft and it's entities most certainly did not originate from on the Earth. The crash near Roswell occurred sometime in the evening of the 2/3rd of July 1947, at about 20.47 hours, at least two dozen persons in the area observed a bright yellow or sun colored disc shaped object over the area. On July 3rd 1947 in the early afternoon, the widely scattered wreckage was discovered by local ranch manager William Brazel, and also his son and daughter. The authorities at the Roswell Field Army Air Forces base were alerted by Mr. Brazel at 09.18 on July 7th 1947, and the two officers of the base were guided to the crash site by the ranch manager. These were Major Jesse Marcel staff intelligence officer of the 509th Bomb group Intelligence Office, and Captain Lee Cerns of the Counter Intelligence Corps. When the two officers returned to Roswell Field with samples of the crash site material, they immediately reported to Colonel William Blanchard of Air Tactical Command. It was at this point, that the first of many decisions were made, that have gone into the historical posture of this government's position, on the public's need to know about the situation. Colonel Blanchard released an official press statement confirming that wreckage of a flying disc had been recovered, this was phoned in to an Albuquerque, New Mexico radio station without approval from higher level command in the Army Air Corps. Indeed, no one in the Pentagon or anywhere else was notified or consulted prior to the release of this information, as a footnote the CIA was created just 9 weeks after this crash and they took over all investigations. In defense of Colonel Blanchard's actions, it should be noted that no established procedure on the issue existed at the time. There were no Office of Special Investigation, CIA, Nat. Security Agency, Defense Intelligence Agency or any other similar such organizations at that time. It should be noted that within less than two years following this incident, and as it's direct result, all of the above agencies were established, with the exception of the Defense Intelligence Agency which was chartered in 1961. At nearly the same time on the evening of 7th July, two events were taking the incident in widely different directions at widely separated locations. In Roswell, Major Marcel was ordered by Colonel Blanchard to load the debris onboard an aircraft and fly it to Wright Field (now Wright - Patterson AFB) at Dayton Ohio for examination. As this was being



done, a reporter from Albuquerque radio station, called to Wright Field to confirm the crash with the commanding general there. This was Lt. General Nathan Twining, Air Material Command, where any such reported incident should have been filled, in fact, the wreckage and all persons involved were already on their way to Wright Field. But this was the first that General Twining had heard of the matter, Twining was forced to state that he knew nothing of a crashed disc craft. Upon finally receiving verbal confirmation by open telephone line from Lt. Colonel Blanchard at Roswell Field, General Twining did three things rapid order in an effort to contain the situation. First, he sent special orders by secured teletype to Blanchard at Roswell, instructing them to do nothing and talk to no one until further orders from him. General Twining used the same system to contact general Roger Ramey, who was in command at Carswell Army Air Forces Base at Fort Worth, Texas, ordering him to direct Major Marcel to vector a meeting, for an intermediate stop at Carswell, which was on his flight path. General Ramey was instructed to A: remove the recovered debris off Marcel's aircraft and place it on board another in sealed craters to be forwarded to Wright Field. B: order Marcel and his crew not to talk to reporters C: notify the press of a photo conference to be held at Carswell were an explanation would be given D: state at the conference that the wreckage was only the remains of a weather balloon, and it's attached tinfoil radar target and prominently display created evidence of the same. Then return Major Marcel at once to Roswell Field, then General Twining to have an open teletype to the newsrooms at the two Albuquerque radio stations, to cease transmission of the original story, and to contact the Carswell office of Public Information of the correct release. Finally the General boarded a plane and flew directly to Roswell Field in New Mexico. At his arrival in Roswell, General Twining relieved Colonel Blanchard and took command, and ordered troops to set up a secured perimeter around the reported crash site. He then personally supervised the total policing of the area and removal of all remaining evidence, as well as the four day briefing of Major Marcel, and the six day debriefing of rancher Brazel, upon he was held incommunicado until the clean up was complete. The wreckage recovered at Roswell consisted of three hundred and twenty seven fragmented pieces of various structural debris. Most prominent among these were beams of many lengths, and ranging in diameter and thickness, from just over half an inch to just under two inches. These were found to be composed of a very light and porous metal alloy, composed of extremely pure aluminum, and silicon mixed with zirconium with a certain crystalline structure. The beams were flexible and were absolutely unaffected by both oxyacetylene and oxyhydrogen blowpipe torches. Several of these contained hieroglyphic and alphabetic markings of unknown type placed onto their surfaces. Also found were many



pieces of a metallic foil like material, presumed to have been the outer casing of the crafts shell or skin. Following the discoveries near Roswell New Mexico, it became obvious to the Intelligence officers working under the newly appointed Secretary of Defense James V. Forrestal, that a special operations group was going to be needed to coordinate the accumulation and dissemination of data on this subject.

The original directorate of the Group were as follows: Dr. Lloyd Berkner - Scientist and Executive Secretary of the Joint Research and Development Board in 1946 (under Dr. Vannevar Bush) Also headed the special committee to establish the Weapons Systems Evaluation Group. He was also Scientific Consultant to the CIA on UFO's during his years with MJ-12 Dr. Detlev Bronk - Internationally known physiologist and bio physicist, who was chairman of the National Research Council, and the Medical Advisory board of the Atomic Energy Commission. Chairman of the Scientific Advisory Committee of the Brookhaven National Laboratory. Dr. Vannevar Bush - Recognized as one of the United States leading scientists. Organized the National Defense Research council in 1941 and the Office of Scientific Research and Development in 1943, which led to the wartime establishment of the Manhattan project to the first atomic bomb. After the war he became head of the Joint Research and Development board, was responsible for the recommendation along with Secretary Forrestal to President Truman, that the Majestic 12 operation was required. Dr. Bush was a principle organizer of the efforts to bring many German scientists, including Albert Einstein to the US before and after the war. The last snippet is the evidence I mentioned earlier, all those involved in this were the Paperclip crew which increased rapidly after this event, involving all the Zionist led Black Eagle SS group out of Germany and other regions close by. The name Bush one wonders if that is some sort of title, some European nobility come under the name of Ramses- Piso- Bush, Vannevar has no relation to the two Georges who became President here, despite a government ruling denying the Bush family from engaging in anything related to the American government, after the treasonous acts by their father and grandfather Prescott Bush. It was also be noted that Bush is not their original name it was Scherff, involved in and with the SS, and that George Snr. it is reputed was the son of Nicola Tesla's accountant. Either way this name Bush looks more and more like a title, than an official surname. James V Forrestal - Served as Secretary of the Navy before he became Secretary of Defense under Truman in July 1947. Among his first acts as Defense Secretary, was the responsibility for organizing the crash recovery of the flying disc from Roswell, New Mexico, which occurred the same month he took office. He was the first to approach President Truman about the need for an operation like MJ-12, and

was in charge along with Dr. Bush, of setting up an International Intelligence gathering organization to monitor world wide UFO activity. The results of these effort would grow to include the CIA and NSA, both of which were founded shortly after the Roswell and Aztec crashes, that decision set this country on a path to totalitarian control with the implementation and creation of those two agencies, neither of which have any benefit for the people or the country of America. Both used the National Security act to their full advantage, and cover up serious crimes they took part in around the globe. This next portion is an all too common occurrence when the CIA is involved in anything as well. As a direct result of the circumstances surrounding the Aztec, New Mexico recovery, Secretary Forrestal suffered a mental breakdown in March 1949 and was admitted to Bathesda Naval Hospital under the cover story of needing a routine physical check up. Bathesda Hospital is a CIA MK Ultra mind control facility. While he was at that facility, he is supposed to have committed suicide by jumping from an upper story window in May 1949. A special committee of counter intelligence of the CIA later concluded that the highest probability his having been either drugged, tricked or pushed to his fatal fall. Frank Olsen died in the exact same circumstances and alleged involvement of the CIA and these two cases being murder, not suicide persist to this day. Perhaps this official CIA document of assassinations will give you more clues or ideas of what took place. 2. Accidents For secret assassination, either simple or chase, the contrived accident is the most effective technique. When successfully executed, it causes little excitement and is only casually investigated. The most efficient accident, in simple assassination, is a fall of 75 feet or more onto a hard surface. Elevator shafts, stair wells, unscreened windows and bridges will serve. Bridge falls into water are not reliable. In simple cases a private meeting with the subject may be arranged at a properly-cased location. The act may be executed by sudden, vigorous excised of the ankles, tipping the subject over the edge. If the assassin immediately sets up an outcry, playing the "horrified witness", no alibi or surreptitious withdrawal is necessary. In chase cases it will usually be necessary to stun or drug the subject before dropping him. Care is required to insure that no wound or condition not attributable to the fall is discernible after death.

The presumed reason for this involves details of the Aztec crash which will follow in that section. Gordon Gray - Assistant Secretary of the Army at the time of MJ-12 Initialization and Secretary of the Army in 1949. In 1950 he was appointed as special Assistant on National Security Affairs to President Truman. In 1951 headed the psychological Strategy board for Unidentified Flying Object Impact (PSBUF01) under CIA Director Walter Bedell Smith. Vice Admiral Roscoe Hillenkoetter - 3rd Director of



Central Intelligence (DCI) from 1947 to 1950. Founding Director of the CIA established in September 1947 to direct International information gathering on UFO's. Was covertly placed on the board of directors of the civilian UFO organization, National Investigation Committee on Aerial Phenomena (NICAP) to monitor their activities and control of the release of their information to the public. Was forced to take an early retirement after he broke security making the public statement that UFO's were real, and through a process of official secrecy and ridicule, many citizens are led to believe the unknown flying objects are nonsense. In defense of his position, it must be noted that by this time, the events of the Aztec, New Mexico recovery and the death of Secretary Forrestal had depressed and demoralized most of the original members of the investigating group. By 1951-52 MJ-12 had to be entirely reconstructed due to the feelings of many of the directorate that the public had a right to know the facts, reconstructed in their world often means they were assassinated. Dr. Jeremy Hunsaker - Aircraft designer and head of the Departments of Mechanical and Aeronautical Engineering at the MIT. Chairman of the National Advisory Committee for Aeronautics, was in charge of studies of the machined portions of the debris recovered from the crash sites. Expert in X-ray microscopic metals analysis. Dr. Donald Menzel - Director of Harvard College Observatory and a consultant to the NSA on Astronomy, he held a Top Secret Ultra clearance. Who knew the NSA had a division for Astronomy? but then who knows why they NSA actually exists to begin with, when we have 16 other agencies here, the majority of which is duplicated and triplicate work. As the British OSS morphed into the CIA, the British GCHQ was morphed into the NSA, as a subsidiary of GCHQ based organization. General Robert Montague - Base Commander at the Atomic Energy Commission Installation at Sandia Base, Albuquerque, New Mexico from July 1947 to February 1951. Was reassigned and transferred following a heated disagreement over National Policy of MJ-12, regarding sightings around nuclear research facilities. He felt the risk to the public health was of greater issue, than security and control of the situation. Rear Admiral Sidney Souers first Director of Central Intelligence (DCI) from January - June 1946. Upon initialization of MJ-12, he became Executive Secretary of the National Security Council, in order to control domestic security of UFO information. Following the Aztec, New Mexico recovery and related actions, Souers resigned (1950) his positions in national security and his commission in the Navy. He was retained as a consultant on security to the Executive Branch. General Nathan Twining - The principle "ramrod" for high security in the matter of Unidentified flying objects, and an opponent of scientific release of data or the involvement of civilian scientists. Twining was an outstanding commander of bombing operations in both the Pacific and European theaters in World War 2. In 1945 he was



appointed Commanding General of Air Material Command, based at Wright Field, now Wright- Patterson. Organized Project Sign and Project Grudge, later became Project Blue Book to control and discredit civilian sightings and civilian investigations, and you all thought Project Bluebook was about disclosure. Chief proponent of covert investigation and clandestine contact attempts, regarding UFO's and the EBE's. General Hoyt Vandenburg - After an outstanding career in the Army Air Forces was appointed the second Director of Central Intelligence in 1946 until May 1947. Following the Aztec, New Mexico incident, he joined General Twining in supporting the sensitive nature of releasing any UFO information to the public. When the Air Technical Intelligence center published its Top Secret "estimate of the situation" indicating the belief that UFO were interplanetary in origin in August 1948. General Vandenburg ordered the document burned before it could be distributed to government scientists with the required clearance. This was directly related to the outcome of the Aztec investigation which began in March of that same year. It is possible to disclose the identities of the original MJ-12 directorate because they are now all deceased. It is necessary in order to understand the climate of confusion and anxiety resulting from the second recovery incident at Aztec, New Mexico in 1948. Just when you thought you have heard it all, the next part reveals more and you ain't seen nothing yet. YOU AINT SEEN NOTHING YET

Most of you all listening to this show will be familiar with the Roswell incident in July 1947, but what is less known is the second recovery of a craft just outside the village of Aztec, New Mexico and approximately 10-15 miles from the Southern border of Colorado. This next part will cover the Aztec, New Mexico on 25th March 1948 crash incident. On March 25th 1948 at approximately 16.19 hours, Mountain Standard time, a disc shaped flying machine came down about 12 miles northwest of the small community of Aztec, New Mexico. The controlled landing occurred in a small desert canyon, on the private grazing land of a local farmer and rancher. The approach of the disc was tracked with the aid of 3 high powered missile tracking radar stations, belonging to the recovery network of the White Sands Test Range, and located in classified areas of southwest New Mexico. The disc craft was first observed in violation of the restricted air space of this facility. The disc was flying on a level glide path, and on a heading from the southwest to northeast at about 3200 feet altitude when first detected. This track detections resulted in an Air Defense Command Alert, that include the scrambling of squadrons of jet interceptors, from the nearby Sandia and White Sands bases. Also per a recent memorandum issued through Operation Majestic, the Commander in Chief of Air Defense Command (CICADC) immediately notified Secretary of State General George



C. Marshall. At 17.53 hours MT the disc craft appeared to lose both speed and altitude, at nearly the exact moment that it was triangulated by returns from all 3 radar dish antennae, in an effort to vector the interceptor squadrons towards their target. At the time it seemed to be an evasive tactic on the part of the disc craft. The current assessment is that the microwaves from these long range radars, almost certainly evidenced a damage to the power or flight control systems of the disc craft. At 18.02 MT, the craft dropped below radar some four minutes, before the White Sands jet squadron would have reached intercept point and engaged to disc craft. Estimates later indicated the disc craft impacted or landed at approximately 18.19 hours MT. The exact position of the landing zone was determined within minutes, by calculation of the last radar triangulated tracks, and confirmed by a visual fly over of interceptors from the White Sands base. The landing zone was at the bottom of Hart Canyon, a dry wash area about 12.2 miles northeast of Aztec New Mexico, and 2.3 miles northwest of the Cave Creek bend in the Animus River. This was on private land about 1.7 miles north of the state highway and nearly 1/2 mile west of unpaved county road S-141 south. At 18.26 hours MT on 25th March 1948, the crash site was visually confirmed by the commander of the 152 tactical fighter wing, and relayed to the Air Defense Command Officer at Sandia Base, Albuquerque, New Mexico. This information was conveyed at once to the CICADC who contacted the Secretary of State Marshall. By 18.35 hours MT, General Marshall had made contact with the Army Air Forces Interplanetary Phenomenon Unit, a section of the Army Counterintelligence Directorate. The IPU was maintained and supported out of nearby Camp Kobe, Colorado and was the closest group able to secure, recover, transport and store a disabled disc craft. This action was entirely correct in the interval before a MAJESTIC operation could be activated, and the preparations of the IPU group while awaiting a MAJICOPS crew saved valuable time. The IPU was forced out after the Roswell, New Mexico crash recovery, and was later absorbed into the enforcement division of OPERATION MAJESTIC, at the time that the Department of the Air Force, was established as an entity separate from the US Army. The disc craft was recovered and the landing zone declared secured by 22.45 hours MT, through the actions of an IPU scout team sent to the Hart Canyon area. Meanwhile General Marshall had contacted Dr. Vannevar Bush the scientific head of MAJICOPS, and a joint IPU/MAJICOPS team was assembled under MJ-12 command, for the purpose of investigating and clearing the landing zone or crash site. The local rancher who owned the land and property were held incommunicado, while the field analysis and subsequent clean up was conducted at Hart Canyon. Visiting with the rancher at that time and place, was people to hunt for game animals on his land, they were the owner of a local radio repair shop, plus an unemployed



oil hunter and inventor. These last two parties were later to get together, and tell their story to a columnist from Variety magazine named Frank Scully. This author later published a book in 1950 detailing parts of the Aztec recovery story. This breach of security was askewed by the use of a cover story for the IPU/MAJICOPS work that proved to be ineffective. It was decided to disguise the Aztec efforts, as an exploration for oil by a fictional drilling company, a fact that was not in agreement with the knowledge of the unemployed oil hunter, who knew that there was no oil in the area. Later both this independent oil hunter and the columnist Scully, were discredited by facts leaked to a writer at True magazine, by covert operatives of the MAJESTIC enforcement division. This action was unfortunate, but very vital in light of the sensational nature of the Aztec discoveries. Fortunately Scully labeled this fortune hunting oilmen as a scientist in his book, and during the period of the books sales, this adventurer was convicted of fraud for trying to peddle a device, he claimed would find oil, mostly by luck, the security breach healed itself and the book was quickly forgotten with only minor help from MJ-12. This is what has gone on since these craft started landing, deliberately or otherwise, a select few can know, and the rest of world who have had valid sightings and experiences, are all declared frauds, criminals, jailed, sent to mental facilities, discredited, killed or ridiculed beyond all reason within their own circle. This is why I have a healthy dislike the anti disclosure elements within the UFO community like Wilcock, Goode, Greer and many others. The life long damage done to people who have had these experiences, which is deeply disturbing in many ways in and of itself, only to have these self appointed jackasses add whole new levels of turmoil to people who have had genuine experiences, is beyond unforgivable. That evening of 15th March, General Marshall ordered ADC off of alert status, and requested that they send teletypes to the radar stations, advising them that there had been a false alarm. Time was an important factor here since the disc craft had landed intact, and had the appearance of having been landed under the control of it's operators. No signs of entry was immediately observed, and the IPU scout team considered it possible that some of the crew, of the disc craft might still be alive inside it. At 01.26 hours MT March 16th, the team of MJ-12 scientists assembled by Dr. Bush, arrived at Durango Air Field Colorado about 35 miles northwest of Aztec. All operators of the teams of IPU and MAJICOPS investigators were then sworn to an Ultra Top Secret security oath. All personal property and identification was left in location at Durango, and the three unmarked trucks headed for the Hart Canyon site. It must be remembered that the helicopter was still in experimental development at this stage, and trucks were the best means of entering rugged terrain, as well as the fact that they would cause far less attention than the noisy and unfamiliar helicopter, which

was however used to bring in the initial IPU scout team. In order to fully follow the course of the Aztec recovery and investigation, it is important at this point to detail the names, and the grounds of the members of the IPU/MAJICOPS team, before returning to a chronology of the events at Hart Canyon. Only four of these persons were on the MAJICOPS directorate. These were Dr. Lloyd Berkner, Dr. Detlev Bronk, Dr. Vannevar Bush and Dr. Jerome Hunsaker. The following were selected by the MJ-12 directorate to accompany the IPU/MAJICOPS team to the Hart Canyon landing site: Dr. Carl A. Helland: Director and senior scientist of the Geophysics and Magnetic Science Laboratory of the Colorado School of Mines. Was instrumental in discovering that sections of the Aztec disc craft, were held together by molecular magnetic bonding along finely polished seams, and determined a means for it's disassembly. Dr. John Von Neumann: Former consultant on the Manhattan Project in 1943 and a close personal friend of Dr. Bush and Oppenheimer from the same project. Expert in both mathematics and computing machines. His work on the Aztec disc eventually led to the binary computer language used today in all modern electronic computers, hmm so ET's created the 1's and 0's then, just who will become clear later. Dr. Robert J Oppenheimer, was Director of the Institute for Advanced Studies at Princeton University from 1947, after a distinguished period of service during the war at head of the Los Alamos atomic bomb project. Also, was Chairman of the General Advisory Committee of the Atomic Energy Commission. Acting for his friend Dr. Bush, who had not yet arrived at Aztec, he selected most of the recovery team members, and arranged with the US Navy for storage in their facilities at Los Alamos, while permanent sites could be prepared. Dr. Johann Von Roesler: an expert nitrogen chemist whose work led to development of Nitrogen Mustard Gas, Nitro-glycerin derivatives leading to TNT and worked with Dr. Bush and Oppenheimer on triggering devices for the atomic bomb, nice chap then? not. Originally included as a consultant on the possible need gain forced entry to the disc craft by use of high explosives, he eventually worked with Dr. Detlev Bronk on investigating the liquid nitrogen coped cryogenic suspension system used aboard the disc craft by it's crew members. Dr. Merle A. Tuve worked with Bush and Oppenheimer for the Office of Scientific Research and development, Manhattan Project during WW2. Top pioneer in radio wave propagation in the upper atmosphere, sounds like HAARP developer to me. Later was part of the Bell Laboratories team which developed the principles of laser light physics, derived from study of systems found aboard the Aztec disc craft. Dr. Horace Van Valkenberg, was director of the school of metallurgy at the University of Colorado, an expert in analytical chemistry. Was useful in determining proper materials, including of components of the Aztec disc craft during the investigation and disassembly. Later



pioneered science of X- ray crystalography, crystal holography and electron microscopic metals analysis as well as the holder of 30 patents through Arizona State University in metal alloy processes. Most of the above were the result of research he began after his analysis of the structural materials of the disc craft. Yes and another reason for this level of secrecy, is so these self appointed people can and have gained extensive advanced technology, ideas and patents for their own self greed. Given the vast sums of money handed over by the tax payer, various agency and NGO's created all harvesting vast sums of the American tax payers money and subsequent government budgets, the public have received little to nothing in a way of a return on their funding. Not only that, endured endless lies and ridicule, and also had most of the technology garnered from these events made available to the public, weaponised against us to boot. The cost of these operations must run into multi trillions of dollars by now, and many rights and freedoms trampled all over to keep this a secret. Although not present during the recovery phase of the Aztec operation at Hart Canyon, it is important we acknowledge the contributions made later by Lambros Calthamos and William Friedman, who are experts in language and cryptology and whose analysis of the writings and symbols found aboard the craft, led to a degree of understanding of the cryogenic suspension system used to freeze the ships occupants. Also, Paul A Scherer whose supply of refrigeration and nitrogen cooling and pumping equipment helped greatly in the part of, of the suspended occupants aboard the disc craft at the field laboratory set up at Los Alamos. Both Calthamos and Friedman went on to work for OPERATION MAJESTIC for many years, in our Covert Operation Section of the Enforcement Division as deep planted agents with the NSA. Dr. Scherer led an illustrious career as Research and Development Director for Air Research Corp. The IPU/MAJICOPS convoy took routes to the Hart Canyon site that avoided main roads, and on arrival they set up road blocks, and secured a 2 mile perimeter around the canyon rim and landing site. In exchange for his silence, private land was leased from the farmer who owned the field in Hart Canyon, for the construction of a controlled access road to and from the area. Equipment carrying trucks were camouflaged to look like oil and gas drilling rigs, and personnel involved wore coveralls, with the name of a fictional oil exploration firm created by MAJICOPS for this purpose. Later a fence was constructed around the perimeter of the canyon and bore the name of the oil company, and warning of blasting on signs attached to it. When the time came for the removal and restoration of the site, trucks were used that were labeled high explosives and were escorted by Blue Berets or National Guardsmen. The cover story which was very effective in keeping the expious away, was spread that these trucks were removing large amounts of nitroglycerin, used in blasting during oil explorations. This was the reason given for the

National Guard escort, that the governor of the state requested the escort to avoid the theft of the explosives. Shortly after sunrise on March 26th 1948 the IPU/MAJICOPS team began operations at the Hart Canyon location. Measurements of the radiation levels around the craft and the landing site were taken and proved negative. Some high concentration of potassium chlorate powder was detected in soil samples surrounding the disc craft. A fine yellowish dust composed of particles less than 5 microns in diameter was detected, coating the nearby underbrush. Chemical analysis showed that this was composed of sulfurous substances in an unfamiliar combination having a bivalent, rhombic crystalline structure and was mixed with an unknown and extremely highly electro-positive element in the Iodide group. It is now known that this was a form of disinfectant automatically discharged by the craft upon any touch down to a planets bioactive soil, an environmentally friendly craft, there is a novel idea NASA. Linear calibration surveys were taken by theodolite (surveyors transit) and photographs were taken from every possible angle with a Graflex 4" x 5" plate camera, equipped with special calibration overlay masks to register dimensions on the films. The ship was determined to be 99.983 feet in diameter, 42.638 feet in height or thickness, including the 9.451 foot extension of the landing pods supporting it off of the ground. These three round, hemispheric pods beneath the craft had obviously been extended from within the hull during a controlled landing effort. These were measured to form the points of an equilateral triangle 22.3 feet on a side, center to center and were 16.45 feet each from the epicenter of the crafts bottom hull. Both upper and lower hull surfaces were smooth with no means of entry, or even of propulsion immediately in evidence. The hull was the color of dull, unpolished aluminum and was apparently metallic in nature with a normal surface temperature. No seams, hatches, rivets or portholes were obvious, photographs taken closer than 15 feet were found to be blurred. Later, both infrared and magnetic radiation fields were found to surround the craft, and were no doubt responsible for fogging of the films in close photographs. Watches and other ferric tools and instruments left within this zone around the craft, were found to become magnetized. Eventually the team crawled across the upper hull surface with access by a scaffold erected around one side of the craft. Upon conducting a close examination, they discovered a small, hairline crack at the base of a slight bulge in the domed top of the upper hull. Careful study determined this crack to be irregular enough as to be a result of accidental impact with a solid object (much later a civilian witness was debriefed in Albuquerque, who testified that he observed the craft strike the side of a cliff, along the south bank of the Animus River, at about the same time the saucer ship dropped below radar). After banging on the hull and calling through a loudspeaker failed to receive any response from the presumed



occupants of the disc craft, it was decided to attempt to widen this crack in an attempt to gain entry. INSIDE

At first the discussion was held as to the possibilities of the craft's internal atmosphere being explosive, or that air could be poison for the occupants to breathe. Finally Dr. Bush waived all such debate, on the grounds that if some action was not taken immediately, any chance for survival of members of the ship's crew would run out with the passage of time. First try with blowpipes was applied in excess of 10k degrees, and finally a diamond tipped drill bits were used, until the crack was at last extended longitudinally, and finally widened into a gap great enough to shine a small electric light inside and look around. Another plate of material of similar construction seemed to be solidly blocking the view. However at a seam along the bottom of the panel, another breach was located. It was then assumed that the craft was constructed of both an inner and an outer hull separated only by a few inches. After many minutes more of effort, the drill broke through into another empty space. Upon extending this opening and looking in, the research team were surprised to discover the interior to be well illuminated with sunlight. It was discovered that the original opening was forced at the lower corner, of a sort of large rectangular window or porthole which had been cracked. These portholes were not visible from the outside, but were extended all the way around the compartment in huge curved rectangles, and separated by only a thin structural brace between them. The exception was the cracked one by which the team gained entry, it had turned a milky translucent color like frosted glass. Later testing showed that the entire outer hull was covered in this transparent material, that was then blocked off by an opaque inner hull where desired by the ship's designers. This was a thin and inflexible skin barely thicker than 4 sheets of typing paper, and yet direct blows from sledgehammers would not dent or rupture this foil like substance. After experimentation with a long thin rod to probe at what looked like levers or buttons inside, a panel in the lower hull extended down along what seemed like invisible seams, and became a ramp leading up into the craft. When calling out provided no reply, the team obtained flashlights and other equipment and entered the disc craft. The greatest discoveries were made on the lower level, dubbed the cargo hold, but the team of investigators did not immediately find the closed door or hatch to this compartment. Instead they found themselves in a small circular chamber about the size of an elevator cab, a spiral ramp of very steep incline led us around a center post to the upper chamber, dubbed the flight deck. Since the team had already observed some details of this upper chamber, and had observed the bodies of 2 small creatures slumped in chairs, it was decided to investigate these first in case they might be



alive. Inside the upper cabin room the team found the bodies of 2 small humanoids about four feet in height and strapped into seats like those in a jet cockpit (acceleration couches) which faced a row of instrument panels, built into a curved countertop circling the cabin just below the portholes, they had seen from outside. The extraterrestrials were then determined to be dead. Later study determined that the normal atmosphere inside the cabin was much thinner and colder than our air. When the crack in the window frame happened the 2 pilots died from sudden increase in pressure and temperature, which caused thin hemorrhages like bruises, and gave a brownish hue to their skin, that at first seemed like burns. The seats holding the bodies were found to adjust to fit almost any human form, and to glide around a track in the floor that followed the instrument panels. The group soon recognized that the instrument panels were active and some symbols were backlit by a blue green glow, some of these were changing as they watched. At this point Dr. Oppenheimer consulted with Dr. Von Neumann and suggested that the team proceed with extreme caution, since the craft was obviously still under some form of power, and it might be activated from within or without by radio control. Dr. Tuve suggested that the team should explore the construction of the controls rather than attempt to operate them, on the chance of being able to trace the power to it's source, and deactivate same, until some understanding of the purpose of each instrument could be determined, this was agreed upon and the work began. Among the first discoveries was that each panel of instruments in the flight deck countertop, slide out like a drawer along invisible lines less than 0.2 millimeters wide, and in a track or rail composed of a single strip of plastic wrapped in a continuous S curve, around 2 metal rollers at the front and rear. There were no ball bearings, springs or motors, and yet each drawer slid both open and shut at the slightest touch of a finger tip as if self powered, later it was found that the rear roller bar traveled back and forth on a track of it's own as the drawer was operated. This second track was curved so as to balance the force imported by the bond in the plastic strip, and thus created an almost frictionless mechanism. The type of plastic was then unknown to earthly science, but has since been developed and has what is known as molecular memory of it's ideal unstressed state, to which it will naturally return. Later it was determined that each section of the controls or instrument board, this craft was self contained as to it's power needs, by some means integrated into it's nuclear structure that gathered electromagnetic and other energy from the space around it, in this case the fields of the Earth. There was no control power system anywhere on the ship and the control, flight and environmental systems drew their power from unknown sources. Instrumentation was eventually found to interconnect and communicate with each other on the molecular level, by means of waves or vibrations set up in the atomic structure of

each device, no wires or other recognizable electrical components were found. The sections of the saucer hull which contained both upper and lower deck cabins, were joined along microscopic lines by means of electromagnetic locking action, engineered into their molecular structure. When Dr. Bush and a team of military engineers found several interlocking key like devices in a cabinet built into the wall, Dr. Helland determined that these could be used to dismantle the craft into sections. At the joints, the operator of the keys which linked together for different sized tasks, simply passes the tool over the seam. The device which looked like a tuning fork and had each time magnetized with opposite polarity, unlocked the joint when passed over it in one direction, and rejoined the sections when it was drawn in the other direction. Even after disassembly and prolonged storage, the separate sections of this craft still maintained their power and operating capabilities to this day. All attempts to alter the magnetic fields that connect sections of the craft, performed with the use of powerful electromagnets under exacting laboratory conditions, have failed to change the degree of the interlocking effect. Also, kinetic force (repeated blows) has failed to alter molecular magnetic alignment, according to crystal holographic imaging units recently conducted. The entire inner hull structure was built over a light weight framework of flexible beams supporting the two front cabins, and formed into pie shaped equal thirds around a single central shaft or pole running through the thickness of the craft, and connecting the upper and lower outer hulls which was divided into equal thirds. The pole running through the saucer was about 41 feet long, and about 16 inches in diameter, It was a perfect cylinder of a solid carbon/zinc alloy. When maintained or stored in a vertical position, this pole has no special power capability, but when laid down at The Hart Canyon site on it's side, the pole began to drain electrical current from machines, generators and batteries, and to broadcast a powerful magnetism which damages sensitive instruments and magnetized tools, so for safety purposes it had to be transported in an upright fashion. Many other discoveries were made, including three different styles of writing, first a form of symbolic pictographs, second an alphabetic style of pictograph which seemed to break down the complex drawings into words, and third a form that looked like the raised symbols in the Braille lettering for the blind, but was different. Much later Calthamos and Friedman showed this last form to be a sort of mathematical code based on binary counting, and read from right to left like Hebrew. Oh my binary and Hebrew connotations, mathematical code which is Gematria, all of which stemmed from the off world group, and connected in particular to one group, to which the Hebrew language, traditions, books and religions all emanated from, the Annunaki. But the most important discoveries were made on the lower level cabin, which the team labeled the cargo hold. While

attempting to take apart some of the panels in the lower entry chamber, the team discovered a hatchway, that disappeared so well when closed that they overlooked it earlier. It was opened and closed by touching a pictograph lower down and the wall beside it. This was curved to match the walls of the main chamber, it was first called the central chamber and later, it was found it had no frame around it. The mechanism had no motor and worked similarly to the wheel less magnetic levitation railroads, we are currently planning to construct, a technology adapted by study of this door mechanism. There is more disclosure of the alleged underground Maglev trains all running at mad speeds below our feet in an extensive network, that to my understanding also runs under the Atlantic. This is why you hardly ever see any so called famous people traveling to and from country, and a further example of the people paying for everything and getting no use or benefits from it. The entire airlock chamber rotated like a geared cylinder inside another type cylinder, that formed a center core the heart or center of the lower cabin, until the two openings in the two cylinders lined up, the material was so thin that the opening in the inner wall nearly went unseen. Inside the cargo hold were found a number of what appeared to be scientific work table and medical examination tables, ah the dreaded tables feared and tortured for the rest of their life by, whilst authorities declare it is all a figment of your imagination, perhaps the smoking gun will be revealed on that here as well. Just as Dr. Bronk was about to suggest that the cargo routinely carried, might be a biological or non human use, Dr. Van Valkenburg found 14 small tube like chambers, buttressing the wall beside a clam shell couch, that looked like it would close to contain a human body. This couch was fitted with hoses for filling it with some liquid or gas, when the two sections would come together and seal. A closer look at the sealed tubes which looked like doors of clothes dryers at a Laundromat, revealed that they were a complex form of refrigeration system. Two tubes were empty and twelve contained the bodies of what looked like human adults and small children, as well as infants, all frozen as if preserved for specimens. The decision was made to remove these from what had now been nicknamed the "smoking gun", and pack them on ice for preservation until a later could determine, if they were aliens or abducted Earth humans. And there you have it the smoking gun and the potential the bodies were abducted Earth humans, that is full on disclosure right there. In the process of transferring the frozen EBE bodies from their capsules in the cargo hold of the disc craft, to containers of dry ice for shipment. Dr's Bronk, Von Rossler, Scherer and two Army pathologists from the IPU, were amazed to discover that one of the small humanoid adults, similar to the pilots found deceased on the flight deck, had thawed out with a pulse, had limited respiration and had lived in an unconscious state for several minutes before expiring. The shocked scientists then



realized the capsules were actually cryogenic suspension chambers, and that the EBE's were still technically alive inside them. Although this concept was almost unheard of in western medicine at this point in time, Dr. Bronk dimly recalled reading about secret experiments conducted in Nazi concentration camps during the war, what a liar Dr. Bronk and the Nazi experiments knew exactly what they were, due to the Nazis working with the highly malevolent Aldebaran group, and in part whether coerced or not, the Vrill group. Such experiments had centered inhumanely on the suspending of the vital life signs and their reanimation, by freezing and thawing of the bodies of inmates, who were used against their will like laboratory animals. That inhumane suspending of the vital life signs and then reanimation is also performed on the public to this day, via MK Ultra style research labs and facilities. By this time the scientists had determined, that each section of the ship was able to maintain some operating power even after disassembly, a test showed this to be true for the cryogenic capsules as well. Due to the lack of proper facilities at the landing site, and the lack of secured holding area for any living EBE's or convalescent provisions, it was decided to remove the entire cryogenic section of the craft, and to relocate to better research and medical laboratories on a military compound of some sort, before attempting to restore any of the EBE's to consciousness. The story was quickly circulated that, yes bodies had been found, all deceased and that these would be removed for later analysis. The bodies of the two small pilots were shown to some other members of the recovery team who had heard about them, and then sealed in dry ice chambers, as was the corpse of the EBE who had expired in the cargo hold after thawing. A big display of this was carried out in full view of the other team members, and other dry ice transportation capsules were secretly loaded with dirt and stones, before the entire group was loaded into a refrigerator truck, labeled high explosives for transport. The rest of the craft in pieces, was loaded onto flatbed trucks, covered with tarpaulins and labeled explosives. Dr. Oppenheimer arranged for full use and needed remodeling of the restricted Navy Auxiliary Airfield complex at Los Alamos base. The convoy proceeded at night and by the most unobserved route possible to these facilities, while units of the IPU/MAJICOPS team assisted by Army Airborne Rangers stayed at the Hart Canyon site, to effect the final clean up operations. The disc craft arrived and was put into secured storage for analysis in April 5th 1948. Two separate laboratories were set up at the Los Alamos site, one was for the detailed photographing and cataloging of each component of the disc craft, and the effort to decipher the forms of

writing found aboard. The second facility was organized around the efforts of teams of doctors led by Dr. Detlev Bronk, to attempt the revival of the crafts occupants. Neither group knew what was the purpose or progress of the other's research, only Dr. Oppenheimer was in a position, acting as a go between to see all phases of the work in progress, and to disseminate the findings of each to the appropriate investigators within each group. This was done in order to limit the risk of information reaching the public, and causing a panic situation based upon a fear of undetectable aliens among them, the thought of riots and murders was on everyone's mind. If you believe that statement you will believe anything. Eventually the medical team was able to resuscitate one adult Earth like humanoid male, and 3 Earth like humanoid infants, all about 6 months of age, two male and one female. The rest of the infants and one short, grey skinned, large headed humanoid EBE perished in the attempt to revive them. This was largely the result of Dr's Bronk and Bush having decided to experiment first on the infants, who were of little intelligence value, in the hope of reviving the short EBE and the adult humanoid for a detailed briefing. The adult Earth like humanoid male turned out to be himself an EBE, but he spoke perfect English with a slight and untraceable accent, and exhibited many telepathic and psychic skills as well. This EBE was in his general appearance, completely human, internally there were only slight differences in the formation of the heart valves, pancreas, lungs and he possessed two livers and an unfamiliar organ, were the gall bladder would be in an earthman. Also his digestive and gastro intestinal systems were simpler, and less able to process the wide range of foods that earthmen are used to. He was surprised to discover the scientists had unfrozen him alive, but was otherwise undisturbed to find himself in the company of earthmen. He stated within minutes of regaining consciousness, that his only surprise would have been if the investigator "had not chosen to hold him as captive" out of your honest curiosity. After a hasty teleconference with President Truman, it was explained to the visitor that if his intentions proved to be non hostile, and he cooperated in an information exchange, he would be granted diplomatic status and soon be repatriated to his own kind, when the arrangement could be made. To this he readily agreed, provided he was not asked to give away any scientific secrets, that could alter the course of our natural cultural development. Altogether the Aztec EBE lived under our protective custody on the Los Alamos complex for nearly a full year, from late April 1948 until March of 1949. After that he was sequestered at a private safe house set up by Army Intelligence in rural Vermont, during which time he met with the President and other top government and military administrators, prior to being returned to his people in August of 1949. He gave the scientists and military de-briefer's a great deal of mostly non technical information about



his civilization, and it's motives for being on Earth. A total of 683 pages of transcripts were made of recorded conversations, a condensed version of some noteworthy points from these many debriefing sessions follows at the end of this section. The EBE saw little harm in allowing us to keep the remains of his space craft for study, since he felt our understanding of it would only gradually be revealing. He did suggest that his people would probably have to drop one in stellar condition in the laps of the Soviet Union, just for the balance of things to be maintained, and you are welcome to take this up with any higher authority you can find willing to listen to you, if you do not approve of this course. The team of scientists were told that the human like infants were destined for our world anyway, and we were welcome to keep them. On August 21st 1949, the Aztec EBE was returned to his own kind at a meeting site southwest of Kirkland Air Force Base, Texas, and arrangements were made for a return meeting at the same location, to open diplomatic relations. And with that he bade us all farewell, but I guess many of us including the scientists and military who observed him and them, all thought the same as this song, I'll see you again.
