JUMP This is our third in our new series called From Russia with love plus. It expands on information contained within our series 1 through to 8C, and goes into wider aspects on certain topics of information within each episode. Tonight we focus on a country rarely mentioned as a power house within the Alt media circles, and yet played a dominant world role of the past, and a largely hidden from view in the recent past and currently. That country is Holland or is now known as Netherlands. Part of, the what was essentially an organized piracy group called the Dutch East or West Indies group, that went on global escapades raping , pillaging and killing many of the native occupants of lands they took over. Most prominent being New Zealand, India and Africa amongst some others, the latter particularly prominent with the De Beers group out of Holland. Then you have the people there known as Afrikaans, they are all Dutch descendants. That group was heavily involved with trafficking, harvesting and slavery in the past, although the term Dutch neglects the frequent hidden hand of the people known as Jews. That is not to denigrate all Jews, no more than you would denigrate the Dutch people for their empire, the British for their empire, Romans for their empire or the modern day version of global skullduggery, the Americans. All peoples, all countries have been used, abused and lied to on a massive scale, and all have been used as pawns in a larger game, too few see, and even less comprehend the scope of it. THE DUTCH TAKEOVER OF AMERICA: New Amsterdam was a 17th-century Dutch settlement established at the southern tip of Manhattan Island, that served as the seat of the colonial government in New Netherland. The factory became a settlement outside Fort Amsterdam. The fort was situated on the strategic southern tip of the island of Manhattan, and was meant to defend the fur trade operations of the Dutch West India Company in the North River (Hudson River). In 1624, it became a provincial extension of the Dutch Republic, and was designated as the capital of the province in 1625. By 1655, the population of New Netherland had grown to 2,000 people, with 1,500 living in New Amsterdam. By 1664, the population of New Netherland had skyrocketed to almost 9,000 people, 2,500 of whom lived in New Amsterdam, 1,000 lived near Fort Orange, and the remainder in other towns and villages. The term orange crops up in several countries involving the Dutch, but also their soccer shirts are orange and we will reveal why later. Also explains why the company ING is in orange, ING means the International Netherlands Group is why. In 1664 the English took over New Amsterdam, and renamed

it New York City after the Duke of York (later James II & VII). After the Second Anglo-Dutch War of 1665–67, England and the United Provinces of the Netherlands agreed to the status quo in the Treaty of Breda. The English, which is the Crown and no is not related in anyway to British royalty, kept the island of Manhattan, the Dutch giving up their claim to the town and the rest of the colony, while the English formally abandoned Surinam in South America, and the island of Run in the East Indies to the Dutch, confirming their control of the valuable Spice Islands. Today much of what was once New Amsterdam is in New York City.

In 1524, nearly a century before the arrival of the Dutch, the site that later became New Amsterdam was named New Angoulême, by the Italian explorer Giovanni da Verrazzano, to commemorate his patron King Francis I of France, former Count of Angoulême. The first recorded exploration by the Dutch of the area around what is now called New York Bay was in 1609, with the voyage of the ship *Halve Maen* (English: "Half Moon"), commanded by Henry Hudson in the service of the Dutch Republic, as the emissary of Maurice of Nassau, Prince of Orange, Holland's stadholder. Hudson named the river the Mauritius River. He was covertly attempting to find the Northwest Passage for the Dutch East India Company. Instead, he brought back news about the possibility of exploitation of beaver by the Dutch, who sent commercial, private missions to the area the following years. At the time, beaver pelts were highly prized in Europe, because the fur could be felted to make waterproof hats. A by-product of the trade in beaver pelts was castoreum, the secretion of the animals' anal glands—which was used for its medicinal properties and for perfumes. The Astor family made most of their early fortune from this trade, but they introduced and were connected to another Dutch family the Roosevelt's, that family to have two Presidents and a first Lady. They were also connected to another famous family name the Stuyvesants. The expeditions by Adriaen Block and Hendrick Christiaensen in 1611, 1612, 1613 and 1614, resulted in the surveying and charting of the region from the 38th parallel to the 45th parallel. On their 1614 map, which gave them a four-year trade monopoly under a patent of the States General, they named the newly discovered and mapped territory New Netherland for the first time. It also showed the first year-round trading presence in New Netherland, Fort Nassau, which would be replaced in 1624 by Fort Orange, which eventually grew into the town of Beverwijck, now Albany. Dominican trader Juan Rodriguez (rendered in Dutch as Jan Rodrigues), born in Santo Domingo of Portuguese and African descent, arrived on Manhattan Island during the winter of 1613–1614, trapping for pelts and trading with the local population as a representative of the Dutch. He was the first recorded non-Native American inhabitant of what would eventually become New York City. The territory of New Netherland was originally a private, profit-making commercial enterprise focused on cementing alliances, and conducting trade with the diverse Native American ethnic groups. Surveying and exploration of the region was conducted as a prelude to an anticipated official settlement by the Dutch Republic, which occurred in 1624.

Pilgrims' attempt to settle in the Hudson River area

In 1620 the Pilgrims attempted to sail to the Hudson River from England. However, The Mayflower reached Cape Cod (now part of Massachusetts) on November 9, 1620, after a voyage of 64 days. For a variety of reasons, primarily a shortage of supplies, Mayflower could not proceed to the Hudson River, and the colonists decided to settle near Cape Cod, establishing the Plymouth Colony.

Dutch return: Governors Island The mouth of the Hudson River was selected as the ideal place for initial settlement as it had easy access to the ocean, while also securing an ice-free lifeline to the beaver trading post near present-day Albany. Here, Native American hunters supplied them with pelts in exchange for European-made trade goods and wampum, which was soon being made by the Dutch on Long Island. Wampum is a string bead of various aquatic shells which the natives used as currency and also jewelry. In 1621, the Dutch West India Company was founded, 60 years before the British equivalent. Between 1621 and 1623, orders were given to the private, commercial traders to vacate the territory, thus opening up the territory to Dutch settlers and company traders. It also allowed the laws and ordinances of the states of Holland to apply. Previously, during the private, commercial period, only the law of the ship had applied. The law of the ship became the law of the land, known as maritime law, could this be the first ever enactment of that law? In May 1624, the first settlers in New Netherland arrived on Noten Eylandt (Nut or Nutten Island, now Governors Island) aboard the ship New Netherland under the command of Cornelius Jacobsen May, who disembarked on the island with thirty families to take legal possession of the New Netherland territory. The families were then dispersed to Fort Wilhelmus on Verhulsten Island (Burlington Island) in the South River (now the Delaware River), to Kievitshoek (now Old Saybrook, Connecticut) at the mouth of the Verse River (now the Connecticut River) and further north at Fort Nassau on the Mauritius or North River (now the Hudson River), near what is now Albany. A fort and sawmill were soon erected at Nut Island, the latter was constructed by Franchoys Fezard and was taken apart for iron in 1648. New Amsterdam

received municipal rights on February 2, 1653, thus becoming a city. Albany, then named Beverwyck, received its city rights in 1652. Nieuw Haarlem, now known as Harlem, was formally recognized in 1658. No one asks who gave them the rights to the city or land? answer is likely the Crown agents. Many Native Americans will state that was our land, and under legal law that is correct, but who gave any people the right to own the land above all others? Is ownership anywhere on the planet outside of the Earth Mother something that should be subscribed to? The first Jewish known to have lived in New Amsterdam arrived in 1654. Before we go forward with this part, people may ask why is the mention of Jews being interjected with the story of Holland? Surprisingly or not, it is not interjected, as it is not a separate story that has been repeated in many countries, namely Russia in 1910's, Germany in 1940's and America ever since. The first Jewish to arrive were Solomon Pietersen and Jacob Barsimson, who sailed during the summer of 1654 directly from Holland, with passports that gave them permission to trade in the colony. Then in early September, 23 Jewish refugees arrived from the formerly Dutch city of Recife, which had been conquered by the Portuguese in January 1654. The director of New Amsterdam, Peter Stuyvesant, sought to turn them away but was ultimately overruled by the directors of the Dutch West India Company in Amsterdam. Because the East and West Indies Companies and ships were all ran and operated by Jewish owners is why. Asser Levy, an Ashkenazi Jew who was one of the 23 refugees, eventually prospered and in 1661 became the first Jew to own a house in New Amsterdam, which also made him the first Jew known to have owned a house anywhere in North America. Here is some interesting details about who Asser Levy was. Given it was the Jewish who first imposed taxes on the people, is it a cohen-cidence that imposing taxes on the people, something the Jewish traders who ran the silk road never paid, is called a levy, it is a levy or levi tax? Asser Levy was probably born in Vilna, present-day Lithuania. He left Poland for Amsterdam, possibly to escape the pogroms of the Khmelnytsky uprising. Although he lived for a time in Amsterdam, he was not given burgher (citizenship) rights, and probably was not granted poorter (permanent residency) rights either. He might also have lived for a time in Schwelm, a town in the County of Mark in modern-day Germany. Two archived documents from Amsterdam reveal that on April 26, 1660, he was there seeking payment of a debt owed to him, and on May 24, 1660, he announced he was going to Germany. Levy might have married his wife Miriam (whose maiden name was probably Israel) while living in Amsterdam, but this cannot be verified; no record of this marriage exists in the Amsterdam archives, but this might be due to the fact that Jews were not required to register their marriages in Amsterdam until 1695. While in Amsterdam, he learned about the opportunities in the New World, and migrated there. Levy might have initially moved to Dutch Brazil; he has been mentioned as one of the 23 Jewish refugees who fled from Recife after the end of Dutch rule in the area. However, Levy is not listed in the extant congregational minute books of the

Brazilian Jewish community, which casts serious doubt on this theory. It is known that he eventually ended up in New Netherland, having possibly arrived in New Amsterdam aboard the St. Catherine or St. Charles in early September 1654. In 1655, Peter Stuyvesant, the governor of the colony, was ordered to attack New Sweden, the Swedish colony on the Delaware River, and accordingly issued orders for the enlistment of all adults. Several Jews, among them Asser Levy, appear to have been ready to serve, but the governor and council passed an ordinance "that Jews can not be permitted to serve as soldiers, but shall instead pay a monthly contribution for the exemption." Levy and his comrades at once refused to pay, and on November 5, 1655, petitioned for leave to stand guard like other burghers or to be relieved from the tax. The petition was rejected with the comment that, if the petitioners were not satisfied with the law they might go elsewhere. Levy successfully appealed to Holland, and was subsequently permitted to do guard duty like other citizens. Levy appears also as a prominent trader in Fort Orange, present day Albany. It is likely that he was responsible for the rebuke given to Stuyvesant by the directors in Holland, during the same year because of his refusal to permit Jews to trade there. Levy was also one of the first licensed butchers in the colony. In 1657, the burgher right was made essential for certain trading privileges, and within two days of a notice to that effect Asser Levy appeared in court requesting to be admitted as a burgher. The officials expressed their surprise at such a request. The record reads: "The Jew claims that such ought not to be refused him as he keeps watch and ward like other burghers, showing a burgher's certificate from the city of Amsterdam that the Jew is a burgher there." The application was denied, but Levy at once brought the matter before Stuyvesant and the council, which, mindful of the previous experience, ordered that Jews should be admitted as burghers on April 21, 1657. Levy was the first Jew to own a house in North America. As early as 1661, Levy purchased real estate in Fort Orange; he was also the earliest Jewish owner of real estate in New York, his transactions there commencing in June 1662 with the purchase of land on South William Street. Within ten years of his arrival Levy had become a man of consequence, and when, in 1664, the wealthiest inhabitants were summoned to lend the city money for fortifications against the English, he was the only Jew among them: he lent the city 100 florins. It is as a litigant, however, that Levy figures most prominently in the Dutch records, his name often appearing for days in succession. He invariably argued his own case and was almost invariably successful, only on two or three occasions did he figure as defendant. As a litigant he is named also in the records of Gravesend, Brooklyn in 1674. Levy's trading relations extended to New England, and he frequently appeared as attorney for merchants in Holland. In 1671 he lent the money for building the first Lutheran church in New York, one may ask why a Jew would build a Lutheran church and not a place of worship for Jews? the answer is all the separate religions link back to the Jewish religion of law, via the Talmud and the Torah. About 1678 he built a slaughterhouse in the east end of what is now Wall Street, where he appears to have been the owner of a famous tavern. Wall Street retained its slaughterhouse beginnings in a different form it seems.

Instead of being unpopular on account of his many lawsuits, the contrary seems to have been the case. The confidence reposed in his honesty by his Christian fellow citizens appears frequently from the court records. Property in litigation was put into his custody; he is named as executor in the wills of Christian merchants, and figures as both administrator and trustee in colonial records. His influence was not confined to New York; in the colonial records of Connecticut he appears as intervening to obtain the remission of a fine imposed upon a Jew there. The court remitted the fine with the comment that it did so "as a token of its respect to the said Mr. Asser Levy." He left a considerable estate, over which there was a long legal contest.

The Vanderbilt family is an American family of Dutch origin who gained prominence during the Gilded Age. Their success began with the shipping and railroad empires of Cornelius Vanderbilt, and the family expanded into various other areas of industry and philanthropy. Cornelius Vanderbilt's descendants went on to build grand mansions on Fifth Avenue in New York City; luxurious "summer cottages" in Newport, Rhode Island; the palatial Biltmore House in Asheville, North Carolina; and various other opulent homes. The Vanderbilts were once the wealthiest family in America, and Cornelius Vanderbilt was the richest American until his death in 1877. After that, his son William acquired his father's fortune, and was the richest American until his death in 1885. The Vanderbilt's prominence lasted until the mid-20th century, when the family's 10 great Fifth Avenue mansions were torn down, and most other Vanderbilt houses were sold or turned into museums, in what has been referred to as the "Fall of the House of Vanderbilt". The fall of the Houses is a common theme throughout this series is it not, and is describing the full takeover by one specific group, using a multitude of elite families along the way, and when their use of over, down they fall like Humpty Dumpty, and no they won't be put back together again. The modern day version of it was described in the Clowns in Panic show and being seen today by more and more people. Branches of the family are found on the United States East Coast. Contemporary descendants include journalist Anderson Cooper, actor Timothy Olyphant, musician John P. Hammond and screenwriter James Vanderbilt. The progenitor of the Vanderbilt family was Jan Aertszoon or Aertson (1620–1705), a Dutch farmer from the village of De Bilt in Utrecht, Netherlands, who emigrated to the Dutch colony of New Netherland as an indentured servant to the Van Kouwenhoven family in 1650. Jan was an original patentee, director of bouweries (farms), and a founder of the New Netherland colony. He also founded the first European settlement on Long Island, called New Amersfoort, and was a Schepen of New Amsterdam in 1654. He is noted as playing an "active role in laying the foundations of the communities of Manhattan, Albany, Rensselaer, and Brooklyn." Descendants of the Van Kouwenhoven family also include, The Harriman family, Michael and Diana Douglas of film fame, Humphrey Bogart, Andy Roddick tennis player, The Jenner family, always wondered why they achieved fame, as their only talent is at being not talented, Lance Armstrong cyclist, 2 governors and a Senator plus also tentative links to

the Wright Brothers of aviation fame. Jan's village name was added to the Dutch "Van" (from) to create "Van der Bilt", which evolved into Vanderbilt when the English took control of New Amsterdam (now Manhattan). The family is associated with the Dutch patrician Van der Bilt. You have to understand also Van and Von are both titles of nobility, like Anna Von Reitz. His great-great-great-grandson Cornelius Vanderbilt began the prominence of the family, the fourth of nine children born to a Staten Island family of modest means. Through his paternal great-great grandmother Abigail Southard, he descends from Republic of Salé President Jan Janszoon, and his son Anthony Janszoon van Salee. They were among the earliest arrivals to 17th-century New Amsterdam. In a number of documents dating back to this period, Anthony is described as tawny or mulatto, as his mother was of Berber origin from Cartagena in the Kingdom of Murcia, which was a region in South Eastern Spain. Cornelius Vanderbilt left school at age 11, and went on to build a shipping and railroad empire that, during the 19th century, would make him one of the wealthiest men in the world. Starting with a single boat, he grew his fleet until he was competing with Robert Fulton for dominance of the New York waterways, his energy and eagerness earning him the nickname "Commodore", a United States Navy title for a captain of a small task force. Fulton's company had established a monopoly on trade in and out of New York Harbor. Vanderbilt, based in New Jersey at the time, flouted the law, steaming in and out of the harbor under a flag that read, "New Jersey Must Be Free!" He also hired the attorney Daniel Webster to argue his case before the United States Supreme Court; Vanderbilt won, thereby establishing an early precedent for America's first laws of interstate commerce. The Vanderbilt family lived on Staten Island until the mid-1800s, when the Commodore built a house on Washington Place (in what is now Greenwich Village). Although he always occupied a relatively modest home, members of his family would use their wealth to build magnificent mansions. Shortly before his death in 1877, Vanderbilt donated US\$1 million for the establishment of Vanderbilt University in Nashville. The Commodore left the majority of his enormous fortune to his eldest son, William Henry Vanderbilt. William Henry, who outlived his father by just eight years, increased the profitability of his father's holdings, increased the reach of the New York Central Railroad, and doubled the Vanderbilt wealth. He built the first of what would become many grand Vanderbilt mansions on Fifth Avenue, at 640 Fifth Avenue. William Henry appointed his first son, Cornelius Vanderbilt II, as the next "Head of House". Cornelius II built the largest private home in New York, at 1 West 58th Street, containing approximately 154 rooms, designed by George B. Post. He also built The Breakers in Newport, Rhode Island. Cornelius II's brother, William Kissam Vanderbilt, also featured prominently in the family's affairs. He also built a home on Fifth Avenue and would become one of the great architectural patrons of the Gilded Age, hiring the architects for (the third, and surviving) Grand Central Terminal. He also built Marble House at 596 Bellevue Avenue in Newport, Rhode Island. George Washington Vanderbilt II, the 3rd and youngest son of William Henry Vanderbilt and youngest brother of Cornelius II, hired architect Richard Morris

Hunt and landscape architect Frederick Law Olmsted, to construct Biltmore Estate on 125,000 acres near Asheville, North Carolina. The 250 room mansion and 175,856 square feet of floor space remains on top of the list of largest houses in the United States to date.

DUTCH DEEP STATE: Yes they have one as well, in fact most countries do, this covers the period 1940 through 1950's The Dutch deep state was rebooted after World War II by the British and Americans. The Dutch outsourced Dutch secret service agents to front-lines, countries like Romania, Bulgaria and other unknown countries, and started a Dutch Gladio-division which.... got out of hand. The Dutch were the leading illegal drug traffickers in the EU from the 1980s, and were named during the 2010s as the "world leaders" of hosting child porn. Free of mass casualty "terrorist" attacks for at least 10 years, and housing many western-backed international courts, may reflect its close ties with the Supranational Deep State. Maybe that region was the hub for creating them? Operation Market Garden may not have been that much of a failure as most would think. Operation Market Garden was a failed World War II military operation fought in the Netherlands from 17 to 25 September 1944. It was the brainchild of Field Marshal Sir Bernard Law Montgomery and strongly supported by Winston Churchill and Franklin Roosevelt. The airborne part of the operation was undertaken by the First Allied Airborne Army with the land operation by XXX Corps of the British Second Army. The objective was to create a 64 mile salient into German territory with a bridgehead over the River Rhine, creating an Allied invasion route into northern Germany. It failed, however, to secure a bridgehead over the Rhine, with the advance being halted at the river. The CIA recruited Dutch agent "Jan Constantin" and 4 others, trained them in Amsterdam and dropped them in as what seems to be mercenaries. According to a parliamentary inquiry supported by the Dutch MOD and a study from the VU University Amsterdam. Bernhard ordered the launch of what they first named a "stay-behind network" of secret service agents, that had secretly started opposition groups against the Germans or Russians in the late stages of the war. These agents - around 10 first - tried developing a plan to have a back-up mechanism in place for armed civilians that would fight against Russians. Two separate groups that originated out of the war were targeted and professionalized by the British. These groups at first did not know of each-others existence. Common theme that, teaching two separate groups and not making each other aware, all very compartmentalization that. The Dutch committed war crimes after they tried to reclaim control of the Dutch East-Indies, better known as Indonesia in 1945, sometimes in cooperation with the British. Many files in the Dutch national archive are still secret, more than seventy years later. Bernhard von Biesterfeld appears to have been a figure of central importance in the Dutch deep state. By his own account, he consulted 12 men before arranging the first Bilderberg Meeting, held in the Netherlands in 1954. The group, initially exclusively male, has had 170 Dutch members over the years, more than other similarly sized European states. By way of comparison, there have only been two

documented Dutch visitors to the Pinay Cercle: Cornelis Bossers & Frans Alphon Maria Alting von Geusau). It should be noted that cannabis got banned during the 1950s in Holland. After World War 2 the CIA employed a few Dutch secret service agents, that actively started opposition groups alongside their own agents in Romania and Bulgaria from the 1950s, Nieuwsuur revealed in 2016. The Bulgaria agency is placed in Sofia, and is the CIA Eastern Europe Division and where Neil Keenan was located, and also why he was located there. According to the segment they "actively employed partizans to stimulate anti-communist actions after a conference in Washington in 1951". The CIA and AIVD (at that point known as BVD) both didn't have any recollection upon request in their databases. What they did there is not recollected, at least according to the official narrative. The CIA commonly have a short memory and remarkably they have a poor record of being able to keep records, often losing them or a weird coincidence that files are all destroyed by a fire, something that has afflicted the CIA badly since its inception. Files go missing or burn, all caused by Russian collusion is another coincidence that has seemingly plagued the CIA. Around 1952 the framework was finalized, and two groups of 21 secret service agents along with the newly formed BVD, started actively recruiting - right-wing - civilians in useful positions, that did not have a leading position in their workplace or any communist ideas, such as teachers, salesman, welders, drivers, physicians and sailors. This became later known as Operation Gladio. These two groups were called Operations and Intelligence, so they went from OI then to AI now. This group directly reported to Minister of war and former officer, Kees Staf from 1952 and PM Willem Drees from 1956. In the 1950s and 1960s, the US Deep state had vastly more money than the BVD, and used it to exert influence into the Netherlands. By 1958, for example, the CIA paid the salaries of approximately 51 of the 691 employees of the Dutch service. According to the Dutch investigative program Brandpunt the agents-to-be (of which 7 appeared on TV), all were personally recruited by one member who became their handlers, and appeared at their door with letters from Kees Staf or PM Willem Drees. They all recalled the "strange exceptional professionalism" of the operation; need-to-know basis, training in plausibility deniability, they were required to be armed 24/7, never met another agent and were also trained in the US and the UK (which would also be their back-up basis of operations in case of a Russian attack). For some positions individuals were trained up to 400 hours. In the 50s, 24 divisions were established: Operation had 7, Intelligence had 17. At the end of the 50s all these agents had their own secret intelligence-station in their house, and a container with weapons and equipment which was to be held secret from their families. If someone "for any reason whatsoever" disappeared, they'd "vanish in the mist and never be found". The HQ of the Intelligence-Division was Villa Maarheeze, located in the coastal town of Wassenaar, according to an essay made up with help of former agents. Operations - located at first in Utrecht, later in Amsterdam in the HQ of the Dutch Marines - fell directly under PM Willem Drees and had these 7 divisions; Psyops, Sabotage, Connections, Falsification, Operational Finance, Security and Codes. Operations was noted as the "Extreme Measures-unit". Their task

was to "commit acts of sabotage", "acts of violence against persons - politicians, activists and journalists included - that supported the enemy", "commit robberies" and "make propaganda that would hurt the enemy". Gladio was already infiltrated in the Dutch media, as the head of Dutch public broadcaster NCRV and head of the chairman of the Dutch Council of Journalism Tom Herstel, was an instructor for the psyop-division. Interesting note; Villa Maarheeze, Clingendael Institute, and one of three royal palaces of Bernhard and Juliana Wilhelmina are located in the same small town of Wassenaar within... 6 miles of each-other. So, who is Prince Bernhard? Prince Bernhard was a member of the "Reiter-SS", a mounted unit of the SS and had joined the Nazi party before the war. He later also joined the National Socialist Motor Corps. Various members of his family and friends were aligned with the Nazis prior to the Second World War, and a number of them attended the royal wedding. Protocol demanded that the prospective Prince-Consort be invited to an audience with his head of state, who at the time was Adolf Hitler. Hitler gave an account of the conversation he had with Bernhard in his Tischgespräche (Table Conversations). This book was a collection of monologues, remarks, and speeches Hitler gave during lunch or dinner to those he had invited. The Prince's brother, Prince Aschwin of Lippe-Biesterfeld, was an officer in the German Army. Although the secret services on both sides were interested in this peculiar pair of brothers, no improper contacts or leaks of information were ever discovered. He cut off relations with those members of his family who were enthusiastic Nazis. As a sign of his "Dutchness", near the end of the war, he spoke only Dutch when negotiating the surrender of German forces in the Netherlands.

History of the Dutch Deep State: US Deep state influence In the 1950s and 1960s, US Deep state had vastly more money than the BVD, and used it to exert influence into the Netherlands. By 1958, for example, the CIA paid the salaries of approximately 51 of the 691 employees of the Dutch service.

1960s Max Kohnstamm was a Dutch deep politician, and Secretary General of the Action Committee for the United States of Europe. As well as attending the 1961 Bilderberg he attended 27 of the subsequent meetings, and became a member of the Bilderberg Advisory Committee, which chooses the steering committee. The Dutch government accepted a request from the NATO and Germany, to place 22 B28 nuclear bombs at Volkel Air Base. These bombs and an US Air Force squadron was placed there, with the task to fly to Cuba if the Cuban Missile Crisis would get out of hand. Does that make any sense, flying to Cuba from Holland, I guess people didn't question anything back then either. The Dutch would not acknowledge this until 2013, when Ruud Lubbers revealed it himself. NATO did not acknowledge this not until 2019. Nazi Germany had left traumatic feelings in a lot of national, resulting in an end of democracy. The 1960s slowly saw a lot of new non-denominational people and institutions. This paved the way for a lot of extreme public discourse for such a small country in future decades, which the

deep state has trouble handling up until this day. In Groningen, fracking for natural gas fields was started, which remains a controversial topic for deep politics until this day, as halting the fracking would've resulted in an economic collapse for that coalition-cabinet, as the Dutch did not want Russian gas, and the Middle East has had its "fluctuations".

1970s The Dutch Prince Bernhard and Queen Juliana returning from Italy because of developments in the Lockheed Martin scandal. Prince Bernhard played a major role until his exposure by the Lockheed/Bribery scandals, which caused the cancellation of the 1976 Bilderberg meeting. When Dutch Prime Minister Joop den Uyl ordered an inquiry, Bernhard refused to answer reporters' questions, stating: "I am above such things". The results of the inquiry led to a constitutional crisis, in which Queen Juliana threatened to abdicate if Bernhard was prosecuted. Bernhard was spared, but stepped down from several public positions and from chairing the Bilderberg meetings. The Lockheed bribery scandals encompassed a series of bribes and contributions made by officials of U.S. aerospace company Lockheed, from the late 1950s to the 1970s in the process of negotiating the sale of aircraft. The scandal caused considerable political controversy in West Germany, Italy, the Netherlands and Japan. In the U.S., the scandal nearly led to Lockheed's downfall, as it was already struggling due to the commercial failure of the L-1011 TriStar airliner. In late 1975 and early 1976, a sub-committee of the U.S. Senate led by Senator Frank Church concluded, that members of the Lockheed board had paid members of friendly governments, to guarantee contracts for military aircraft. In 1976, it was publicly revealed that Lockheed had paid \$22 million in bribes to foreign officials, in the process of negotiating the sale of aircraft, including the F-104 Starfighter, the so-called "Deal of the Century". This is how the old world works, all based on bribes and skullduggery, but notice no one is ever charged under the national security act? Why? because companies like Boeing, Lockheed Martin, Haliburton and Bechtel, along with CIA subsidiaries are the National Security, which was created to protect those mentioned groups. No cry by the portal people media of collusion as well, that only applies if you don't like a political opponent. Victor Halberstadt is an economist who has maintained a low public profile in spite of attending all Bilderberg meetings since 1975, and being honorary Secretary General of the group from 1980-2000. The - now - notorious drug policy was strangely green-lit in the 70s, with the withdrawal on the complete ban on cannabis, and start of the coffee-shops in Amsterdam and Utrecht. They called it "an experiment", it never became clear why the Dutch chose to do this, I do, it's simple, the CIA told them to do so, as they ran many of the drug operations for black budget money. The Dutch cities had a favorable location - close to each-other and other European cities, high density, and quick and modern infrastructure. As globalization caused companies to outsource to Asia, the oil crisis of 1973 and the loss of jobs caused many people to become homeless (or hopeless). And turned to drugs or working for the Chinese, Russian and Italian mafia, that had set-up hubs in Amsterdam as everything was legalized. After a extreme surge of heroin, and the rise of drug dealers in the main streets of Amsterdam,

Utrecht, Rotterdam & The Hague, most main drugs except cannabis were banned at the end of the 70s. At that point many Dutch crime bosses had already become skilled drug dealers known for their expertise. This became the start of the Dutch illegal drug trade where Klaas Bruinsma started his career in Amsterdam.

1980s Paul Bremer was US Ambassador to the Netherlands from 1983-1986. Max van der Stoel became the main coordinator of the Operations and Intelligence. Juliana had just pressured the public into not looking any further into Bernhard when Prince Claus - a former soldier of the German army was revealed to be the future prince of Beatrix Armgard. In 2016 Claus was accused of "picking up underage boys in the city of Amsterdam" and at least "watching former Dutch Minister of Finance Onno Ruding having sex with one of them" in 1982. The victim recalled "paedophile-prostitution to be tolerated in that time" The first scandals of Vipaedophile are dated from this era - and were not reported in corporate media. Prince Claus there appears to be only one earlier hint that he, for example, liked little boys when the Netherlands Government Information Service issued the statement "the Prince is not homosexual and wants the rumours to stop" following a article of the Telegraaf. He was suspected after several sources were citing him that he also visited a "gay bar in New York" having proof made with an infrared camera, even Ronald Reagan was concerned at that time stating he was "worried about their royal policies". I can guarantee that gay bar in New York incident was a sting operation, this is what Gladio and CIA are all about, is getting people in awkward positions and then exploiting it for their own gains. Many top people have fallen victims of this often stage managed manipulations games. Klaus, Bruinsma, and dozens of other lawyers, politicians and Bernhard and his 1001 Club, appear to be connected in one way or another in a sex cult, with alleged ritual abuse all the way to Marc Dutroux. Marc Paul Alain Dutroux is a Belgian convicted serial killer, rapist, and child molester. Dutroux was convicted in 1989 for the abduction and rape of five young girls (with his then-wife Michelle Martin) and other accomplices. He was released on parole after three years in prison. In 1996, Dutroux was arrested on suspicion of having kidnapped, tortured and sexually abused six girls aged between 8 and 19, four of whom died. His widely publicized trial took place in 2004. Dutroux was convicted of all charges, along with the murder of a suspected former accomplice, and sentenced to life imprisonment. Dutroux's accomplices included Michelle Martin, Michel Lelièvre, Michel Nihoul, and Bernard Weinstein. Interesting the name Weinstein comes again, like his notorious namesake Harvey, turns out Bernard Weinstein also had links to the Mossad. Jeffery Epstein is also linked directly to Mossad as well. Independent researchers have uncovered evidence that Bernard Weinstein was connected to the infamous Mossad spy agent Zev William Barkan (aka Bruckenstein) and sometime Israeli diplomat, for years involved in international espionage, including insurrection, fraud and assassination spanning the globe, in Austria, Dubai, Mumbai, Belgium, Holland, New Zealand and Canada. ISGP has their names pop up several 100 times regarding these matters, Bruinsma (with his clan already connected

to gladio and controlling police-units, one should wonder how powerful this boss exactly was) His crime syndicate was being called by one news site, as being involved at secretive parties in Amsterdam's financial district - the place where Nieuwsuur said cocaine is mandatory - with child-abuse in the 1990s. The editors of the article specifically mentioned stopping the investigation for the moment citing "the urge to stay alive for quite a while".

Israel's influence In October 1981, Juliana appointed deep politicians Victor Halberstadt and Cees de Galan to mediate the Dutch Cabinet crisis. This crisis originally was presented by the original narrative as a feud, between the PM and progressive Dries van Agt and his CDA-fraction, and the socialists in the coalition headed by deputy prime-minister "left"-wing Joop den Uyl and his PVDA party. Following the 1973 Oil crisis and the major inflation and loss of jobs, the two could not reach an agreement on social reforms. Other forgotten details include the participation of the NATO Double-Track Decision of 1979. This was essentially NATO controlling countries weapons amounts, seen globally as positive towards disarming weapons, but in essence it was neutralizing countries attempts at sovereignty, With NATO running their own army, to then be seen as protectors of the EU, which is fake, it is Rothschild's private army. And with the 22 B28 nuclear bombs being placed there in previous decade, perhaps those fake SALT agreements of that time, makes more or less sense now. PVDA members wanted to participate in a protest in 1981 with 400,000 civilians in Amsterdam, as other protests regarding the Iran-Iraq war and the 1980s Afghan war, were also becoming political hot topics. Another theory regarding this crisis was that Van Agt was removed by the Dutch Deep state that backed Den Uyl, (who has a picture in his bedroom and is a close friend of Israeli PM Golda Meir) who was PM from 1973 until 1977 and was a supporter of Israel as Van Agt was deemed "too risky". Van Agt's is most known for his outspoken or sometimes explosive character; he remarked in the 1970s that the last remaining known Dutch convicted Nazi's in prison, should be released because he did not consciously experience the war, and "was Aryan". He was relocated the Dutch embassy to Tel Aviv and told Dutch media in 1982 that, "Israel must not think that with provocations and attacks it will reach peace, as with gun-violence, unilateral acts and breaking international law, and not complying with decisions made by the international community, such as those that have been enacted by the UN", and actively supported sending and keeping UN-troops in Lebanon during the 1982 Lebanon War. This is suggestive that the UN is a proxy organization of Israel, even after being cited for breaking more international rules by the UN, more violations than all other nations combined, it was always vetoed, by America in particular. Van Agt became a staunch supporter of Palestine and hard critic of Israel and remained it well into the 2000s. Meanwhile Joop den Uyl spoke on the Jerusalem Conference on International Terrorism, as the speaker for the "Dutch response" to "terrorism". Interestingly enough Van Agt's cabinet had a lot of politicians connected to deep state milieu not known at that time. Van Agt; 1 time Bilderberg, Max van der

Stoel - head of the Dutch-Gladio division from 1982. Hans van Mierlo - 1 time Bilderberg, started - with the future mayor of Amsterdam - a "shadow government" modelled on the British in 1971, publicly advocated for nuclear weapons against the Soviet Union. A NATO clown then. Hans van den Broek, after Van Agt was put out of power, as a lot of privatization was slowly introduced. Privatization means the clowns harvest the stock into a tighter circle they own and control. YOUNG WATERS

Bilderberg All Dutch Prime Ministers since 1982 have visited the Bilderberg: (Ruud Lubbers (1982-1994), Wim Kok (1994-2002), Jan Peter Balkenende (2002-2010), Mark Rutte (2010-).

Hollanditis "Hollanditis" was a word coined in 1981 by US historian Walter Laqueur to describe the rise of Dutch pacifism. In 1983, 550,000 participants demonstrated in The Hague, aimed against the deployment of US cruise missiles carrying nuclear warheads.

Revolutionary Anti-Racist Action Revolutionary Anti-Racist Action (RaRa) bombed property. The Dutch Interior Minister termed them a "terrorist" group. One of the victims was a prince and the owner of a leading supermarket-chain member of the 1001 club, if even he didn't receive protection, who was behind these attacks? is a question unanswered today.

1990s Crime bosses and corrupt officials were intertwined at this point. An interregional investigational unit, known as the IRT, was the subject of a parliamentary inquiry. The enquiry revealed the police officers infiltrated Klaas Bruinsma's (and his successors) drug empire, and actively participated in it and executed several criminal acts, which caused both teams to end up investigating each-other. Most notably, the employment of civilian criminal infiltrates was controversial. The enquiry and it's findings have caused the biggest law-changes in the Dutch criminal justice system.

Dutch official Gladio admittance Up until this point the Dutch never admitted Gladio to be existent. Several weapon stashes were found and reported by corporate media, but mayors, prosecutors, and other high-ranking officials all denied knowing the origins. Even when newspaper Elsevier released an article naming several Dutch spooks, and at least two MPs as KGB-agents by our source, a spook himself. The agent was later revealed to be working for the World League for Freedom and Democracy. The precursor of that group was the World Anti-Communist League (WACL) is an international non-governmental organization of anti-communist politicians and groups founded in 1966 under the initiative of Chiang Kai-Shek, leader of the Republic of China (Taiwan). Ruud Lubbers admitted the existence in 1990 of a Dutch division of the Operation Gladio-network. But noted, the Dutch division was not under direct NATO-Command, but the government, he lied NATO is controlling the Governments. This proves that NATO is

ran by ex CIA agents, such as Robert David Steele, who wrote the intelligence handbook for NATO, as revealed in the Clowns In Panic show. The organization operated under the "single-agent principle" meaning they did not work in groups, and therefore could not commit crimes like the Bologna bombing, Peteano bombing and Piazza Fontana bombing. All civilian-employees were fired at this point. A Belgian agent revealed to Amsterdam main newspaper Het Parool, that the Belgian and Dutch Gladio-networks were in fact actively working together, meeting regularly. Belgium is a fake created country to run counter operations against we the people, a military base and think tank country, like Israel is in the Middle East. Belgium is actually just South Holland. In May 2004, Lubbers was accused by Cynthia Brzak, an American UNHCR employee, of sexual harassment following a meeting in his office that was attended by two other UNHCR staff members. Three years prior to the controversy over the sexual harassment case, Ruud Lubbers was criticised for his mis-handling of the UNHCR/SC-UK 2002, which uncovered the widespread sexual exploitation of refugee children, by aid workers and peacekeepers in three West African countries (Liberia, Guinea and Sierra Leone). The study team which had encountered these findings unexpectedly whilst conducting a broader assessment, documented 67 allegations implicating 40 aid agencies and several peacekeeping battalions, and often involving humanitarian workers and peacekeepers exchanging meagre aid supplies (biscuits, soap, plastic sheeting) for sex with children. That is the UN involvement again, they have exploited many countries in this way, particularly in African countries. The UN are not peacekeepers that are a highly organized piracy based company, it is not peace PEACE, it is piece PIECE, they take a piece of this and a piece of that, with the ultimate goal of taking a piece of everything, just like NATO. Ruud Lubbers' response was to deny these findings, discredit the authors and excuse these behaviors; for example in a CNN interview on 8 May 2002, Lubbers was heard to deny the problem in the face of CNN's own research, which confirmed the problem existed and was taken to task by the interviewer, for dismissing these exploitative relationships inter alia as 'romances'. He was roundly criticized by his own staff for that interview. Despite repeated attempts by Lubbers to lead a negative campaign against the report, the international community and governments in particular, took the allegations seriously and passed a UN General Assembly resolution A/RES/57/306. Investigation into sexual exploitation of refugees by aid workers in West Africa in May 2003, requiring the UN to take action at the highest level to tackle such abuses. This led to the UN Secretary-General's Bulletin, 'Special measures for protection from sexual exploitation and sexual abuse' in October 2003, and an endorsement of the Inter-agency standing Committee's working group on sexual abuse and exploitation, which had already been set up a year earlier in June 2002 in response to the report. The classic sleight of hand tactics of the agencies, give the illusion of investigating something, takeover the investigation with their own puppets, and stifle the discourse and investigations. If the exploitation group set up in 2003 worked, the practice would have stopped, it hasn't. After these revelations the Dutch public did not ask questions about Gladio, as Lubbers

left The Hague for an international career. The classic case of diverting the peoples attention, bit like Covid whilst they launch operation Humanity takedown via technology. It is also a common theme to use sex as a distraction. Muslim-"terrorism", the war on terror and several conflicts like in Sudan, Yugoslavia and Libya were becoming more popular due to commercial media, and increased television coverage of such events by newly viewable commercial TV-stations such as CNN or national-known RTL.

Yugoslavia A Dutch major was revealed to have ordered the MIVD in 1995, to secretly go to a lieutenant who had made pictures of Serbian war crimes in Srebrenica. The photographic films could've proven the Dutch would've known of the genocide much earlier, than the international community would've condemned it to be. The film was "damaged beyond repair" after an "unusual production process". Lieutenant Peter Putten of the research-unit of the Royal Netherlands Marechaussee argued in 2015, that the mistakes that led to the film never to be published and damaged beyond repair, was part of a cover-up by the Dutch government. Funny how evidence disappears in unusual circumstances is it not, if not setting fire to whole buildings or whole cities in the past to hide the evidence of a previously advanced civilization, this practice is all too common, almost as common as killing those who have the evidence. One of the leading involved MIVD-researchers did not go that far, but did argue it was strange the Dutch MOD told him to remain silent. It seems the NATO-countries tried to made sure Yugoslavia destroyed itself from inside out, and did not want anyone to find proof that they actively participated in war crimes with other purposes.

More Gladio investigations Newspaper de Groene published Dutch historians Wiebes and de Graaff's findings in an extra page, depicting Lubbers to have lied about the actual clandestine operations, and purposes of the organization. Their initial direct allies from the start next to the British were the CIA and the Mossad. It appears a Clandestine Planning Committee planned and organized foreign "counter-intelligence" operations, that at times tried to instigate coup d'etat's. The Dutch Gladio-division and a predecessor of the MIVD were actually working together in the same building, actively aiming to work together with the same methods for policies the SDS were following. At the supposed end of Gladio there were 38 known Dutch hidden weapon depots. The Dutch only... weren't that successful; they had "informants close to Indonesian President Sukarno up until 1964 as he was drifting towards communists" when the CIA attempted a coup in 1965; Ah the legendary Mr. Sukarno, he of Neil Keenan fame and all about gold and Kennedy which is a Black Sun family, claiming the stolen gold looted out of several countries during WW2. Of course the CIA attempted a coup there, all about the gold is why. Two Dutch agents got caught in Moscow and jailed for two years, Surinam dictator Desi Bouterse - who was steering to communism befriending Fidel Castro and the leader of Grenada. He discovered right hand and sergeant Roy Horb, suddenly got gifted expensive horses which led to his contacts being outed as CIA-operatives, leading to a

murderous spree of Bouterse which included Horb. In 2007 Maxime Verhagen, revealed a plan was cancelled to overthrow the dictatorship in 1986. Ruud Lubbers, Maxime Verhagen, Hans van den Broek confessed they and the Americans, actually planned to overthrow and arrests Bouterse with a full invasion in 1987, but did not do so out of fear for too many Dutch casualties. The villa also discovered and aided the Mossad in destroying a submarine communications cable between Egypt and Libya in 1972. De Groene also confirmed the Spanish Gladio agents had attempted to kill Dutch Princess Irene in 1975, and Prime Minister Cals was rumoured to have escaped a coup in 1965 by the Dutch counterparts. Two former agents threatened to "put agricultural poison in baby powder" in 1992 when blackmailing Dutch food business Nutricia.

2000s Wim Kok and his government resigned after the parliamentary enquiry about Yugoslavia published their findings. At this point neoconservatives from the SDS had surged to leading roles in the Dutch government and aligned institutes, leading the Dutch to join war on terror under Jan Peter Balkenende's command.

Neoconservaties and War on Terror Pim Fortuyn was assassinated on 6 May 2002, a week before the prime ministerial elections. His direct opponent Jan Peter Balkenende was elected instead. According to an international weekly journal of science called Nature Research, Balkenende's government oversaw at least 27 instances of the CIA planes, using Dutch airports near Amsterdam, Rotterdam and The Hague for extraordinary rendition in his first 4 years. One instance had the final destination set as Amsterdam, where a possible black site would be remains unclear. The leaked reports and their findings were not reported in Dutch commercially-controlled media. In a big leak of diplomatic cables, Balkenende turned out to be quite active during the Iraq War and Afghan War, gaining Dutch support for joining the intervention in both cases, promising to seemingly back the US for as long as they would be there.

Gladio Revelations In 2007 investigative reporter Peter R. de Vries stunned the public with new revelations about Operation Gladio in a 4 year-long investigation. Linking numerous weapons-depots in Utrecht, Amsterdam and Roermond to Gladio. Several corrupt police officers were revealed to have turned a blind eye, and even massively and actively participated in the distribution and hiding of weapons, and munitions to Belgium and "unknown foreign Gladio-criminals". At first weapons ended in the hands of the Dutch main drug lords. The weapons were traced back to be used in murders on police-agents, robberies on armoured cash transport cars, assassinations and more in Denmark, France, Germany according to further investigation by Brandpunt. Most notable was the consistent occurrence of arms smuggling, and suspects arrested, but released and not prosecuted, after the intervention of public prosecutors that derailed investigations, until the statue of limitations kicked in. That tells you it is an agency based crime syndicate. Even when a new owner of the munition-shop requested the shop to be cleared of any

wrong-doing publicly, summary proceedings had been rejected twice. Arms dealers that were suspected of smuggling Gladio-weapons were never jailed, but even given their license back while the case was under investigation. Meanwhile weapons had been linked to "murders on communists", the MIVD was listed as the company to have covered-up the instances of massive thefts, of the underground-depots in Dutch woods. At least one known company indicted has admitted, it's former owners were probably involved in Gladio. The whole investigation looked like a mafia movie, as several retired owners only declared to the police that, "they should stop searching" as "this goes much further", upon being released the next day. The Belgian journalist interviewed called it "ludicrous" that the Dutch did not instigate a parliamentary inquiry, as it appeared all Gladio-groups just went rogue, and "were full with Nazi's in every Gladio-country", and also implicating them in the Olaf Palme assassination, he was the Swedish Prime Minister. Koos Hertogs - murderer, kidnapper and rapist of 3 girls - was named in the book of Yugoslavian secret agent Slobodan Mitric as a Dutch Gladio-agent. Who he had trained with, to attempt a coup on an African country bordered by South Africa that was a former Portuguese colony (which points to Mozambique). Hartogs was filmed in an investigation with Peter R. de Vries, as being entangled in a cover-up with the presiding judge - Vice-President of The Hague Court Cornelis Stolk. Who he had given child pornography in exchange for a "better" judge, an evaluating psychiatrist that was previously married to Stolk, and free driver's lessons. Stolk actually managed to get an early release for Hartogs. In August 2012 writer Patrick Oomens published the book "The case Koos H.", in which he questions Koos H. being a serial killer, and concludes that he doesn't fit the profile. VIPaedophile including Hartogs, Joris Demmink and Klaas Bruinsma were all in a large long-reaching network, started to appear as official opposition narrative during the 2010s, which raised questions were one should look. Two sides of the same coin is that ploy, like Republican and Democrat, both Trump and Kushner were avid Democrats prior to 2016, Labor and Conservative in the UK, same program, the illusion of being opposition. All documents regarding "Gladio" were deleted in the 1990s, oh how convenient that is, I guess that came under the term National Security again then. And de Vries' sources claims "someone just stole all important pieces of evidence when we got close to a case". So all of this will remain memory holed and a Dutch third rail topic. Brandpunt and de Vries their investigations, appear to imply "Gladio has never ended", which was backed by several former agents and police-investigators. Brandpunt found a classified file from 1998 which stated "preparations have been made to have to make future O&I operations possible. Personnel and materials have been reserved." An unregistered company named "Quia Oportet" listed, was named as successor if needed, in both the Dutch MOD and the Dutch Ministry of Dutch Ministry of General Affairs in their files in 2002. But the government responded, this company and all files regarding it are "state-secret" and will not be released until 2050. Is this a confirmation of Operation Gladio B? you bet it is. PARADISE (WHAT ABOUT US)

2010s At this point with the rise of Internet and social media, the importance of controlling the narrative on media became important. The Dutch were active specialized contributors to "counter-terrorism." The Dutch called the Russians not neutral, and therefore not welcome in the investigation of Malaysian Airlines 17. Sijbren de Jong, Maria de Jong and the Dutch MOD set up the Dutch cluster of the Integrity Initiative. The Integrity Initiative (II) is an organ of the UK Deep state, controlled through the Institute for Statecraft. It was exposed in 2018-19 by 7 sets of leaked documents. Craig Murray blogged that it "offers us a glimpse into the very dirty world of surveillance and official disinformation. If we actually had a free media, it would be the biggest story of the day." Lucy Morgan Edwards summarised it in January 2019 as "an extremely shady covert disinformation and anti-democratic deep state outfit". In 2018 Rian van Rijbroek appeared on Dutch TV, introduced in 2018 on Dutch TV as a cyber security expert, and a hacker working for an intelligence agency, and multiple governments again indicting Russia, China and North Korea. In 2019 the Clingendael Institute hosted Strengthening Europe's 'soft' and 'hard' defence, a Chatham House rule meeting attended by at least 4 members of the UK Deep state's Institute for Statecraft. The brother of a deceased Gladio-member gifted his brothers enormous-depot to the police of Rotterdam in 2019. In July 2019 the AIVD tried to prohibit Dutch journalist Huib Modderkolk from releasing a book, that was planning to reveal the name of the operation and a foreign spook, that cooperated in the Cozy Bear case. The case was noted by lawyers to be very strange, as the AIVD seemingly tried to censor parts that were requested with public sources, before he finished the book. The AIVD won the case even though Modderkolk had already removed details, after he e-mailed them a concept version. Modderkolk started investigating after he produced an article regarding the sources of wikileaks, and his office was inexplicably hit with power outrages, which he and his colleague suspected was done deliberate. Modderkolk worked 6 years on this book - called It's war, but nobody sees it - and among other things revealed the CIA often utilized the AIVD for quite intensive tasks. Which included aggressive cyber warfare such as involvement in the spreading of the Stuxnet-virus in Iran), that the AIVD got nothing back for return. Among other things, the book is full of interesting questionable decisions by the AIVD, including the "suicide" of infant-hackers, giving the CIA classified information for drone attacks killing more children. Bellingcat has its own office in the Hague, and receives significant funding from Dutch sources through formally 'private' organizations, like the Adessium Foundation. Their universities have produced numerous deep politicians. LSV Minerva seems similar to Skull and Bones only a tiny bit slightly less effective, or not as thoroughly investigated? The secret Commission for Intelligence and Security Services revealed the MIVD had collected 1,8 million metadata of wiretapped telephone-data in one month, this data was shared with the NSA. Clingendael Institute In 1983 Clingendael Institute was founded by the Dutch MOD, it was the result of a merger of 5 small think-tanks. Nowadays it receives 75% of its funding from the Dutch Ministry of Foreign Affairs and Dutch MOD, and is mentioned among "major national think tanks" (such as Egmont, Chatham House etc.) in Integrity Initiative documents.

Functions The Netherlands likes to boost an image of being "the most well-behaved boy in the EU-class" and hosts several international organizations supporting "democracy". It has its own military info-war system.

NATO's public relations NATO is popular in the Netherlands, and actively participates in all parts of its joint military operations, including propaganda about them. The Dutch led by Mark Rutte in the 2010s have adopted a form of realpolitik, similar to Angela Merkel, and are willing to do anything to "stay on as members of the in-group that runs the Western world, to be taken serious inside NATO, and to be in the core countries of NATO." The country is the seat for NATO courts such as the International Criminal Tribunal for the former Yugoslavia. The ICC and the ICJ which are used to prosecute NATO's enemies, while being depicted as impartially dispensing justice on behalf of the "international community".

International Criminal Court The International Criminal Court is located in the Hague. The ICC wrote Tony Cartalucci, is neither "international nor a legitimate court, but is most certainly criminal. It is an institutionalized tool – one of many – used by Western corporate-financier interests, to coerce and control nations across the developing world."

International Court of Justice The International Court of Justice ignored the blatant illegality of the 2003 Iraq War, even when the Kuala Lumpur War Crimes Commission found Tony Blair, and a bunch of US government officials guilty of war crimes.

Organisation for the Prohibition of Chemical Weapons The Organisation for the Prohibition of Chemical Weapons, infamous for its biased investigations of alleged chemical weapons incidents (like Douma), has its HQ in the Hague. This is despite the heavy cover-up of disasters like the Bijlmer disaster. When the Israeli El Al airline crashed into apartment buildings in 1992, a cargo only plane that killed 43 people, although the real figure is unknown as that building contained many undocumented immigrants from Suriname and Aruba, both of which are former Dutch colonies, also people from Ghana. The flight flew from NY was also stated to contain military based chemicals, including sarin the nerve gas. The Dutch minister initially denied any military cargo, but after several people got sick on the ground, they eventually admitted it. The shipment was from a US chemical plant to the Israel Institute for Biological Research under a US Department of Commerce license, a bit like the Wuhan Institute in China incident then is it not?

Trafficking The port of Rotterdam and Schiphol Airport are major world transit hubs for all kind of cargo.

Child Porn Over a third of all child porn over the world is hosted on Dutch servers, likely KPMG servers which is Rothschild's owned. With an EU hotline reporting 82%, a British foundation 50% ("defeating the second ranked country the US by 42%) and even a one of the lowest estimates put Holland as hosting 20% of all images. The Amsterdam Internet Exchange (AMS-IX) is an Internet exchange point based in Amsterdam, in the Netherlands. Established in the early 1990s, the quality of this location and the Dutch infrastructure is given as reasoning. He agreed to pay a 390 euro fine. On October 13, the House of Representatives (Netherlands) approved a motion in which the PvdA, GL and the SP requested that an independent investigation be conducted into the nature and extent of "organized sadistic abuse of children", bypassing Grapperhaus' original refusal to investigate.

Mayer Amschel Rothschild sold the British government German Hessian mercenaries to fight against American Revolutionaries, diverting the proceeds to his brother Nathan in London, where N.M. (Nathan and Mayer) Rothschild & Sons was established. Mayer was a serious student of

Cabala and launched his fortune on money embezzled from William IX- royal administrator of the Hesse-Kassel region and a prominent Freemason. The Rothschild-controlled Barings bankrolled the Chinese opium and African slave trades. Barings bank later became ING, International Netherlands group. It financed the Louisiana Purchase, when several states defaulted on its loans, Barings bribed Daniel Webster to make speeches stressing the virtues of loan repayment. The states held their ground, so the House of Rothschild cut off the money spigot in 1842, plunging the US into a deep depression. It was often said that the wealth of the Rothschild's depended on the bankruptcy of nations. Mayer Amschel Rothschild once said, "I care not who controls a nation's political affairs, so long as I control her currency". War didn't hurt the family fortune either, the House of Rothschild financed the Prussian War, the Crimean War and the British attempt to seize the Suez Canal from the French. Nathan Rothschild made a huge financial bet on Napoleon at the Battle of Waterloo, while also funding the Duke of Wellington's peninsular campaign against Napoleon. Both the Mexican War and the Civil War were goldmines for the family. A Rothschild family biography mentions a London meeting where an "International Banking Syndicate", decided to pit the American North against the South as part of a "divide and conquer" strategy. German Chancellor Otto von Bismarck once stated, "The division of the United States into federations of equal force, was decided long before the Civil War. These bankers were afraid that the United States, would upset their financial domination over the world. The voice of the Rothschild's prevailed."

Rothschild biographer Derek Wilson says the family was the official European banker to the US government, and strong supporters of the Bank of the United States. Family biographer Niall Ferguson notes a "substantial and unexplained gap" in private Rothschild correspondence between 1854-1860. He says all copies of outgoing letters written by the London Rothschild's during this Civil War period "were destroyed at the orders of successive partners". There we have it again of destroying all evidence. French and British troops had, at the height of the Civil War, encircled the US. The British sent 11,000 troops to Crown-controlled Canada, which gave safe harbor to Confederate agents. France's Napoleon III installed Austrian Hapsburg family member Archduke Maximilian as his puppet emperor in Mexico, where French troops massed on the Texas border. A few generations earlier Mayer Amschel Rothschild bragged of his investment strategy, "When the streets of Paris are running in blood, I buy". Mayer Rothschild's sons were known as the Frankfurt Five. The eldest- Amschel- ran the family's Frankfurt bank with his father, while Nathan ran London operations. Youngest son Jacob set up shop in Paris, while Salomon ran the Vienna branch and Karl was off to Naples. Author Frederick Morton estimates that by 1850 the Rothschild's were worth over \$10 billion. Some researchers believe that their fortune today exceeds \$100 trillion. The Warburgs, Kuhn Loeb's, Goldman Sachs, Schiff's and Rothschild's have intermarried into one big happy banking family. The Warburg family- which controls Deutsche Bank and Banque Paribas- tied up with the Rothschild's in 1814 in Hamburg, while Kuhn Loeb powerhouse Jacob Schiff shared quarters with Rothschild's in 1785. Schiff immigrated to America in 1865, he joined forces with Abraham Kuhn and married Solomon Loeb's daughter. Edmond de R Loeb and Kuhn married each others sisters and the Kuhn Loeb dynasty was consummated. Felix Warburg married Jacob Schiff's daughter. Two Goldman daughters married two sons of the Sachs family, creating Goldman Sachs. In 1806 Nathan Rothschild married the oldest daughter of Levi Barent Cohen, a leading financier in London. Merrill Lynch super bull Abby Joseph Cohen and Clinton Secretary of Defense William Cohen are thus descended from Rothschild's. what a Cohen cidence - not. Hillary was a Rothschild and Bill is a Rockefeller, all the same inbreeding program of the royals, the pharaohs and the Hebrew Annunaki, where it all stems from. Today the Rothschild's control a far-flung financial empire, which includes majority stakes in most world central banks. The Edmond de Rothschild clan owns the Banque Privee SA in Lugano, Switzerland and the Rothschild Bank AG of Zurich. The family of Jacob Lord Rothschild owns the powerful Rothschild Italia in Milan. They are members of the exclusive Club of the Isles, which provides capital for George Soros' Quantum Fund NV, which made a killing in 1998-1999 destroying the currencies of Thailand, Indonesia and Russia. Soros was a major shareholder at Harken Energy. Quantum NV handles \$11-14 billion in assets and operates from the Dutch island of Curacao, in the shadow of massive Royal Dutch/Shell and Exxon Mobil refineries. Curacao was recently cited by an OECD Task Force on Money Laundering, as a major

drug money laundering nation. The Club of Isles group which funds Quantum is led by the Rothschild's and includes Queen Elizabeth II, and other wealthy European aristocrats and Black Nobility. Fugitive Swiss financier and Mossad cutout Marc Rich, whose business interests were recently taken over by the Russian mafia Alfa Group, is also part of the Soros network. Ties to drug money are nothing new to the Rothschild's. N. M. Rothschild & Sons was at the epicenter of the BCCI scandal, but escaped the limelight when a warehouse full of documents conveniently burned to the ground, around the time Rothschild-controlled Bank of England shut BCCI down, ah yet again the burning down of a building to hide evidence, unreal the amount of coincidences that, that happens. The House of Orange-Nassau (Dutch: is the current reigning house of the Netherlands.) A branch of the European House of Nassau, the house has played a central role in the politics and government of the Netherlands and Europe. Especially since William the Silent organized the Dutch revolt against Spanish rule, which after the Eighty Years' War (1568–1648) led to an independent Dutch state. Several members of the house served during this war and after as stadtholder ("governor") during the Dutch Republic. However, in 1815, after a long period as a republic, the Netherlands became a monarchy under the House of Orange-Nassau. The dynasty was established as a result of the marriage of Henry III of Nassau-Breda from Germany and Claudia of Châlon-Orange from French Burgundy in 1515. Their son René inherited in 1530 the independent and sovereign Principality of Orange from his mother's brother, Philibert of Châlon. As the first Nassau to be the Prince of Orange, René could have used "Orange-Nassau" as his new family name. However, his uncle, in his will, had stipulated that René should continue the use of the name Châlon-Orange, and so history knows him therefore as René of Châlon. After the death of René in 1544, his cousin William of Nassau-Dillenburg inherited all of his lands. This "William I of Orange", in English better known as William the Silent, became the founder of the House of Orange-Nassau. The House of Nassau is listed in several countries not just the Netherlands, United Kingdom, Ireland, Luxembourg, Belgium, France, Germany Orange, Nassau. A nobleman's power was often based on his ownership of vast tracts of land and lucrative offices. It also helped that much of the lands that the House of Orange-Nassau controlled sat under one of the commercial and mercantile centers of the world. This became possible and was part of the UK Magna Carta, lands owned by the Kings was transferred in power and ownership to Baron's and nobles, or nobility, not we the people as some espouse on the internet.
