BRICK IN THE WALL This is part 5 of our series of Expose shows that have focused largely on the Covid virus scam, that has affected not infected, the whole globe. First, there's the Infection Fatality Rate (IFR), this is the total number of people who are infected by a disease and the number of them who die. This figure includes those who have no symptoms at all, or only very mild symptoms – those who stayed at home, coughed a bit and watched Outbreak. Then there's the Case Fatality Rate (CFR), this is the number of people suffering serious symptoms, who are probably ill enough to be in hospital. Clearly, people who are seriously ill – the “cases” – are going to have a higher mortality rate than those who are infected, many of whom don't have symptoms. Put simply – all cases are infections, but not all infections are cases. Which means that the CFR will always be far higher than the IFR, with influenza, the CFR is around ten times as high as the IFR, and Covid seems to have a similar proportion. The CFR is the total number of deaths divided by the total number of people that have the disease's symptoms. In contrast, the IFR is the total number of deaths divided by the total number of people that carry the infection. Covid-19 has an IFR of 1% and CFR of 2–3%. More recent data by the CDC and WHO, however, estimates that Covid-19 has an IFR of 0.65% and 0.5-1%, respectively. The flu has an IFR of 0.1% or lower and CFR of 2–3%. Thus, among those who became symptomatic (i.e., CFR), Covid-19 is not any deadlier than the flu. This had led to the notion that lockdowns were not necessary as Covid-19 is just like the seasonal flu. The very fact that a major American learning center cannot tell the difference between 1% - 1.0 and 1/10% - 0.1, should raise enormous alarms bells. Who started the mistake that led to Fauci, Birx and others shouting for pandemics, lockdowns and mask mandates? The John Hopkins Center, who have degrees and PHD's in Math deficiency. The court stated, the PCR test's reliability depends on the number of cycles used and the viral load present. Citing Jaafar et al. 2020, the court concludes that "if someone is tested by PCR as positive when a threshold of 35 cycles or higher is used (as is the rule in most laboratories in Europe and the US), the probability that said person is infected is less than 3%, and the probability that the said result is a false positive is 97%." The court further notes that the cycle threshold used for the PCR tests currently being made in Portugal is unknown. The threshold cycles used in PCR tests in India is between 37 and 40, which makes the reliability of the PCR test less than 3% and the false positive rate as high as 97%. This case concerned the fact that four people had been quarantined by the Regional Health Authority. Of these, one had tested positive for COVID using a PCR test; the other three were deemed to have undergone a high risk of exposure. Consequently, the Regional Health Authority decided that all four were infectious and a health hazard, which required that they go into isolation. 97% of the time that positive tests are false positives, 97% and yet where is the media on this fact? Any test never mind medical of this importance, that delivers a 97% wrong testing result would be scrapped and yet the whole world is closed down, partially or otherwise based on these false positive test results and the fact the John Hopkins center is unable to do basic maths. A paper that analyzed the results of a massive post-lockdown Covid-19 testing drive, that included nearly every eligible resident of Wuhan, China has found no evidence that positive cases without symptoms spread the disease. The analysis, published in the scientific journal Nature, looked at the results of a screening initiative held between May and June in Wuhan, the city where the first cases of the novel corona virus were detected in late 2019. The origins of the virus have yet to be determined, with new studies suggesting that the disease could have been in Italy as early as September last year. Nearly 10 million people were tested, consisting of 92 percent of all residents aged six years or older. Incredibly, no new symptomatic cases were registered, and only 300 asymptomatic cases were detected. Symptomatic means constituting a symptom, as of a disease. Stated no new cases. Asymptomatic means neither causing nor exhibiting symptoms of disease. Stated only 300. Subsequent tests of 1,174 close contacts of the asymptomatic cases found resulted in no new positives. There is "no evidence that the identified asymptomatic positive cases were infectious," the paper said, adding that the results of the massive screening program could help health authorities "adjust prevention and control strategies in the post-lockdown period." The analysis seems to confirm preliminary findings that were released during the screening program. Professor Lu Zuxun, from Wuhan's Huazhong University of Science & Technology, said back in June that there was currently no evidence that asymptomatic people were passing the virus to other people, but cautioned at the time against drawing broad conclusions. The paper's

authors acknowledged that previous studies had found evidence that asymptomatic individuals were infectious and could become symptomatic later, but theorized that Wuhan residents still testing positive for the virus after the city's strict lockdown had a "low quantity of viral loads" and therefore were unable to pass the illness on to other people. The paper comes amid a growing debate over the effectiveness of Covid-19 restrictions. City and even nationwide lockdowns and mask-wearing mandates have been justified, using the argument that even asymptomatic individuals could spread the disease, and inadvertently overwhelm health services. When clearly all the evidence points to this not being the case. However, many have argued that the social and economic costs of lockdowns far outweigh any purported benefits, and have pointed to evidence that asymptomatic people are not infectious. Back in June, the World Health Organization (WHO) backtracked after stating that asymptomatic people rarely infect others with Covid-19, saying that there wasn't enough evidence to back up the claim. Yet lockdowns continue despite all the evidence to the contrary.

The Wuhan doctors also mentioned the alleged virus did not surface in Wuhan first, and mentioned Italy, here is a piece backing that claim up. The new corona virus was circulating in Italy since September 2019, a study by the National Cancer Institute (INT) of the Italian city of Milan shows, signaling that COVID-19 might have spread beyond China earlier than previously thought. But the Italian researchers' findings, published by the INT's scientific magazine Tumori Journal, show that 11,6% of 959 healthy volunteers enrolled in a lung cancer screening trial between September 2019 and March 2020, had developed coronavirus antibodies well before February. A further specific SARS-CoV-2 antibodies test was carried out by the University of Siena for the same research titled "Unexpected detection of SARS-CoV-2 antibodies in the pre-pandemic period in Italy". It showed that four cases dated back to the first week of October were also positive for antibodies neutralizing the virus, meaning they had got infected in September. "This is the main finding: people with no symptoms not only were positive after the serological tests but had also antibodies able to kill the virus," Apolone said. All of which means we don't need no vaccine.

Dr. Anthony Fauci, the nation's leading infectious disease expert who has guided the U.S. through the pandemic, no he didn't guide us through anything except a total lie and a fake pandemic, he projected Americans could expect their first doses of an approved corona virus vaccine as early as April. Front-line health care workers are expected to get their first doses by the end of December or early January. After prioritizing people at risk of infection or severe disease, the healthy general population can expect first doses of a vaccine starting in April, and through July if all continues on track. BS in Microbiology, Washington State University Q: How long do you think it will be until there's a vaccine? KK: The shortest time to get a vaccine has been four years; the average is 10 to 15 years. The fact that we think we might have a vaccine in just a year is scientifically pretty amazing. Scientists mapped the entire genome of the virus within a month from when it was identified. It's amazing to look at how much we do know about this virus in such a short period. Indeed Ms. Kamm it is amazing and extraordinary as all other vaccines take over a decade, but she stated they mapped the entire genome of the virus within a month, so how does she explain this piece then? Is the vaccine done by moderna, or is the vaccine mode RNA? it's all in the words once you "see". So what is RNA? Ribonucleic acid (RNA) is a polymeric molecule essential in various biological roles in coding, decoding, regulation and expression of genes. Take note of the words coding and decoding, as it will become clear why later. RNA and DNA are nucleic acids, along with lipids, proteins, and carbohydrates, nucleic acids constitute one of the four major macromolecules essential for all known forms of life. Like DNA, RNA is assembled as a chain of nucleotides, but unlike DNA, RNA is found in nature as a single strand folded onto itself, rather than a paired double strand. Cellular organisms use messenger RNA (mRNA) to convey genetic information (using the nitrogenous bases of guanine, uracil, adenine, and cytosine, denoted by the letters G, U, A, and C) that directs synthesis of specific proteins. Many viruses encode their genetic information using an RNA genome. So having establish RNA is a messenger of code, which is likely why humans can be computer like in nature. The RNA delivers the code and changes the expression of the genes, but like all coding it depends on who encodes the code and the information contained within it. The RNA is the deliverer of genetic information, and so has the potential to alter our genetic coding. Some RNA molecules play an active role within cells by catalyzing biological reactions, controlling gene expression, or sensing and communicating responses to cellular signals. One of these active processes is protein synthesis, a universal function in which RNA molecules direct the synthesis of proteins on ribosomes. This process uses transfer RNA (tRNA) molecules to deliver amino acids

to the ribosome, where ribosomal RNA (rRNA) then links amino acids together to form coded proteins. Coding, decoding, messenger, communicating responses, all very computer like that is it not?

The first two vaccines to show any results - made by Pfizer-BioNTech and Moderna - both use an experimental approach, called mRNA, which involves injecting part of the virus's genetic code into the body to train the immune system. Antibodies and T-cells are then made by the body to fight the coronavirus, is the theory, yet urine therapy works in exact the same way, yet curiously is not used by organized medical practices. The theory behind that is the urine has filtered through our system, and contains genetic coding of all the waste contained within the sample. Upon testing the sample the genetic codes are revealed and so then a treatment for excessive, rogue or wrong cells is then formulated. But both the normal vaccines and the urine sample contain live virus material, and when taken or absorbed the body then reacts to the coded information it receives, and counteracts the virus or rogue antibodies contained within our bodies. What this reveals to us all is, these vaccines are not the traditional vaccines that administers live virus, this has no live virus present, and only the genetic code of the virus. Who are BioNTech? They are a German company who in August 2018, BioNTech announced that it had entered into a multiyear research and development collaboration with the US company, Pfizer Inc. to develop mRNA-based vaccines for prevention of influenza. Under the terms of the agreement, following BioNTech's completion of a Phase I clinical trial, Pfizer would assume sole responsibility for further clinical development and commercialization of mRNA-based flu vaccines. In September 2019, it signed an agreement with the Bill & Melinda Gates Foundation to develop HIV and tuberculosis programs, to identify and develop preclinical vaccine and immunotherapy candidates for the prevention of HIV and tuberculosis infections, and for the long-term antiretroviral therapy-free remission of HIV diseases. The company is working to develop the BNT162b2 vaccine against SARS-CoV-2 with Pfizer and Fosun. Fosun are linked to the Carlyle group also, they are an asset management group in the main. In June 2020, BioNTech received €250 million from Temasek Holdings (Singapore), which is the same company board that housed by the Swedish clown Marcus Wallenberg.

Operation Warp Speed (OWS) is a public-private partnership, initiated by the U.S. government to facilitate and accelerate the development, manufacturing, and distribution of COVID-19 vaccines, therapeutics, and diagnostics. Operation Warp Speed was introduced in early April 2020, after a round-table meeting with industry executives at the White House on March 2. It will promote mass production of multiple vaccines based on preliminary evidence allowing for faster distribution, if clinical trials confirm one of the vaccines is safe and effective. The plan anticipates that some of these vaccines will not prove safe or effective, making the program more costly than typical vaccine development, but potentially leading to the availability of a viable vaccine several months earlier than typical timelines. "The plan anticipates that some of these vaccines will not prove safe or effective" so not just the UK who anticipate this vaccine will not be safe then, and we are suppose to trust these people? On March 27th, the United States Congress allocated nearly \$10 billion for Operation Warp Speed through the CARES Act (Coronavirus Aid, Relief, and Economic Security) with \$6.5 billion designated by Congress for countermeasure development through BARDA, along with \$3 billion for NIH research. Operation Warp Speed is an interagency program that includes components of the Department of Health and Human Services, including the Centers for Disease Control and Prevention, Food and Drug Administration, the National Institutes of Health, and the Biomedical Advanced Research and Development Authority; the Department of Defense; private firms; and other federal agencies, including the Department of Agriculture, the Department of Energy, and the Department of Veterans Affairs. CDC are a vaccine manufacturer not a governmental body, FDA is also not a governmental body either, the term federal agency, they operate outside of Government, or actually run it in most cases. Legislative definitions of the term federal agency are varied, and even contradictory, the official United States Government Manual offers no definition. NIH started out as US navy hospital group, they became Federal which is not a government term and is a separate body altogether from the government, in 1944 under the Federal Public Health Act. Do they have precedence in giving patients injections without consent, yes in the 1960s, virologist and cancer researcher Chester M. Southam, injected HeLa cancer cells into patients at the Jewish Chronic Disease Hospital. When three doctors resigned after refusing to inject patients without their consent, the experiment gained considerable media attention. By the 1990s, the NIH committee focus had shifted to DNA research, and launched the Human Genome Project. Dr. Fauci and Deborah Birx both worked for NIH, in fact she worked in the same lab as him 1983-1986. Her husband was Bill Clinton's advance man organizing all trips made by the Clintons, Reffe currently serves

on the Board of Directors of the US Committee to Expand NATO. Biomedical Advanced Research and Development Authority or BARDA for short, manages an 2004 operation called Project Bioshield, which provides a mechanism to fund the research, development and stockpiling of vaccines and treatments that the government could use, during public health emergencies such as chemical, biological, radiological or nuclear (CBRN) attacks. The term Project should always bring concern, you all should know which organization run all the projects by now, the CIA. As for the rest, the DOD runs DARPA, just some of the activities of DARPA, insect allies program 2017-2021 program. In 2016 a tender for contracts to develop genetically modified plant viruses, for an approach involving their dispersion into the environment using insects. Plant viruses hold significant promise as carriers of gene editing circuitry, and are a natural partner for an insect-transmitted delivery platform. In 2014 they did this, Brain implants, often referred to as neural implants, are technological devices that connect directly to a biological subject's brain. Some brain implants involve creating interfaces between neural systems and computer chips. This work is part of a wider research field called brain-computer interfaces. (Brain-computer interface research also includes technology such as EEG arrays, that allow interface between mind and machine but do not require direct implantation of a device.) Throw in they are responsible for HAARP, robotic insects and animals for warfare, and rogue human influencing satellites they are also involved in, and you see a bigger picture. President Trump officially announced the public-private partnership on May 15, 2020. Operation Warp Speed will coordinate existing Health and Human Services-wide efforts, including the NIH ACTIV partnership for vaccine and therapeutic development, the NIH RADx initiative for diagnostic development, and work by BARDA. The Food and Drug Administration announced on June 30, 2020 that the vaccine will need to be at least 50% effective to gain approval, in at least diminishing the severity of COVID-19 symptoms. Only 50% effective to gain a pass from the FDA oh my, but then this was the same agency along with influence from Donald Rumsfeld, who said Aspartame was safe as a substitute sweetener. The company who developed that was G.D Searle, who Rumsfeld was CEO and then President of the same company, guess who owns the trademark for G.D Searle? Pfizer!!, G.D Searle eventually merged into another company of genetic modifying called, Monsanto. So, if you needed confirmation your so called government would not approve an unsafe vaccine, Rumsfeld and Ronald Reagan were both involved in getting a cancer causing Aspartame approved. Months before the COVID-19 pandemic, the White House Council of Economic Advisers prepared a report at the request of the National Security Council's biodefense team. The report emphasized how federal policy needed to encourage private and public partnerships, to enable faster approval and production of vaccines during a pandemic. The fact this biodefense team was assembled before the pandemic suggests further, advance knowledge of this event unfolding. Remember us outing the Pentagon earlier in the year of having mass quantities of PPE's with \$1.25 masks they were going to sell to Americans for \$7, the Pentagon had acquired those in or before December 2019. After Rick Bright, the BARDA Director was reassigned on or about April 22, following his resistance of "efforts to fund potentially dangerous drugs promoted by those with political connections," Moncef Slaoui was named in May by the Trump administration as Operation Warp Speed chief adviser. Slaoui is a vaccine researcher and, formerly, Chairman of Global Research and Development and Chairman of Global Vaccines at GlaxoSmithKline, where he led the development of five major novel vaccines. Slaoui is also a major stockholder in the 6 leading BioPharma corporations. His wife works for the John Hopkins Center, all in house you see, House being the operative word, House of? General Gustave F. Perna, who served as commanding general of Army Materiel Command, was named Operation Warp Speed chief operating officer, looks very born to, to me but not confirmed. The project has other scientists, physicians, and military officers involved in management of the key focus areas of development, manufacturing, and distribution. The project has a budget of \$10 billion, with additional funds allocated through BARDA. Operation Warp Speed was managed by White House senior adviser Jared Kushner with the support of the United States Department of Defense and the United States Department of Health and Human Services. Kushner has tentative links with the group known as Fosun, and his deal with a Chinese group for masks was almost certainly done with that group. We outed Kushner, FEMA and Gavin Newsome has having done that deal for PPE's, whilst threatening and banning the American companies including 3M from selling PPE's to Americans.

The Human Genome Project (HGP) was an international scientific research project, with the goal of determining the base pairs that make up human DNA, and of identifying and mapping all of the genes of the human genome, from both a physical and a functional standpoint. It remains the world's largest collaborative biological project. Planning started after the idea was picked up in 1984 by the US government, the project formally launched in 1990, and was declared complete on April 14, 2003. Picked up in 1984? all a bit Orwellian that is it not? When you consider that the website group known as Ancestry.com was also launched in the same time period of 1986, deeper questions emerge. Funding came from the US government through the National Institutes of Health (NIH) as well as numerous other groups from around the world. A parallel project was conducted outside the government by the Celera Corporation, or Celera Genomics, which was formally launched in 1998. Most of the government-sponsored sequencing was performed in twenty universities and research centers in the United States, the United Kingdom, Japan, France, Germany, Spain and China. The Human Genome Project originally aimed to map the nucleotides contained in a human haploid reference genome (more than three billion). The "genome" of any given individual is unique; mapping the "human genome" involved sequencing a small number of individuals, and then assembling these together to

get a complete sequence for each chromosome. Therefore, the finished human genome is a mosaic, not representing any one individual. Yet their test results combined people into color coded regions, which is group genome not individual. The Human Genome Project was a 13-year-long, publicly funded project initiated in 1990, with the objective of determining the DNA sequence of the entire euchromatic human genome within 15 years. The project was not able to sequence all the DNA found in human cells. It sequenced only euchromatic regions of the genome, which make up 92.1% of the human genome. The Human Genome Project (HGP) was declared complete in April 2003. When you consider that Project Bioshield was launched less than a year later, which provides a mechanism to fund the research, development and stockpiling of vaccines and treatments that the government could use during public health emergencies such as chemical, biological, radiological or nuclear (CBRN) attacks. Perhaps now we see a larger picture emerging, that has numerous branches and implications? WERE NOT GONNA TAKE IT

Legally mandated vaccination or "forced vaccination" has long understood to be a grievous infringement of freedom, but has been carried out in some countries, including in the US. And in Article 6.1, Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be expressed and may be withdrawn by the person concerned at any time, and for any reason without disadvantage or prejudice. For this very reason is why they are currently stifling all knowledge that is beneficial to we the people, with their army of false news and checkers reaching a scale this year of epic proportions. First Amendment to the United States Constitution prevents the government from making laws which regulate an establishment of religion, or that would prohibit the free exercise of religion, or abridge the freedom of speech, the freedom of the press, the freedom of assembly, or the right to petition the government for redress of grievances. It was adopted on December 15, 1791, as one of the ten amendments that constitute the Bill of Rights. Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. Do state governments have the authority to compel such refusers, to get vaccinated on threat of punishment? In *Jacobson v. Massachusetts* (1905), the U.S. Supreme Court confronted a state law, that allowed local governments to require smallpox vaccinations, when the local health authorities deemed them necessary. Cambridge resident Henning Jacobson balked at his city's vaccination requirement and was fined \$5. He contested that penalty and took his case all the way up to the highest court in the land. What was Jacobson's legal argument? In the words of the Court, Jacobson, insists that his liberty is invaded when the State subjects him to fine or imprisonment, for neglecting or refusing to submit to vaccination. That a compulsory vaccination law is unreasonable, arbitrary and oppressive, and, therefore, hostile to the inherent right of every freeman, to care for his own body and health in such way as to him seems best. The Supreme Court rejected that argument. That came about after Boston which was a hot bed of anti vaccine people, underwent compulsory door to door vaccination, after the state initially blamed the homeless for the disease. No one asks why didn't the state do anything to prevent people being homeless in the first place? I know common sense question again. Quarantine camps are they new ideas? think again. Boston 1901-1903, All patients with smallpox, except those who were extremely ill, were taken to special facilities. A detention hospital on Southampton Street served as the main hospital. When additional beds were needed, the quarantine facilities on Gallop's Island, in Boston Harbor, were hastily expanded. It wasn't just Boston though that implemented it, a certain place situated just down the coast, just had to get in on the act as well, yes New York. How New York Separated Immigrant Families in the Smallpox Outbreak of 1901. Vaccinations were administered by police raids, parents and children were torn apart, and the New York City Health Department controlled the narrative. Late on a Friday night in February 1901, when the residents of an Italian neighborhood in New York City's East Harlem were home and sleeping, a battalion of more than 200 men police officers and doctors, quietly occupied the roofs, backyards and front doors of every building for blocks. Under the command of the Bureau of Contagious Diseases, they entered the homes one by one, woke every tenant, scraped a patch of their skin raw with a lancet, and rubbed the wound with a small dose of the virus variola. It was a smallpox raid, and the residents in good health were being vaccinated. But for anyone who showed any symptom of smallpox, the events of that night were even more alarming. They were taken immediately to docks on the East River, and sent by boat under the cover of night to an island just south of the Bronx, called North Brother. Today, North Brother Island is an overgrown and uninhabited bird sanctuary; from the 1880s to the 1940s, it was a thriving complex of quarantine hospitals for typhoid, smallpox, tuberculosis, diphtheria and other contagious illnesses. As of 1901, as the *Atlanta Constitution* reported, mere mention of the place to a New Yorker was "like conjuring up a bugaboo." Both North Brother Island and South Brother Island were claimed by the Dutch West India Company in 1614 and were originally named "De Gesellen", translated as "the companions" in English. The islands were both originally part of Queens County. On June 8, 1881, North Brother Island was transferred to what

was then part of New York County (later to become the Bronx). On April 16, 1964, South Brother Island was also transferred to the Bronx. The islands had been incorporated into Long Island City in 1870, before the consolidation of New York City in 1898. Long Island of course is associated with other types of heinous experimentation on humans, the infamous Montauk project was ran from there also, is it connected the two stories? you decide.

On the subject of the CIA we revealed this nugget of information on September 24th show, that could well be linked from the previous piece. The CIA launched its own federal lab and research and development branch on Monday. CIA Labs makes the agency a possible research partner, for the more than 300 other federal labs and academic experts. The agents would then be able to take a portion of the profits, while the CIA will take the rest of the money, according to the MIT Technology Review. Officers could make 15 percent of the total income with a maximum of \$150,000 per year. The research areas that CIA Labs cover will include artificial intelligence, bioscience, virtual and augmented reality, quantum computing and advanced materials and manufacturing, among others, according to a release. "CIA Labs conducts multidisciplinary research, development, testing, and engineering to address new challenges; adapt, improve, or accelerate the production of existing solutions; and solve persistent scientific and technological problems in new ways," the release said. The CIA requests that other federal labs and academic leaders send in their ideas to work together via an online form. Dawn Meyerriecks, the head of CIA's directorate of science and technology, said in a statement that CIA Labs "will help us maintain our competitive edge and protect our nation." For those new the original term for nation did not mean country, but race. With the CIA being directly involved in the ET narrative with the Majestic 12, and being formed just months after the Roswell and Aztec crashes, one has to ask the question, which race are the CIA? they chose for that enzyme, you think that is a coincidence? It's not. Neuropeptide Technology Cell Lysis (n.) "dissolution of cells, bacteria, etc.," 1902, from -lysis or from Latin lysis, from Greek lysis "a loosening," from lyein "to unfasten, loose, loosen, untie" (from PIE root *leu- "to loosen, divide, cut apart"). Earlier in the sense "gradual recession of a disease" elisis? Perhaps it is not lysis at all, but if you add bio to it, it perhaps makes more sense of what they are actually doing. Bio means of life, lysis means to loosen or unfasten, when the two are added together you get the word biolysis. Biolysis first formed in 1865, and means "the destruction of life," later more specifically "dissolution of a living organism, resolution of a dead organism into its constituent matter" Luciferase, CAT, and alkaline phosphatase reporter activity accumulate primarily in the cytoplasm of transfected cells. Transfected cells are harvested by washing the adherent cells in the plate with phosphate-buffered saline 3 times. Cells are then lysed by the addition of 1 ml per 100-mm plate of Triton lysis buffer. Presence of the reducing agent dithiothreitol (DTT) is critical to maintain luciferase enzymatic activity. The lysed cells are scraped with a rubber policeman, which is a plastic or rubber scraper, transferred to Eppendorf tubes, and vortexed, and the insoluble material is pelleted in a microcentrifuge for 5 min at 4°C. After transfer to new Eppendorf tubes, 100 μ l of each supernatant (the cytoplasmic fraction) is assayed for luciferase reporter activity, and 50 μ l is used for assay of alkaline phosphatase reporter activity. U to L is Cubic Micrometer and Liter conversion. The firefly luciferase reporter assay provides rapid results of cellular transfections. Approximately 112–3 hr should be sufficient for the experienced user to produce triplicate results of luciferase, and the internal control alkaline phosphatase assays.

Circadian Rhythms Introduction: Luciferases are naturally occurring protein enzymes that catalyze emission of light from a substrate (luminescence). Many structurally heterogeneous forms of luciferase exist, in a wide range of species. The best known is firefly luciferase, which catalyzes the emission of green (~560 nm) photons from its natural substrate, firefly luciferin, in the presence of oxygen and ATP. Many luciferases have relatively short half-lives of just a few hours, or even ~1 h in some cases, making them good reporters of changes in transcriptional rate on a circadian timescale. Genes for firefly luciferase and a few others have been cloned and are available commercially. Luciferase luminescence is extremely dim, often too dim to be seen by the unaided eye in experimental applications. Various much brighter fluorescent reporters are available, and two of these have been used successfully to monitor circadian rhythms. Green fluorescent protein (GFP) and "Cameleon," a sensor of cytoplasmic $[Ca^{2+}]$. Luciferase, however, enjoys two principal advantages over the fluorescent reporters. First, luciferase does not require exogenous illumination: the light detected is emitted from the biological sample itself. Fluorescent reporters, on the other hand, require bombardment with toxic, relatively high-energy photons, so that the reporter can be excited and then re-emit lower-energy photons. Over long-term circadian experiments, phototoxicity is a serious concern

with fluorescent reporters but a nonissue with luciferase. Second, background emission of light by biological samples (or by luciferase substrate alone) is generally extremely low, whereas autofluorescence background levels can be as high as the fluorescence signal of the reporter itself. GFP fluorescence, for example, spectrally overlaps that of riboflavin (vitamin B₂), an essential enzyme cofactor found in biological tissues and culture media. So it overlaps riboflavin, what is that purpose? It is required by the body for cellular respiration. Respiration refers to a person's breathing and the movement of air into and out of the lungs. The respiratory system provides oxygen to body tissues for cellular respiration, removes the waste product carbon dioxide, and helps maintain acid-base balance. So it overlaps your respiratory system, bit like masks then. Connecting more dots now? Thus, despite its modest photic output, luciferase is well suited as an optical reporter of circadian function. These transgenic organisms exhibit robust (although quite dim) circadian rhythms of bioluminescence, useful for a wide range of genetic and biochemical studies of circadian clock mechanisms. Expression of the luciferase gene fusion product confers on the host the ability to glow in the dark. The reporter visualizes transcriptional and translational expression of the attached foreign gene, and enables one to localize it to particular domains, cells, or organelles of almost any organism. This can be done noninvasively, with inexpensive, nonisotopic, easily available substrates, and at extremely high sensitivity under no significant endogenous background. So these microchips are being made with bioluminescence to be able to be scanned externally, and does not reveal itself to the host.

Luciferase Assay A luciferase assay is used to determine if a protein can activate or repress the expression of a target gene. Unlike the ChIP or EMSA assays, which only assess the ability of a protein to interact with a region of DNA, a luciferase assay is able to establish a functional connection between, the presence of the protein and the amount of gene product that is produced. This assay is unable to determine whether the protein directly interacts with DNA itself; the protein could indirectly affect transcription by activating or repressing a separate protein or protein complex that affects transcription. So, this microchip can not only target our genes, but our proteins, our DNA and also RNA, mode RNA now makes more sense does it not?

In light of Elon Musk and the mention of Deus Ex, I decided to look into it as a potential clue and I am sure you will all at THI, be familiar with the narrative most of which was warned of in this show. Deus Ex is a series of role-playing video games, the series, set during the 21st century, focuses on the conflict between secretive factions who wish to control the world by proxy, and the effects of transhumanistic attitudes and technologies in a dystopian future setting. (remember recently we discussed of how they always say dystopian to make it out as a future event, when it is the past or now) Deus Ex (2000), Deus Ex: Invisible War (2003), Deus Ex: Human Revolution (2011), Deus Ex: The Fall (2013), Deus Ex Go (2016) and Deus Ex: Mankind Divided (2016). While each game has

a distinct story, they are all set within the same world: an Earth of the future which has evolved a dystopian cyberpunk society. In this setting, several organizations compete for overall control of the world, several of the societies mentioned or shown are inspired by real-world and invented secret societies and conspiracy theories. The one constant through the series is the Illuminati, although FEMA, Majestic 12, and the Knights Templar are also featured. The main characters in the series possess artificially acquired superhuman abilities, referred to as "Augmentation". Deus Ex takes place during 2052, while the world is facing a crisis, caused by a mysterious nano-virus called the Gray Death. The fact that the 2 vaccines are stored at such record low temperatures by Pfizer and Moderna has been suggested that they contain nano particles, as no other vaccine or drugs is stored at such low temperatures. In the midst of the crisis, JC Denton, a nano-augmented rookie agent for the United Nations Anti-Terrorist Coalition (UNATCO), is sent to eliminate terrorist cells, but ends up drawn into the various schemes of rival factions and secret societies, who are responsible for the epidemic. Once he arrives in Area 51, Denton has the choice between neutralizing technology and plunging the world into a second dark age, allying with the Illuminati, or merging with an advanced AI so as to impose a benevolent dictatorship. That last sentence is deliberately misleading, the idea that neutralizing technology will plunge us into a dark age is, pure fear porn, it is the AI that will plunge us out of our current mode of existence, I will go into more later. Invisible War takes place twenty years later, after a massive economic depression and period of war called the Collapse, that was indicated by Denton's actions and a combination of possible events from the first game. The game's protagonist, Alex D, a clone of Denton, is drawn into a conflict between two seemingly opposing factions, and learns of conspiratorial factions which seek to drastically change the world, including JC Denton: Alex can perform missions for any of them, and eventually becomes able to choose which organization should rule the world. That is the Rothschild's and Black Sun, both of them are being duped and manipulated at this point, and always have been. Human Revolution is set in 2027, twenty-five years before the first title, where corporations have extended their influence past the reach of global governments, and the development of bio-mechanical augmentation by a few elite and powerful companies threatens to destabilize society. That is ongoing now, they always say the future, when it is now or mainly in the past. The game follows Adam Jensen, the security chief for bio-tech company Sarif Industries. After a devastating attack on Sarif's headquarters which leaves him near-death, Adam is forced to undergo radical augmentation surgery, and he becomes embroiled both in the search for the attackers and the political and ethical repercussions of augmentation technology. Of all the names to pick for a so called fiction, they choose Adam, there have been many, not all where human, but the next Adam will be vastly different from all previous forms, unless we stop it. The Fall is a parallel story, set after the spin-off novel Icarus Effect. (The term refers to the phenomenon of businesses failing abruptly after a period of apparent success, where this failure is brought about by the very elements that led to their initial success. The historical script:

Bulls take everything to ever more extremes and keep raising target prices along the way ignoring the technical charts that scream caution as technical disconnects keep stretching to historical extremes. (Icarus flying to the sun with no consequences is the pervasive theme during each bubble.) As a side note, did you know over 70% of new manufacturing plants in North America, for example, close within the first decade of operations. Around 75% of mergers and acquisitions do not pay off – the acquiring firm's shareholders lose more than the acquired firm's shareholders gain. The Icarus paradox. Augmented means to make bigger, greater or more complete and is indicative of the super soldier and robot program, but lets look at other aspects of it called Augmented reality. Augmented reality (AR) is an interactive experience of a real-world environment, where the objects that reside in the real world are enhanced by computer-generated perceptual information, sometimes across multiple sensory modalities. Augmented reality is related to two largely synonymous terms: mixed reality and computer-mediated reality. It follows the story of Ben Saxon, an augmented former British SAS mercenary, who is on the run from his former employers, a group of augmented mercenaries that play a crucial part in the plot of Human Revolution. It is not Revolution, but devolution. Mankind Divided is set in 2029, 2 years after the events of Human Revolution in a world dealing with the consequences of the previous game's events, regardless of the choice made by Adam at the end of Human Revolution, the Illuminati have twisted his message and augmented individuals are persecuted and feared. A disillusioned Adam works with an international taskforce (hinted to be a precursor to UNATCO in Deus Ex) designed to stop the rising wave of terrorism, brought on by the disenfranchised and desperate augmented, while working to uncover the perpetrators of the events that led to the current state of the world.

Then we come to this latest hint of reality, augmented or otherwise. Tech mogul Elon Musk unveiled his latest foray into science fiction Friday night: a brain chip implant to allow people who are paralyzed to operate technology, such as smartphones or robotic limbs, with their thoughts. It has nothing to do with the sympathy for the paralyzed at all, that is a seducement into a dark agenda program. "I think it's going to blow your minds," Musk said. Schwab admits: “Unlike certain past epidemics, COVID-19 doesn’t pose a new existential threat.” Despite the corona virus not being an “existential threat,” Schwab believes that it can and should be used as the catalyst to create a new world system, which he calls the “Great Reset.” A new system where capitalism still exists in a watered down form, but where the real power is wielded by a few global elites with more authoritarian forms of government aiding and abetting them. Schwab also speaks of a coming Fourth Industrial Revolution, where most human jobs will be accomplished by robotics. “The COVID-19 crisis has shown us that our old systems are not fit anymore for the twenty-first century. It has laid bare the fundamental lack of social cohesion, fairness, inclusion and equality,” Schwab said. “In short, we need a great reset.” For Schwab, a choice exists between going back to the capitalist status quo, which has served most quite well since the end of World War II, and a new system of capitalism-lite with Marxist elements thrown in. “Specifically, we will need to reconsider our collective commitment to ‘capitalism’ as we have known it,” Schwab writes. Schwab continued: “We must rethink what we mean by ‘capital’ in its many iterations, whether financial, environmental, social, or human. In Schwab’s new world, things such as rolling lock-downs, crowd restrictions, and mask mandates will become a permanent part of not only America, but the entire world. This change, Schwab believes, is coming whether we like it or not. “Radical changes of such consequence are coming that some pundits have referred to as ‘before corona virus’ (BC) and ‘after corona virus’ (AC) era. We will continue to be surprised by both the rapidity and unexpected nature of these changes — as they conflate with each other, they will provoke second -, third -, fourth – and more-order consequences, cascading effects and unforeseen outcomes,” Schwab writes. When you break it all down, Schwab’s pronouncements are little more than a repackaging of the same globalist agenda that we’ve been hearing about since the 1990s. This time, however, globalists such as Schwab are using the COVID-19 pandemic as an excuse to foist their collectivist ideas on the world. A timely reminder of the timeline of their plans.
