We have to start to getting prepared for the inevitable mass losses of people and process it now, and ultimately gather together to protect, support and care for each other. We can all deny it and not face the uneasy prospect of it all unfolding, but reality has a way of biting back. This is our time to come together, our time to prepare, our time to process the potential of life with large numbers of people missing. People may say that is a bit dark, but is it not better to make plans incase of a situation arises? than to react to an outcome? We have spoken of this often of, being proactive not reactive. Humanity has a bad habit of being reactive and not proactive, which is future thinking. With reactionary traits, you are immediately on the back foot and it often leads to making errors playing catch up. The clowns and their Hebrew Annunaki counterparts have always ran many simulation exercises and determined their eventual outcome, this is how they implement their disaster events on the public. All the evidence points to a very dark winter, which curiously was the first stage of alleged preparedness studies and mock operations, back in 2001. Operation Dark Winter was the code name for a senior-level bio-terrorist attack simulation conducted on June 22–23, 2001. It was designed to carry out a mock version of a covert and widespread smallpox attack on the United States. Tara O'Toole and Thomas Inglesby of the Johns Hopkins Center for Civilian Bio-defense Strategies and the Center for Strategic and International Studies. Randy Larsen and Mark DeMier of Analytic Services were the principal designers, authors, and controllers of the Dark Winter project. O'Toole is currently a senior fellow and executive vice president at In-Q-Tel, which is CIA, of which the Q part may well be indicative. Inglesby like Fauci is involved in the HIV studies. Dark Winter's simulated scenario involved an initial localized smallpox attack on Oklahoma City, Oklahoma, with additional smallpox attack cases in Georgia and Pennsylvania. The simulation was then designed to spiral out of control. Just like the modern day Covid experiment, that has spiraled out control of not just the people, but the psychopaths who formulated it, and is creating ouroborus programs for themselves and they launch from one failed program to another. This would create a contingency in which the National Security Council struggles to determine, both the origin of the attack, as well as deal with containing the spreading virus. By not being able to keep pace with the disease's rate of spread, a new catastrophic contingency emerges in which massive civilian casualties, which would overwhelm America's emergency response capabilities. The disastrous contingencies that would result in the massive loss of civilian life were used to exploit, the weaknesses of the U.S. health care infrastructure and its inability to handle such a threat. The contingencies were also meant to address the widespread panic that would emerge, and which would result in mass social breakdown and mob violence. Exploits would also include the many difficulties that the media would face, when providing American citizens with the necessary information regarding safety procedures. Or they could just do what they always do, make shit up and read scripts from the agencies, the most prevalent of which is the CIA. We can carry on giving them the bird, as they have been mocking us our whole lives. Dark Winter was written in 2001, just before the dark day for America, is it a cohencidence the previous dark day in America was referenced in that alleged simulation, Oklahoma? What a cohencidence it was the same year of the dark autumn day in New York, which just happened to coincide with a ritual sacrifice day, and the emergency code number 9-1-1. It was a humanity emergency code day, and the evil that exists in New York dropped three buildings, two of which were towers and the power of 3, and replace the twins (Isis or Jachin and Boaz) with one, called the One World Trade Center, does the One World ring any bells? But three is also the numeric code for Saturn. They also called it the Freedom tower, and people rejoiced as they missed the code within the words, free dom equals free domain. The second simulation was called Atlantic storm in 2005, again it involved Johns Hopkins, and lead representatives of Canada, Germany, France, Italy, Holland, Poland, Sweden, UK, WHO and the US version Madeline Albright who was born to. The predicted outcome was determined with this assessment of that program, and it said this. The initial problem facing the participants was whether to use a ring vaccination strategy over a mass vaccination one, in order to deal with the small number of those thought to be infected with the smallpox virus. Ring vaccination is a strategy to inhibit the spread of a disease by vaccinating those who are most likely to be infected. This strategy vaccinates the contacts of confirmed patients, and people who are in close contact with those contacts. This is the same policy they used for the Covid simulation that went live. While ring vaccination is recommended for initial control over an outbreak, states may quickly choose to switch to mass vaccination if it is unsuccessful. In addition, the participants for countries with no infected persons faced pressures to share available vaccine resources, with countries currently experiencing outbreaks. As more countries began to experience outbreaks, domestic pressures forced participants to withhold the sharing of vaccines, in order to preserve their supply for their own citizens. Does all that sound familiar today? it should do. Other strategies, such as vaccine dilution, became necessary as the amount of those suspected to be infected grew. Participants also considered the viability of closing borders, to prevent the further spread of the outbreak to their own countries. Certain dire measures, such as the use of military quarantines, were considered as participants also had the obligation to ensure public safety in civilian populations. Maybe they warned us of the Atlantic storm a year before, with the movie the Day after tomorrow? That event would end the Manhattan problem and sink it to the depths of the ocean. Is the potential LaPalma landslide, that event? Clade X was the third exercise done in 2018 and also involved Johns Hopkins, and it revealed this. Clade X was a 2018 pandemic modeling exercise by Johns Hopkins University's Center for Health Security, named after the hypothetical infective agent. In the simulation, the hypothetical pandemic resulted in 900 million simulated deaths. Perhaps the term Clade meaning brings us a clue? a group of animals or plants consisting of a shared ancestor and everything that comes from it. Around the same time the entity known as Q and Trump kept saying the calm before the storm, it is coming you will see. Is that the Atlantic storm after the Dark Winter?

So what is a digital twin? Here is a short piece with added information from Teal Swan on digital twins, and no I am not endorsing her, but this piece is relevant. A Digital Twin is an exact replica or Clone, used to represent that individual's Personality Matrix

projected into another dimensional plane, usually the virtual representation is placed in a location within the Phantom Matrix. The Digital Twin is used by the NAA as a Mind Control weapon which attempts to overlay into the Lightbody, it is designed to subvert the organic consciousness of that individual. The NAA was a major radio facility located at 701 Courthouse Road in Arlington, Virginia. It was operated by the U.S. Navy from 1913 until 1941. The station was originally constructed as the Navy's first high-powered transmitter for communicating with its bases across the U.S. and the Caribbean. Like everything else that comes out of the Military, it is then weaponised against we the people. Many times, seemingly to be an evil twin, but this is a digital twin of that individuals' identity that is used as, a Holographic Insert to abuse the inner spiritual Christos within organic human beings. Additionally, the Red Cube AI technology is designed to be a genetic code crasher for anti-hierogamic union, or to create interference through an Alien Love Bite scenario. That engages that person in heavy emotional dramas via Victim-Victimizer archetypes and mistaken identity, by keeping the inner and outer gender principles split apart. This next piece is all about an interview done back in 1969, and is another of their think tank plans for the world that has devious methods. The interview was recalled by a person involved in that meeting or was it a plan, like Operation Lockstep and many others of these types of simulated thinking, but turns out prophetically real, at the peoples expense. It lays it all out in category form of how they planned to change our world for their own ends and greed. Lets see how many categories have actually unfolded. Dr. Day gave a lecture to the Pittsburgh Pediatric Society in 1969 where he let the hushed cat out of the bag. His lecture was taped and those tapes were finally transcribed. Basically, the agenda is to corrupt morality, encourage unrestricted sense gratification, and eliminate or ridicule religiosity, spirituality, common sense, and the concept of right or wrong. As I have a copy of those tape transcriptions, I will endeavor to share them with you so you can see the realities that have come, and will continue to come our way. It will be up to each and every one of us to pick a side, there is no middle road. How we conduct ourselves and what we impart to our children and loved ones will determine our integrity

one way or another. So, in this article, I will simply list the agendas to be followed in forthcoming articles with more elaboration. Suffice it to say that the powers to be want our world to go to hell in a hand basket so they can dictate activity, consciousness, and work toward ultimate control over each and every one of us.

The introduction to Dr. Day's lecture began with: Is there a power, a force or a group of men organizing and redirecting change? Everything is in place and nobody can stop us now. People will have to get use to change. The real and stated goals are as follows: Population control, permission to have babies, redirecting the purpose of sex, sex without reproduction and reproduction without sex. Contraception universally available to all, sex education as a tool of world government, tax funded abortion as population control. Encouraging homosexuality as a means of population control, families to be diminished in terms of importance, Euthanasia and the demise pill. Limiting access to affordable medical care makes eliminating the elderly easier, planning the control over medicine, elimination of private doctors. New difficult to diagnose and untreatable diseases, suppressing cancer cures as a means of population control, inducing heart attacks as a form of assassination. Education as a tool for accelerating the onset of puberty and evolution, blending all religions, the old religions will have to go. Changing the Bible through revisions of key words, the churches will help us. Restructuring education as a tool of indoctrination, more time in schools, but not learning anything, controlling who has access to information. Schools as the hub of the community, some books would just disappear from the libraries, changing laws. Encouraging drug abuse to create a jungle atmosphere, promoting alcohol abuse, restrictions on travel, the need for more jails and using hospitals as jails. No more security, crime used to manage society, curtailment of American industrial pre-eminence. Shifting populations and economies, tearing social roots, sports as a tool of social change, sex and violence inculcated through entertainment. Travel restrictions and implanted I.D.s, food control cue Monsanto, weather control via the Haarp project. Know how people respond and make them do what you want, falsified scientific research, terrorism, financial control. Surveillance, implants, and televisions that watch you. Home ownership a thing of the past, the arrival of the totalitarian global system or so they thought.

This is what Dr. Dunegan said, about a year ago or so I wrote an article about the New World's Order implementation and furtherance of the eugenics plan. This plan was let out of the closet, so to speak, by Dr. Richard Day who was a Professor of Pediatrics at Mount Sinai Medical School in New York. He also served as Medical Director of Planned Parenthood Federation of America, and was a profound atheist and an insider of the New World Order. During the meeting in Pittsburgh, Dr Day touched on the subject of cancer, and what he relayed to his audience shocked then, and many readers may find his revelations shocking also. Dr Day said, we can cure almost every cancer right now in 1969. Information is on file in the Rockefeller Institute, if it's ever decided that it should

be released. Dr. Dunegan recalls what Dr Day said very clearly, because he found it unbelievable as did the other attendees, that an institute who could effectively treat one of the most destructive diseases known to humanity, would withhold that knowledge. We have revealed extensively how these Institutes, Universities and think tanks how they not only withhold knowledge, but collectively plan and scheme the most heinous agendas on we the people. Dr. Day continued, but consider if people stop dying of cancer, how rapidly we would become overpopulated. You may as well die of cancer as something else. The world is only over populated by psychopaths. He then went on to explain that treatment would be geared more towards easing some of the symptoms, and making the sufferer comfortable rather than a cure. Which is exactly how most medications work, ease the symptoms and not cure the disease, as that way they make more shekels. It is the policy of every hospital, clinic or doctors, because they are all part of the system, knowingly or not, and all are in it for the shekels. In the UK doctors are getting \$15 per jab and an extra \$12 if it is a child, so don't tell me those participating in that are not complicit in it. Although the Rockefeller Institute have taken precautions to hide the information within the institute, Dr Day said that one day it may come to light, if independent researchers get close to developing the same technology and cure. But for the time being letting people die of cancer was a good thing, because it would slow down the problem of overpopulation. As with the attendees at the meeting, any normal thinking person may disbelieve that an organization which purports to research cures and new medical treatments, would withhold this vital information. But as we have seen many times before, where there is power and money anything can happen, especially when the supporters of eugenics are involved. Rockerfeller's bank is Chase, and they were involved in sending money to the Jewish Elites in Germany to fund World War 2, that was said by Dr. Dunegan and I agree with that statement. In 1973, Rockefeller founded the Trilateral Commission together with Zbigniew Brzezinski, who was also born to. As an independent body bringing prominent political and business figures together, with the publicized aim of promoting political and economic dialogue across the world, at a time of considerable friction among governments. The Commission is divided into three regional divisions, European, North American, and Asia Pacific. The Commission has received considerable criticism since its inception. Most notably claims that the Commission is pivotal, in league with other organizations in promoting and plotting to instill a world government system, as part of a global push by influential organizations, such as major world financiers towards a New World Order ruled by a secret elite. The Trilateral Commission also has very close ties with the Council on Foreign Relations, one of the oldest and most influential think tanks in the USA. It is said that the CFR runs the American Government, in particular it's ridiculous foreign policy, which is a not a policy for America, but the Jewish EL-ites who operate inside every New World based organization. There is also some crossover between the memberships of the two organizations. The Council on Foreign Relations' David Rockefeller Studies Program' is the hub of the think tank, and employs 70 full-time scholars and practitioners who use their expertise and knowledge, in covering issues affecting today's global agenda. As with the Trilateral Commission, the Council on Foreign Relations has been criticized for similar reasons, supporting globalism. Dr. Day went into prophetic mode with the next statement. When talking about changes in medical care, Dr Day said, there would be new diseases to appear which had not ever been seen before. They would be very difficult to diagnose and be untreatable at least for a long time. We have seen this with several diseases that have plagued humanity. Part of the plan for population control, according to Dr Day, was to encourage the old who no longer had a use within society to take their own lives. Euthanasia has been a controversial subject, with campaign groups advocating the right to take one's life, and other groups claiming that it is immoral. The recent piece we did on the Sarco machine certainly brings that plan into being, does it not? Next is a series of categories of how they planned to bring society down and implement their New World Order, remember this was 1969, and so 52 years ago, and it proves how long they plan ahead. The first section is the Demise of the family: Dr Day revealed plans which would create less security and unity between humans, through the planned demise of the concept of family. Between humans? are they distinguishing a difference in species? why do all these types of documents speak of us in terms of humans? Maybe as we have stated all along, these planning psychopaths are not our type of human, we have labeled them the Hebrew Annunaki and all the supporting evidence validates that more and more. The traditional family structure of a married mother and father, living together with children would become less important in the structure of society. Having large families would no longer be the objective of the New World Order. Having large families would no longer be the objective of the family unit, and in some instances the number of children that could be born to a couple or mother would be limited to two at most. Unmarried couples living together would become more commonplace, to such an extent that society would accept it as the norm. Perhaps the new norm, which they revealed that meme in the past 18 months. The limitation of family sizes has been legislated for in some countries, and other have placed or proposed restriction on social benefits, for more than a designated number of children. China has placed restrictions on the number of children which may be born to a couple since 1979. In China, urban couples are restricted to one child, with exceptions in other circumstances. Additional children are permitted in the case of twins or other multiples, where the couple lives in a rural area, couples where the mother and father were born as the only child, and ethnic minorities. The one child policy has been called for by several other countries. This led to an imbalance in nature and nature in a way corrected it. If females were the first born in China since that policy, a large number of them were killed because of Chinese tradition of keeping the name of the family going. So an imbalance occurred and in some way nature and or coercion saw the rise in transsexuals in Asia, which can be attributed to that policy. Now China has reversed their policy, for their own attempt to dominate the world by sheer numbers, if you are talking

of over population in one country, China and India both have a large population problem. China has performed an estimated 336 million abortions over the past four decades as part of its enforced family planning policy, according to figures recently released by the country's health ministry. It has also performed 196 million sterilizations and has inserted 403 million intrauterine devices, which is a normal birth control procedure in the west, but one that local officials often force on women in China. China has a history of female infanticide spanning 2,000 years. When Christian missionaries arrived in China in the late sixteenth century, they witnessed newborns being thrown into rivers or onto rubbish piles. In the seventeenth century Matteo Ricci documented that the practice occurred in several of China's provinces, and said that the primary reason for the practice was poverty. The practice continued into the 19th century and declined precipitously during the Communist era, but has reemerged as an issue since the introduction of the one-child policy in the early 1980s. It is not the only atrocity recorded in China as we recently covered the sculpture in Baodingshan where the horse headed chimeras were killing people, then grinding them up to feed the serpent god. Perhaps that is the reasoning behind the Rus building the Great Wall between the two countries? and no it was not built by the Chinese at all, the guard towers are facing the wrong way for it to be a Chinese built wall. In 2009, the Canadian government called for world leaders to consider a world-wide one child policy. In 2012, in Nigeria, President Goodluck Jonathan said that too many people were having children, and said that consideration may be given to legislation and policies aimed at reducing the birth-rate. In the UK, the Optimum Population Trust called for a two child policy to be introduced, to curb what they described as an environmental liability as the birth-rate rose significantly in 2007. That's a new name to call us, and environmental liability, deary me, the only people who have destroyed the environment with their greed based companies, are the same EL-ites wanting to blame us and fix the world for themselves, and they ask us to pay for it, the answer to that is go fuck yourselves. The UK government attempted to introduce restrictions on benefit payments that parents would receive. Under the proposed welfare bill, the government would restrict the UK's child benefit to the first two children. At the time of writing there had been no conclusion to the proposals. In 2013, the UK government introduced legislation to allow three person IVF, and to allow the registration of three parents for children resulting from successful treatment.

The next category is, Divorce would be made easier and become more prevalent: Most modern cultures in the 21st Century have some form of process for divorce. The concept of couples staying together for their natural lives has become less of an expectation of society, especially in Western society, where divorce has become much easier and accepted, than it was up until the 1950s and 1960s. In the UK, divorce was frowned upon, and divorcees faced stigma and prejudice from society especially if they had children. Many couples stayed together even though their relationship had broken down. The big change in the UK came in 1969 with the introduction of the Divorce Reform Act, which

allowed couples to divorce by mutual agreement after they had been separated for two years, or after five years if only one of them wanted a divorce. What a cohencidence that, that bill was introduced the same year Dr. Day did this speech, such remarkable cohencidences. Throughout the US and Europe, getting married became easier, which also resulted in the divorce rate soaring with the reason for divorce often cited as behavior, the official explanation for divorces based on falling out of love or growing apart. According to data from the Office of National Statistics, behavior was the reason in 27% of divorces in the UK, and most divorces 74%, occur between 11 and 20 years of marriage. According to the US Census Bureau, 41% of first marriages end in divorce, 60% of second marriages, and an astonishing 73% of third marriages. That's because the system makes you pay for the previous marriage, effectively then the divorce is paying for two families, that in my opinion is not right and has to stop. The age range with the highest divorce rate is between 20 and 24 years of age.

The next category is, it would become common for people not to marry and live together: Cohabitation has been on the increase in recent times, with more couples choosing to live together than get married. In the UK, the Office of National Statistics estimate that in 2012 5.9 million people cohabit, a significant increase on the 1996 figure of 2.9 million. Similar statistics from the CDC in the US show a significant increase in the number of cohabiting couples. Cohabiting couples who have children are less likely to consider getting married than in the 1960s and 1970s.

Next category is make it harder for families to stay together: The bonds between family members have slowly been eroded over the last 40 to 50 years in many Western societies. The traditional role of family members looking after each other, especially in times of illness, old age, or severe hardship has been diluted, as relatives move further away from the family hub to study, work, or establish families of their own with partners from other areas and distant countries. Although it is said that the world is a smaller place than it used to be, with a more efficient and far reaching transport infrastructure and more communications technology, the physical presence of family members is the core of kinship and maintaining the close bonds necessary for the family unit. Since the mid-1990s, there has been a 50% increase in the number of people aged between 45 and 65 who live alone in the UK. Figures produced by the National Office of Statistics show that in the region of 2.5 million people have no spouse, children, or partner living with them in their home. In the US, it is estimated that the number of children in broken homes in 1950 was in the region of 12%, by 2000 this figure had jumped to 60%. These figures do not take into account the number of broken families, who still live together because of economic pressures, and which create a toxic environment for children. According to the charity Relate, many couples are forced to stay together, because they are unable to afford the cost of divorce or accommodation. The family unit becomes dysfunctional and the parents and children will split as soon as they are able.

Next is category is more men transferred to other locations for work: For some, the prime reason for moving away from the traditional family unit is economic. With the closure of traditional employers in areas where families have settled for generations, family members are forced to move where they are able to find employment. This may entail a move to a new city, or even a new country. When a traditional local employer such as a factory is forced to close, the choice for many families is to endure a life of poverty, or for family members to seek employment elsewhere, and this is often the male partner. The evidence of that is in Detroit, the car factories closed down and so did the city, that was left to rot and decay. In recent times we have seen the economy of some European nations decline to such an extent, that large numbers of the population are unemployed. In 2013, Chancellor Angela Merkel of Germany said that the unemployed of the Eurozone should move to find work. Having implemented extreme restrictions on countries such as Spain and Greece, the economy has effectively crashed and created extremely high unemployment. The globalization of the workforce will mean that more families and communities become fragmented, and will find it difficult to maintain traditional bonds when faced with poverty and hardship. Creeping globalization in many areas of society will result in the near destruction of the traditional family unit.

Next category is make marriage less stable and less desirable to have babies: Couples and families facing the prospect of poverty and having to move to other areas or countries, are not able to establish themselves on solid foundations. With the ever present prospect of having to move each time there is a change in the work market or economy, it makes little sense to take on more responsibility than necessary by having children. In such an unstable situation, it may happen that the partnership may have to end as each partner seeks employment in different locations from each other.

To make that possible, transport would be easier and less expensive for a while: To encourage a mobile workforce, they have to be able to move around the desired zone easily. This means they have to have access to readily available and relatively cheap transport. Car ownership has increased year on year as motor vehicles have become cheaper to produce and own pro rata. In the US in 1960, there were around 410 cars owned per thousand population. In 2000 there were around 828 cars owned per thousand population, and the trend has increased by around 12% per year since. In the UK, car ownership became cheaper and within the range of the average income family. There were 137 cars per 1000 population in 1960, and 515 per thousand in 2002. Although the cost of car ownership remains within the means of most average income families in the US and the UK, the cost of motoring has risen as the cost of fuel has increased. Air travel has become cheaper, with companies such as Easyjet and Ryanair offering highly discounted flights to destinations worldwide. As with motoring, the cost of fuel continues to rise which will affect how sustainable cheap air travel will be. Where once the concept

of family was seen as the hub of the community, and families tended to stay within a fairly small area. As travel has become easier and as the family unit has become less stable, so people have been forced into a position of becoming economic nomads. This further results in the bonds between family members and communities becoming weaker, some to the point of no longer existing.

The next category revealed as a plan to destroy families and also reduces the birth rate is, the promotion of an agenda surrounding Homosexuality: Dr. Day talked about homosexuality, and according to Dr. Dunegan, Dr. Day said people will be given permission to be homosexual. How benevolent of them to consider it, who made them god? It is curious that this would be included in the globalist's plans for the future, because homosexuality has as far as we know from scholars, been part of human life since we emerged on this planet. But it has been used as a divide and conquer tactic by the church, first to turn people against them, then reverse it into a shame and guilt program, and then elevate homosexuals higher than the traditional heterosexual lifestyle. It is not until we look into a little bit of history and the development of openness concerning homosexuality, that we begin to see why this was specifically mentioned. The term homosexual is a fairly recent addition to the English language, only appearing in the 19th century, although there have been references to same-sex relationships in various languages throughout history. It was the realm of the fake gods, Pharaoh's, Royalty and EL-ites and was kept hidden within their circles, unless power or control was needed, then they used incest as a means to attain power. The very fact the bible references incest 54 times, tells you the bible is all about the aforementioned entities. The earliest reliable records of homosexual activities are from ancient Greece, where homosexuality was practiced and generally accepted, sometimes celebrated by both men and women. Not all of ancient Greece approved, there were areas such as Iona that had restrictions on samesex interactions. There has been humans in every major period of history, and in every major society, who have engaged in homosexual activity whether accepted or not. In some societies, homosexual activities were used in rituals, in others homosexuality was practiced for pleasure. It is used in rituals as the anal cavity can let in entities and host possession. I don't think many people care about the practice used for private pleasure, but many still have an issue with a lifestyle choice, largely due to religion, who coincidentally wrote the bible themselves. Since the time of the Greeks, many societies have imposed severe penalties for same-sex relationships. In England, anal sex between any gender was made illegal by the Buggery Act of 1553 during the reign of Henry VIII, with the penalty being death by hanging. The offence of sodomy had been dealt with through ecclesiastical courts prior to the Act. The Act went through several alterations until it was finally repealed in 1829, and was replaced by a section 15 of the Offences against the Person Act in 1828. Was that act against the so called Sodomites, that were connected heavily to the Hebrew Annunaki group? In our more modern history, homosexuality started to gain interest among scholars and scientists in the 19th century.

The writings of Sigmund Freud with his theories on sexual identity started to become widely read and accepted. Magnus Hirschfield established the Institute for Sexual Science in Berlin in 1919, which continued to amass material relating to homosexuality until 1933. Freud and Hirschfield it should be noted where both Jewish. Although dissolved in 1933, the material from the institute has been part of various universities in Germany since. One of the most famous cases in the UK is the trial of Oscar Wilde in 1895, when he was convicted of gross indecency for homosexual acts which fell short of sodomy, and sentenced to two years in prison. Homosexuality in England was to remain illegal until 1967, when the Sexual Offences Act permitted homosexual acts in private by men over 21 years of age. There has never been legislation in the UK concerning lesbianism, with laws specifically referring to interactions between males. Laws concerning homosexuality in the United States have been made state by state, and the remaining sodomy laws were invalidated in 2003 by the Supreme Court ruling in the Lawrence v. Texas case, with the exception being in the US armed forces. Although homosexuality specifically sodomy is no longer illegal, military personnel are still governed by the Uniform Code of Military Justice in which an article states A: Any person subject to this chapter who engages in unnatural carnal copulation with another person of the same or opposite sex, or with an animal is guilty of sodomy. Penetration, however slight, is sufficient to complete the offense. B: Any person found guilty of sodomy shall be punished as a court-martial may direct. But perhaps Dr Day was not referring to the legislative framework in particular, when he said people will be given permission to be homosexual, it is more likely that he was referring to a shift in social attitudes to homosexuality. Which meant that the unaware homosexuals thought society finally recognized and cared about them, when in reality land they, transgender, women via the Feminist movement, and blacks were all used as a tool for divide and conquer. In recent times we have seen civil partnerships and gay marriages discussed and approved of by many institutions, that had previously expressed that homosexual union was wrong and immoral. Societies in most developed countries have accepted homosexuality and transgenderism as part of normal, everyday life. Media personalities have come out as being gay, and being gay is no longer a barrier to engaging in society, although there are still some exceptions and prejudice still exists. Media personalities should not be the marker for anyone in a lifestyle choice, most of them are puppets who will do and say anything for fake publicity. But, people are no longer afraid to be gay and openly display their sexuality to the rest of their society.

The next category is sex and reproduction would be separated: You would have sex without reproduction, and then technology was, reproduction without sex. This would be done in the laboratory, was the next subject in Dr Day's presentation to the group. The first successful scientific experiment in fertility was conducted in 1884 by Philadelphia physician William Pancoast. Pancoast treated a couple's infertility by injecting sperm from a medical student into a woman while she was anesthetised, and she gave birth to a

boy nine months later. This was the first recorded incident of artificial insemination, although it didn't appear in a medical journal, the Medical World Journal, until 1909. I have said many times, technology and experimentation is not the future but way in the past, that was not done in 1984 as many would state if asked the question, but 1884. But there was earlier attempts in this going back even further. The first successful experiment with artificial insemination in animals was performed by Italian physiologist Lazzaro Spallanzani, who in 1780, while investigating animal reproduction, developed a technique for artificial insemination in dogs. Spallanzani was actually a Cat holic priest! so the alleged god loving profession was actually playing god themselves, and yet no one questioned that? Several other experiments took place in the early 1900s with limited success. In 1944, a lab technician, Miriam Menkin, became the first person to fertilize a human egg outside of the human body. After working on external fertilization of eggs for six years, her first success came in February 1944. She went on to repeat this success three times between February and April 1944. Although Menkin has been successful in fertilizing eggs outside of the body, her experimentation never reached the stage of implanting them back into the donor. If you believe that you will believe anything. Menkin born in Latvia, moved to New York, worked at Harvard and born to Jewish parents, an all too familiar story. The world's first test-tube baby according to popular theory was Louise Brown, who was born in 1978. Through the research of Professor Sir Robert Edwards with his colleague Patrick Steptoe, IVF treatment became available to millions worldwide, and has to date resulted in over five million babies being born. The common sense question is, if they have been saying for over a 100 years about over population, why did they allow this treatment to produce extra children? Does that make sense? no, it's a program then. The great question is, who or what was involved in producing the offspring? ponder deeply on that. They were using the science from these experiments for other purposes, and why it was allowed and continued. This is how and why they developed the genetics, that is all so prevalent today with the Covid nonsense. In 2013, the first true test-tube baby became a real possibility, when scientists at Oregon Health and Science University, extracted stem cells from human embryos created in a laboratory. Although human embryos had been created before, they had not had healthy stem cells extracted from them. With the healthy stem cells being created scientists have taken a significant step to creating cloned humans. Cloned humans? now you know one of the reasons for the earlier experiments then. Why would anyone need cloned humans? unless they were being used for negative purposes, otherwise it has zero value. The developments caused concern among campaign groups who questioned the need for the research, when simpler ways of creating stem cells for biological research already existed. Campaign groups talking common sense there, that was their problem, their research will never make sense, because at the heart of it is weaponizing it against the public, or using it for heinous agendas. The team at Oregon Health and Science University were also criticized by other scientists in the field, for publishing the controversial research data claiming that the team were irresponsible, and others claiming there should be an international ban on human cloning. Cloning is for clowning, pure and simple.

The next category for their plans is Compulsory Sterilization: In December 2012, scientists at Institut de Veille Sanitaire, St Maurice, France, discovered that the sperm count in human males across the world was in sharp decline. The research was conducted over a seventeen year period showed that the sperm count had reduced by a third, and the scientist's prediction was that the reduction in sperm count was set to continue. Reasons for the decline of the male sperm count were not found. It was found, by adding chemicals to food, water and products that caused a direct reduction in the male sperm count. Water fluorination has been a subject of concern. Scientific claims that fluoride in drinking water can cause infertility have been proven in several studies. However, the World Health Organization considers the ratio of 1.5mg/L of fluoride in drinking water, to be a safe dose with limited adverse effects. Well the WHO have proven over the last two years to talk utter shit, and we take their advice with a ton of salt. It may be disturbing that there are any effects at all, when we consider the millions of people who are exposed to fluorinated water, with every person being different in age, health and so on. The reason governments give for putting fluoride in the water supply is to reduce tooth decay. That joke is as bad as the two planes brought down 3 buildings conspiracy theory. In the USA, where around 65% of the population are dosed through fluorination of the water supply, the worst tooth decay occurs in poor areas that have been fluoridated for decades. This could be because for fluoride to be most effective it is believed that it should be applied directly to teeth, and not through the water supply. When fluorination was stopped in areas of Finland, East Germany, Cuba and Canada, tooth decay apparently decreased. Well I never and no shit Sherlock for that confirm. Fluoride is a toxic chemical, and has been shown to cause genetic damage at low doses, and has been linked to cot death, Alzheimer's and eczema. Fluoride also causes collagen to disintegrate, which is an essential part of the structure of bone, muscle and skin. Fluoride has also been linked to underactive thyroid glands, and was once prescribed to depress thyroid activity. Many countries especially in Europe, have banned the use of fluoride in water supplies due to the health risks involved. Mosaic a major fertilizer producer, is a major supplier of fluorination products for the worldwide water fluorination market. Mosaic was formed by Cargill Inc. and IMC Global Inc. IMC Global Inc. is owned by Cargill Inc.. You may remember that in an earlier show we touched on Cargill's involvement with Monsanto and the GMO industry. Inspite and despite all their plans, schemes and plots, remember we are all still here and fighting and alive and kicking. ALIVE & **KICKING**

As you can see this level of human experimentation and planning has been ongoing for some time, now we have two relatively unknown human experiments to be covered. We have covered a few of the heinous medical experimentation done under the banner of the US Military, and quite why Americans put their children in that organization at this point, staggers belief. It is beyond stupid, and whilst it contains elements of the mind control program, the sheer volume of American lives lost in the past 50 years alone, should have rendered far more questioning of it, and indeed a blanket boycott of that entity. It is sheer madness at this point of how family hand over their offspring for an organization, that not only mistreats their own people, but sacrifices them and others around the world for their Hebrew Annunaki paymasters. Here are some other examples if you don't your beloved Military is not involved with crimes against Americans and humanity. The first is Operation Whitecoat. Operation Whitecoat was a bio-defense medical research program carried out by the United States Army at Fort Detrick, Maryland between 1954 and 1973. Fort Detrick was exposed in an earlier show of being involved with not only bio-warfare, but also potentially the origin of the Covid samples. It should be noted of how far back human experimentation and fake medical research done not to help people, but to use people as guinea pigs for their bio warfare programs. The fact this was being done 50 to 70 years ago, and take note of the advancements since, all people should be alarmed, not just alt media followers. The program pursued medical research using volunteer enlisted personnel who were eventually nicknamed Whitecoats. Presumably because they thought the volunteers would need a white coat straight jacket, all because people believe they are doing it for their country. These volunteers, all conscientious objectors, including many members of the Seventh-day Adventist Church, were informed of the purpose and goals of each project, before providing consent to participate in any project. Since when have the Military ever told the truth? The stated purpose of the research was to defend troops and civilians against bio-logical weapons, and it was believed that the Soviet Union was engaged in similar activities. Ah the nasty Russians line again, that has had Americans in fear for the past 60 odd years, guess what? they are not coming to get you. If they were? do you think for one second they would announce it? think different. Although the program was discontinued in 1973, human use research for bio-defense purposes is still conducted at the U.S. Army Medical Research Institute of Infectious Diseases at Fort Detrick, and at other government and civilian research institutes. Discontinued my ass, just like the MK Ultra was discontinued, just like Project Mockingbird was discontinued, all as likely as the MSM telling the truth. However, these post-Whitecoat studies are often human use challenge studies, in which a person is inoculated with a known pathogen, to determine how effective an investigational treatment will be. Here is a novel idea, lets use the Generals and other so called high level Military people for experiments, seen as they all think it is of value. Over the course of the 19-year program, more than 2,300 U.S. Army soldiers, many of whom were trained medics, contributed to the Whitecoat experiments by allowing themselves to be infected with bacteria tularemia or Q fever, that were considered likely choices for a biological attack. Oh my Q fever, we had another bout of Q fever recently. While some volunteered immediately after basic training, for conscientious objectors at Ft. Sam Houston Texas before they began their medic training, the near certainty of being assigned as a combat medic in Vietnam,

helped some medics choose instead to remain in the United States with the Whitecoat program. So the coercion program was used there, go to war or be infected with unknown diseases, with unknown side effects. They say we have free will, but not with these people and the choices they give you, yet again the duality choice, and the lesser of the two evils, when the answer was neither. The goal of the program was to determine dose response for these agents. The volunteers were then treated with antibiotics to cure the infections. Some volunteers, under experimental protocol, were also given investigational vaccines for Q fever and tularemia, as well as for yellow fever, Rift Valley fever, hepatitis A, Yersinia pestis (plague), and Venezuelan equine encephalitis and other diseases. There they go again with their experimental vaccines. Some soldiers were given two weeks of leave in exchange for being used as a test subject. The old two weekks program rears it's head again. These experiments took place at Fort Detrick which is a U.S. Army research installation in Frederick, Maryland. The volunteers were allowed to consult with outside sources, such as family and clergy members, before deciding to participate. The participants were required to sign consent forms, after discussing the risks and treatments with a medical officer. Of the soldiers who were approached about participating, 20% declined, just like the Milgram experiment of stupid people believing in and following authority. Many of the vaccines that protect against bio-warfare agents were first tested on humans in Operation Whitecoat. According to US Army Medical Research, the Whitecoat operation contributed to vaccines approved by the U.S. Food and Drug Administration for yellow fever and hepatitis, and investigational drugs for Q fever, Venezuelan equine encephalitis, Rift Valley fever, and tularemia. US Army Medical Research also states that Operation Whitecoat helped develop biological safety equipment, including hooded safety cabinets, decontamination procedures, fermentors, incubators, centrifuges, and particle sizers. The classic sleight of hand trick of, look we did good work, of course they developed the antidote, as these psychopaths developed all the diseases in the first place. Operation Whitecoat came to an end in 1973 when the draft for the U.S. military ended, and thus no more conscientious objectors were to be conscripted. A conscientious objector is an individual, who has claimed the right to refuse to perform military service on the grounds of freedom of thought, conscience, or religion. In some countries, conscientious objectors are assigned to an alternative civilian service, as a substitute for conscription or military service. The choice was become a guinea pig for the psychopaths, or play the soul dier sacrifice game. The United States Government Accountability Office issued a report on September 28, 1994, which stated that between 1940 and 1974, the United States Department of Defense and other national security agencies, studied hundreds of thousands of human subjects in tests and experiments involving hazardous substances. A quotation from the study, many experiments that tested various biological agents on human subjects, referred to as Operation Whitecoat, were carried out at Fort Detrick, Maryland, in the 1950s. The human subjects originally consisted of volunteer enlisted men. However, after the enlisted men staged a sitdown strike to obtain more information about the dangers of the

biological tests, the Seventh-day Adventists who were conscientious objectors were recruited for the studies. Who are these Seventh day Adventists? The Seventh-day Adventist Church is a Protestant Christian denomination which is distinguished by its observance of Saturday, the seventh day of the week in Christian and Jewish calendars, as the Sabbath, and its emphasis on the imminent Second Coming advent of Jesus Christ. They'll have a long wait. Distinctive post-tribulation teachings include the unconscious state of the dead and the doctrine of an investigative judgment. The unconscious state of the dead? what about the living? these religious people are bizarre. The church is known for its emphasis on diet and health, including adhering to Kosher food laws, advocating vegetarianism, and its holistic understanding of the person. White Christians - check, Jewish involvement - check, Vegans - check, focus on the dead - check, do I need to say anymore? No Whitecoats died during the test period, but the Army has addresses for only 1000 of the 2300 people known to have volunteered, I guess the other 1300 where not important enough to find out, or the had the death card. Only about 500 (23%) of the Whitecoats have been surveyed, and the military chose not to fund blood tests, I wonder why? A handful of respondents claim to have lingering health effects, and at least one subject claims to have serious health problems as a result of the experiments. In 2005, an assessment of health status among the Project Whitecoat research volunteers was published. It reflected the self-reported, current health status among 358 exposed individuals and 164 unexposed control subjects, and found no conclusive evidence that receipt of investigational agents, was related to any adverse health outcomes. No conclusive evidence, only 23% used for analysis, what about the other 77%? It's Johns Hopkins math again. No differences in current overall health, current exercise levels, self-reported symptoms, and self-reported medical conditions were seen between the study groups. However, possible associations were seen between exposure to antibiotics or other biological agents and self-reported asthma, as well as between receipt of tularemia vaccine(s), and self-reported asthma plus increased frequency/severity of headaches. The size of the study population was judged to be insufficient to assert with confidence, that the statistical associations with asthma and headaches were real. Why because the other 77% died? The Seventh-day Adventist Church's relationship to government military activity has been supportive but noncombative. In 1936, the SDA Church established the Medical Cadet Corps Training Program. This allowed Adventists to remain noncombatant but positive toward the war effort. Sabbath observance remained a concern for the drafted members of the church. Adventist Conscientious Objector perspective differed from the National Interreligious Service Board for Conscientious Objectors. In 1967, Adventists withdrew from NISBCO because that organization opposed conscription. According to Bull and Lockhart, Operation Whitecoat, and the earlier established Medical Corps, enabled Adventists to participate in the armed services without violating their Sabbath principles. So, the church and the Military where working hand in hand on human experimentation, not a surprise to our listeners, but maybe outside of our show it is.

Project SHAD, an acronym for Shipboard Hazard and Defense, was part of a larger effort called Project 112, which was conducted during the 1960s. Project SHAD encompassed tests designed to identify U.S. warships' vulnerabilities to attacks, with chemical agents or biological warfare agents, and to develop procedures to respond to such attacks while maintaining a war-fighting capability. Project SHAD was part of a larger effort by the Department of Defense called Project 112. Project 112 was a chemical and biological weapons research, development, and testing project conducted by the United States Department of Defense and the CIA, handled by the Deseret Test Center and United States Army Chemical Materials Agency from 1962 to 1973. The project started under John F. Kennedy's administration, and was authorized by his Secretary of Defense Robert McNamara, as part of a total review of the US military. The name of the project refers to its number in the 150 review process. So, the American public's favorite President was involved in this also, why? because he was a Black Sun agent. Robert McNamara, lets look at him shall we. Graduated from UC Berkeley and Harvard Business School, worked for the Ford Company and then became Secretary of Defense. McNamara's salary as the CEO of Ford ran to some \$3 million dollars per year, while by contrast the position of the Defense Secretary paid only \$25,000 per year. Who gives up a \$3M a year job for \$25K? there had to be some skullduggery going on there. Given the financial sacrifices, McNamara was able to insist to Kennedy, that he have the right to appoint his officials and run the Pentagon his own way. The great question is, just who was backing him? He was the one who advocated sending more and more American soul diers to Vietnam. In October 1966, he launched Project 100,000, the lowering of army IQ standards which allowed 354,000 additional men to be recruited, despite criticism that they were not suited to working in high stress or dangerous environments. He was a member of the Phi Gamma Delta fraternity, was elected to Phi Beta Kappa in his sophomore year. McNamara grew increasingly skeptical of the efficacy of committing American troops to Vietnam. In 1968, he resigned as Secretary of Defense to become President of the World Bank. McNamara's hawkish stance on Vietnam was well known in Washington, and many in the press often referred to the war as McNamara's war, as he was the one in the cabinet always pressing for greater American involvement. Once again we ask just who was backing him? I think we all know who. The Shipboard Hazard and Defense Project (SHAD) was a series of tests conducted by the U.S. Department of Defense during the 1960s, to determine how well service members aboard military ships, could detect and respond to chemical and biological attacks. Dee Dodson Morris of the Army Chemical Corps who coordinated the ongoing investigation says, the SHAD tests were intended to show how vulnerable Navy ships were to chemical or biological warfare agents. Which in reality land equates to scaring the Government into giving more shekels, that's how they operate, all about the shekels and zero accountability of it, or the programs they were running. The objective was to learn how chemical or biological warfare agents would disperse throughout a ship, and to use that information to develop procedures to protect

crewmembers and decontaminate ships. DoD investigators note that over a hundred tests were planned, but the lack of test results may indicate that many tests were never actually executed. Of the 134 tests that were planned initially, but reportedly, only 46 tests were actually completed. Which means they went badly wrong or the Government never coughed up the shekels. Public Law 107-314 required the identification and release of not only Project 112 information to the United States Veterans Administration, but also that of any other projects or tests where a veteran might have been exposed to a chemical or biological warfare agent. It directed The Secretary of Defense, to work with veterans and veterans service organizations, to identify the other projects or tests conducted by the Department of Defense, that may have exposed members of the Armed Forces to chemical or biological agents. In 2000 the Department of Defense began the process of declassifying records about the project, and according to the U.S. Department of Veteran Affairs, approximately 6,000 U.S. Service members were believed to be involved in conducting the tests. So, 6000 guinea pigs were used in the tests, most of which were coerced or had no idea, maybe many of them were MK Ultra'd? In 2002, the Department of Defense began publishing a list of fact sheets for each of the tests. Although many of the roughly 5,500 veterans who took part were aware of the tests, some were involved without their knowledge. A bit of Johns Hopkins math again, when reporting some had no knowledge, suddenly 500 were knocked off the list. Certain issues surrounding the test program were not resolved by the passage of the law, and the Department of Defense was accused of continuing to withhold documents on Cold War chemical and biological weapons tests, that used unsuspecting veterans as human samplers, after reporting to Congress it had released all medically relevant information. Yet Congress which means is a group of baboons, fitting if you ask me, did nothing about it, but the sad fact is, even if they wished to do so, they would have been blocked under the National Security Act. A Government Accounting Office May 2004 report, Chemical and Biological Defense, stated the DOD needs to continue to collect and provide information on tests and potentially exposed personnel, indicates that almost all participants who were identified from Project 112. 94 percent were from ship-based tests of Project SHAD that comprised only about one-third of the total number of tests conducted. Jack Alderson, a retired Navy officer who commanded the Army tugboats told CBS News, that he believes the Pentagon used him and other service members to test weapons, and those tests including agents, vaccines, and decontamination products have led to serious medical problems including cancer. Secrecy agreements can now be ignored by veterans in order to pursue healthcare concerns within the Department of Veterans Affairs. The V.A. has offered screening programs for veterans, who believe they were involved in DoD sponsored tests during their service. The VA are in on it also, they play by their paymasters rules, not the Veterans. The Institute of Medicine of the National Academies has commissioned studies of Project SHAD participants. The first, Long-Term Health Effects of Participation in Project SHAD was released in 2007, and found no clear evidence that specific long-term health effects are associated with participation in Project SHAD. The second, Shipboard

Hazard and Defense II (SHAD II) by the Institute Of Medicine's Medical follow-up Agency (MFUA) began in 2012, and as of April 2014 is ongoing. MFUA are also involved with other studies of note, the advancing prion science, guidance for the National Prion Research Program (2004). Of Course prions are involved with the Covid Jab. Noise and Military Service, implications for hearing loss and tinnitus, which has been ongoing since WW2, and they took until 2004 again to review it? An assessment of the CDC Anthrax vaccine safety and efficacy research program (2003). The five series study, the mortality of Military participants in U.S. nuclear weapons tests (2000). Epidemiology in Military and Veteran populations, March 7, 1990 (1991). Health consequences of service during the Persian Gulf War, recommendations for research and information Systems (1996).
