THI-SHOW TRANSCRIPT 2022-02-08

FOR WHAT IT'S WORTH This is an extra show that focuses entirely on law, but what is law? have we defined it? or did it define us? This show will be beneficial if you connect with the truth, and let go of the lie and the fiction. It will be a very useful strategy for those who follow Law, legal, common or natural Law. Some people have labeled me anti common law, and yet negate the fact we despite having had very few guests on our THI shows, probably the most prominent is a common law group called National Liberty Alliance. We will endeavor to going deeper on what is and what is not law in this show, and people are free to make their own choices as to which path is best. Too many get involved in legalese, which means babble and so not understandable in anyone's terms, and anyone who has visited a court will hear the judges and lawyers spouting the most ridiculous babble ever and acting like they know law, when clearly they don't. My issue with it is, I don't believe you can go through their courts, unless you get lucky and some have and won. But the majority with or without knowledge will get crushed by the system, and thrown out of the court or into jail for what is declared contempt of court. But John Darash, Gerard and Karl Appel have done a lot to teach the common law to many people. For me the key is the teaching aspect, to change the real course, you will need masses of funds to fulfill the ideal behind common or natural law courts, officers and enforcement teams. Enforcement being the key word as that makes most things fall short. Our own Communal Gathering Law group have formed the bulk of this show, and I want to thank them for their research, input and efforts to date. They will be introduced soon, but first some background.

Unbeknown to most people we have not lived under real law for a long time, tonight will go some way to correcting that. To really understand law and it's implications, you have to go back in time and will find some very disturbing truths, tonight will reveal that to you. We have to go to the truth, however disturbing to counteract the lie. What is the lie will become very clear to you in the show. They have been using all kinds of informed and implied consent practices, spell magic, word magic, mistranslations and outright fraud. Latin is the language of legalese, and legalese means babble, which is incoherent baby speak and so, it is not meant to make sense. Any lawyer who says they understand law is talking, well babble. It is a law to protect the criminals who have ran our society in a real bad way, encouraging all kinds of illegal practices, heinous schemes and programs against we the people. They have created legal fictions of us, as the all capital letters program means you are A: a corporate entities and B: you are a dead person. Dead people cannot own anything, and so they by default think they own us, all of our property, equipment, land and businesses. They essentially patented everyone under their system of complete ownership of us all, and every asset of this planet. Your birth Certificate registering, means they own your child, registering your car, boat, yacht, bike, pet means they own that as well. Your Social Security or National Insurance number confirms that, they deemed us as cattle, and branded a number on us to use as they please.

There is a reason some call it Draconian law, as they have been the rulers of this planet for at least 16500 years. We have lived under Draconian law, which rolls in the Talmud and Torah both of which comes under the Hebrew Anunnaki program we have covered in many shows, particularly the From Russia with Love series. This fact that an off world group exists, never mind operates us disturbs many people. But just because the truth disturbs you, does not make it a lie. We have to accept they exist to begin to address the problem, of taking back the planet under human rule and law. Ignoring a problem never makes it go away. There was a Draconian Constitution at one point and was put out onto the internet for people to see, but GO ogle in their wisdom has removed it, but I retained a copy and this is what it said. The Draconian Constitution, or Draco's code, was a written law code created by Draco near the end of the 7th century BC. In response to the unjust interpretation and modification of oral law by Athenian aristocrats. Created in 620 BC by the Draco. What is the meaning of a Draco? A feathered snake, a flying reptile, a dragon. Draco, the Athenian lawgiver, law from the Old English word licgan meaning to lie. He, the aforesaid Draco, meaning dragon, gives lies (laws) to the Athenians. They say his laws are draconian.

So, who or what are the Draco? they are an off world reptile based group from the Alpha Draconis constellation whose flag is represented by the 6 pointed star. The 6 pointed star is not representative of Israel or Solomon, Solomon like "Moses", Noah, Melchizedek and other biblical characters were all their people, not ours. Israel the country has never existed, it existed as a House of Israel and connected to another of their control regions called Egypt. Pharaoh means the Great House. They have controlled us all by stealth, lack of knowledge, ignorance and our inability to face truth. Israel is another of their play on words and means the worship of Isis, Ra and El, who were also part of this Draco Alliance who represented themselves to us a gods. This is what is portrayed in the scripture books, these fake gods, countries, religions and law, all came from them. We see them by the symbols, their hieroglyphs, their religions of the worship of the cat,

which is Bastet the consort of Ra, and how they walk in their songs. WALK LIKE AN EGYPTIAN

Some of the most common mistakes of the Common Law groups is using the terms Magna Carta, and also assemblies. We will cover as to why neither should be used, before we go into the main body of the show, prepared by our own Communal Gathering Law group. This is a very brief summary of the truth about the Magna Carta. Keep in mind that a complete history of more than 6,000 years has been completely wiped out. It was replaced with a combination of propaganda and false claims thereby cementing and ensuring the status quo, of a narrow elite of families against traditional nobles and the rights of the people. Keep in mind all Statutes that existed in England prior to the 16th Century, were most likely destroyed in the Fire of London 1666. The English language as we know it today was created by the Jesuit College of English in the 16th Century; hence, any Statutes, such as the Magna Carta, that are claimed to be originals that were written prior to the 16th Century are dubious at best. It is highly probable that these claims are fraudulent, and documents were forged at a later date to support the current power structures.

The true meaning of a Magna Carta or Great Charter, carta can also mean cartel, is a Master Tenancy Agreement in the granting of certain rights by the Roman Vatican Cult issued, at the commencement of a reign as the basis of all secular law, to which a King would then add their ordinances. Basically a Carta or Charter is a deed granting some corporate franchise, conferring some privilege or exemption according to some Sovereign power and authority, itself granted from a higher Ecclesiastical authority. Denizen also means you are part of a franchise. Plus the fact they have inserted privileges instead of human rights ascribed to us all. There were multiple Magna Carta's issued across Europe, basically setting the terms of peace and conditions between a monarch of a Noble House, granting perpetual rule under patent from the Roman Vatican Cult and their lesser nobles.

In the case of the noble houses of England, including the House of Plantagenet followed by the House of Lancaster, House of York and the House of Tudor, the tradition of establishing a Magna Carta between the lesser noble classes and the King at the commencement of their reign, was continued from 1216 until Henry VIII (1509-1547) of the House of Tudor. Therefore, there is not one Magna Carta in England, but at least thirteen separate historic instruments from 1216 to 1547. Also keep in mind that the Archbishop of Canterbury, whose signature was on the Magna Carta's, was the highest Roman Vatican Cult Bishop in England, who outranked the Monarch. This leads us to question the claims that the Magna Carta signed by John Plantagenet is void, due to coercion as disinformation to hide the fact that, England has been a vassal of the Roman Vatican cult since the Norman invasion in 1066. Which was sponsored by the Roman Cult, and since Duke John Plantagenet ceded the land permanently to the Roman Vatican Cult and himself a vassal in return for, the Roman Pontiff recognizing the Plantagenet as lawful and legal monarchs.

From 1217 until the reign of Henry VIII all Kings/Queens of England were vassals of the Roman Vatican Cult, were expected to commence their reign by firstly, reconfirming the Magna Carta as the basis of all secular law of the realm. The practice ceased in England under Henry VIII, following the concept and system of Acts and Statutes of Parliament that lived beyond the life of a Monarch, which is when the concept of law outliving the Sovereign first commenced. The claim that the 1216 Magna Carta was signed by Duke John of Anglia as somehow the King of England, Wales and Ireland, with Scotland in agreement, is a an absurd and untenable fraud designed to hide the facts that. (1) John was only a Duke of part of the Island of Britain called Anglia. (2) Under the terms between the House of Plantagenet and the House of De Montfort of Gascony since 1154, John was the vassal of Gascony. (3) Duke John never controlled Wales, nor Ireland, nor Scotland nor even Kent during his reign as Duke. (4) The true Magna Carta was signed after Duke John was executed, not before. (5) The true Magna Carta was between the surviving Barons of the Duchy of Anglia to pledge fealty to the Crown of France. (6) Anglia by the solemn sacred pledge of the Barons of Anglia became a Duchy of France from 1216. By 1227, following King Louis IV of France (1226-1270) securing a solemn pledge by Henry III, to fight with the French against Duke Simon V De Montfort of Gascony, Duke Henry failed to secure the support of his barons. Instead, Baron Gilbert de Clare led a rebel force against the forces of Henry III and the French in England. Neither side were able to gain a decisive victory, and it was not until 1235 that Henry forced Gilbert de Clare and the rebel barons to flee to France, and the protection of the Duke of Gascony. It was another four years before the English King was able to send a sizeable force, to the aid of King Louis IV of France. Finally, in 1242 the English and French met the forces of the Duke of Gascony at the Battle of Taillebourg, at which Duke Simon V De Montfort was decisively defeated and forced to retreat France. As reward, King Louis IV of France made Duke Henry III of Anglia also Duke of Aquitaine, over the captured lands of the Duke of Gascony. Around 1244, Duke Henry III of Anglia secretly received an official delegation of Venetian nobles and Franciscan Priests, from

the religious order invented by Venetian Doge Giovanni Bernadone Morosini (Moriconi) "the Frenchman" (1249-1253). Henry III granted exclusive, absolute and perpetual ownership of Thorne Island in the middle of Thames River, to the Franciscans and therefore Venice. Work immediately commenced on the construction of the largest church ever conceived in England, and in 1269 West Minster Abbey was consecrated. The legend that the abbey was built by Benedictines from France and Germany, is a crude and absurd fraud. In 1258, Gilbert de Clare and an invasion force landed in northern Britain and south to Oxford, where he declared the Duchy of Anglia abolished and the existence of a new Duchy called Land Castre, now known as Lancaster, meaning literally purged, pruned or cleaned land. To be ruled by a Great Council of Barons as defined by the Provisions of Oxford. Crown Prince Edward engaged the rebel Barons in central England, while a second invasion force headed by Duke Simon V De Montfort landed by 1263 in the south, and proceeded to capture south-east Britain. Then forcing Henry III Plantagenet into Battle in Sussex at the Battle of Lewes by 1264, at which Henry was captured and executed by Duke Simon V De Montfort. Prince Edward was captured soon after by the forces of Gilbert de Clare. In 1264, upon conquering and expanding the former lands of the Duchy of Anglia, Duke Simon V De Montfort refused to accept the Provisions of Oxford, and instead demanded Prince Edward be handed to him. Gilbert de Clare and the rebel barons instead refused, and pledged their loyalty to Edward as a king, if he solemnly swear to uphold the principles of the provisions. Aided with reinforcements from France, Duke Simon V De Montfort was killed at the Battle of Evesham in 1265. However, Edward did not immediately declare himself a King, instead he undertook a famous and elaborate ceremony, in declaring to undertake a Crusade to the Holy Land. However, Edward found reason to divert to both Venice and then to Rome, where he met Doxi (Doge) Lorenzo Tiepolo (1268-1275) and Roman Pontiff Gregory IV (X) (1268-1274) (Tedaldo Visconti of Pisa). In 1272, Edward returned to Britain, aided by a militia force funded by Venice of at least 30,000. Edward reached a truce with the Danish Kingdom of Kent, granting them unique status of self-rule while still being under the Kingdom of England. By 1274, Edward was crowned the first King of England. Mercia was finally subjugated by a militia force, and Llywelyn ap Gruffydd was assassinated by 1277 under treachery of the Anglicans. Then in 1297, the first genuine Magna Carta of English nobles was signed by Edward I, in recognition of his solemn promise when captive in 1264. Thus, the first statute of England is 1297, with all previous laws and statutes a deliberate fraud.

An assembly is a church gathering, and is not an official Government entity. Assembly of persons, for consultation, deliberation or advice, early 12c., originally in the Church sense. Synagogue (n.) late 12c., the regular public worship of the Jews, also the building in which this is done, from Old French sinagoge synagogue, mosque, pagan temple. 11c. from Late Latin synagoga congregation of Jews, from Greek synagoge place of assembly, synagogue; meeting, assembly. Used by Greek translators of the Old Testament as a loantranslation of late Hebrew keneseth assembly, as in beth keneseth - synagogue, literally house of assembly, which is where the Israeli Government word comes from Knesset. There is no entry anywhere in law or by documents that states an assembly can become a Government. Using these words and claiming their assemblies are the new Government is a recipe for disaster for ordinary people. Claiming you are the new government brings up the word coup, which is short for coup d'etat. Coup d'etat means technically any sudden, decisive political act, especially an important and unexpected change in the form and methods of a government, but in 20c. popularly restricted to the overthrow of a government. Let's look at the law on this, 18 U.S. Code § 2385 - Advocating overthrow of Government. Whoever knowingly or willfully advocates, abets, advises, or teaches the duty, necessity, desirability, or propriety of overthrowing or destroying the government of the United States or the government of any State, Territory, District or Possession thereof, or the government of any political subdivision therein, by force or violence, or by the assassination of any officer of any such government; or Whoever, with intent to cause the overthrow or destruction of any such government, prints, publishes, edits, issues, circulates, sells, distributes, or publicly displays any written or printed matter advocating, advising, or teaching the duty, necessity, desirability, or propriety of overthrowing or destroying any government in the United States by force or violence, or attempts to do so; or Whoever organizes or helps or attempts to organize any society, group, or assembly of persons who teach, advocate, or encourage the overthrow or destruction of any such government by force or violence; or becomes or is a member of, or affiliates with, any such society, group, or assembly of persons, knowing the purposes thereof. Shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States or any department or agency thereof, for the five years next following the conviction. As for the above, you have all been warned. From Canon Law to the standard of excellence, where we set the much higher bar of excellence, not the lawless way they did it, and so then it becomes our law.

TPC COMMUNAL LAW INTRODUCTION The True Rule of Law: Acknowledgement: My deepest gratitude and respect go to Frank O'Collins, founder of Ucadia, and who's over 40 years of research I have used as the reference material for this essay.

Introduction: In this article I will set out to define what is the True Rule of Law; however, in order to recognize what Law is, first we must: Know who we are. Know how our Honor and Free Will choices are used against us. Know by what mechanisms the current system maintains its' control over our minds. Know by what relationship the casting of spells and magic has to do with the True Rule of Law. Spoken words are a vibrational frequency. As we speak, audio waves excite the atoms in the air, our ears turn them back into signals that are decoded by our brains. Our word definitions and beliefs filter our perceptions and distort our ideas and ultimately our actions. Thus, we collectively manifest a world of ideas and perceptions based on the things we choose to believe. This is why most schools no longer do the phonetics, as they are asking you to change the tone and often the meaning of the word. There is a reason words in the European languages have multiple meanings, all designed to confuse us. Teaching children the etymology of words can overcome this deceit within two generations. Language can be deceptive. The Jesuit College of English in the late 16th Century introduced the worlds' first Mind Influence System, that eventually replaced physical slavery with voluntary slavery of the mind. A number of ideas and words were introduced as the English Language was created. Some key words and ideas that influence our minds today are: The word government (from 3 Latin words): "ago" meaning to manage, to drive. "vern" meaning a servant born in their masters' home. "ment" meaning mind. Govern itself means to control. Hence the original and true meaning of the word government is, to manage/drive the mind of a servant born in their masters' home, which is the plantation. Plantation means the abode of the plant, a plant in it's other form outside of gardening means, to insert someone or something to corrupt, distract, deflect or hide from, like a secret agent.

The word Parliament (from 4 Latin words):

"par(s) meaning stage, side, direction, role, duty, function, degree.

"lis/litis" meaning a legal controversy, action, suit.

"ab/a" meaning in connection to, concerning, about.

"ment" meaning mind.

Hence the original and true meaning of the word Parliament is, to direct legal controversies, action, suits in connection to or concerning of the mind. Parlia means to speak, so speak of the mind, and so they speak for our mind. This is where the Speaker of the House comes from, it is the House of Government a lower control structure of the House of the Pharaohs mentioned earlier. It all goes back to Egypt and the off world control system.

The word democracy (from 2 Latin words):

"demo" meaning to take away, subtract.

"cratis" meaning ribs, framework/fasces, the bundle of sticks carried by Roman legions signifying Roman Law and rights of Roman citizens.

Hence the original and true meaning of the word democracy is, to take away, subtract Roman Law and Rights through Fascism. All forms of Government, be it Democracy, Socialism, Communism and even Fascism, are all part of the same system of control, ran by the same group of people known as the Zionist. They created it all for the illusion of choice and to divide and conquer the people.

The word common (law) (from 2 Latin words):

"com/committo" meaning to entrust, commit.

"munis" meaning burden, public duty, service or obligation.

Hence the original and true meaning of Common Law is, to entrust, commit by consent to a burden, public duty, service, obligation by Law, which is equivalent to voluntary enslavement or lawful slavery.

Many people will not agree with that assessment, but common law is for commoners. If we are not all commoners, that then means there is a hierarchical system that separates us from others. Those others have then assumed control over us. What is the meaning of commoner? Commoner (n.) late 14c. (mid-14c. in Anglo-French), one of the common

people, a member of the third estate. A member of the third estate, not the first estate as it would be if we were all free. The Estates system was brought in around the French Revolution, which like the Magna Carta and the Russian Revolution of 1919, was all fake and not for the benefit of the people. Estates of the Realm: the First Estate (clergy or the church), the Second Estate (nobility) and Third Estate (commoners). With around 27 million people or 98 per cent of the population at the time, the Third Estate was by far the largest of the three, but it was politically invisible and wielded little or no influence on the government. Not all members of the Third Estate were impoverished. At the apex of the Third Estate's social hierarchy was the bourgeoisie or capitalist middle classes. The bourgeoisie were business owners and professionals with enough wealth to live comfortably. As with the peasantry, there was also diversity within their ranks. A system of venality evolved that allowed the wealthiest of the bourgeoisie to buy their way into the nobility, though by the 1780s this was becoming more difficult and frightfully expensive. This is a typical trait and failure with humanity, that with money you buy into the dark programs for a fake status, and in doing so not only sell yourself out, but the people you came from. All too common that commoners trample on their own people, and that has to end going forward, we elevate each other, not trample over each other to get to some greater wealth or image status. Noble (n.) man of rank, person of acknowledged social or political preeminence, person of rank above a commoner. Villain (n.) Old French vilain meant peasant, farmer, commoner, churl, yokel. Meaning character in a novel, play, etc. whose evil motives or actions help drive the plot is from 1822. So a commoner is classed by their words as a villain. Boy (n.) mid-13c., boie servant, commoner, knave (generally young and male); c. 1300, rascal, ruffian, knave; urchin. knave (n.) late Old English cnafa boy, male child; male servant.

The word Environment (from 3 Latin words)

"en" meaning within.

"virio" meaning green, flourishing.

"ment" meaning mind

Hence the original and true meaning of the word environment is, flourishing within ones' mind, or to put it another way, within ones' imagination.

Our environment is a wakeful and conscious dream projected over, the perceived dimension of this external world, so that the two become indistinguishable.

A bit like the modern technology of the virtual world, and the said to be the future technology the Metaverse. When in reality it has already been running in the sub conscious world, now they are trying to implement it into the physical world.

The above words, government, parliament, democracy, common law have created a hidden system of voluntary enslavement within our minds (environment), which is now in the open once we see the original and true meanings of the words. It also leads us to question Environmentalism, when we know that the environment exists within ones' mind.

Environmentalism is another concept of the Green brigade, given virio also means green, add in the Matrix which was green, and the mind control MK Ultra was ran by a person with a fake name, Dr. Green and you begins to see a bigger picture in your mind, not theirs. It is another example of the externalization of us, replacing the inner knowing, the inner church and God/Source, the inner abilities or technologies, the inner peace, sanctuary and sanctity of what it means to be a spark of creation. As above so below, as within and so without.

Our body & mind observe & perceive what is changing or moving in the world. Our mind can filter out and not focus on the noise, every single nook and cranny. It creates an approximation of the underlying world, ignores/deletes some stuff, as well as inferring some stuff that is not there. If our mind becomes stressed when unbalanced by fear, anxiety, worry, enforcement, law, government or any other situation projected onto us by external influences, it diminishes. Our bodies also become unbalanced, depleting our energy and power, making us feel weak, out of control, with our physical health also suffering.

Our mind is the most powerful thing we have and if we allow others or external things to manage it for us, life can become very difficult. If we learn to manage our own mind and not let others or things control it, we can find peace of mind, develop and grow our mind and our spirit, and improve our health. We find that we have the power to project an environment that is heaven on earth, and can manifest the reality of this, a self-fulfilling prophecy.

The key to overcoming the mind issues is, to learn to control it and or turn it off, when you have developed the self enough to operate from the heart. The mind can be controlled and manipulated, thinking from the heart, it can't. For those new, the heart has more neurons than the brain, they want you to use the dualling hemispheres of the brain, as both sides fight and they feed your head with enough to control. The key is to not feed your head, but feed your heart, heart is where your wisdom comes from. Wisdom and intellect are a much higher form of learning than intelligence. Most people can become intelligent via reading books, but too few go onto gaining wisdom and intellect, because too many stay in the mind. But we all need some peace of mind. PEACE OF MIND

Words have power, words form through spelling. A spell is an utterance or something said. Magic is energized by our belief that something is possible. If we believe that words uttered as a curse can affect us, they have power over us. A spell is witchcraft and a part of the dark arts, there is no light witchcraft, that is another illusion game. Using witchcraft is cheating your own development, there are no short cuts, and cheating is the dance of the dark.

The English language was created in the 16th Century as part of a Mind Influence System designed to affect, manipulate and change the mind of entire populations. It is a very occult language made up of Latin, Ancient Greek and Egyptian, French, Saxon, Irish Gaelic and Ancient Briton languages. Occult simply means hidden. The Law is occulted to inhibit our competence and deflect our counter claims.

When we know the root meaning, what the original meaning of a word is, we take the power of a word, we control that power, and any use of the word can no longer control us without our acceptance.

They played on our fear but, what is Fear?

Fear is an energy flow that, like a fire, needs to be constantly fed and is maintained through force and manipulation. Love, on the other hand, is pure power harmonically attracting energy. One can simply be in love without using any force.

The current system of government (mind control) is maintained through fear, force and fraud. As applied here, fear is an inwardly reactive energy, force is an outwardly aggressive action and fraud is a deception. When we discover the original meaning of fear, the root of mind control, their whole paradigm comes crashing down, it loses it's power and can no longer control our mind.

We are taught that the word fear means calamity, peril, sudden danger, risk of death. A state of distressed negative sensation, potentially a crippling emotional state of mind and body, induced by some perceived threat in the mind. Fear is the most potent weapon of mind control of the current system because it is self-actualized.

But where did the word Fear come from? It actually originates from the 1st millennium BCE, and comes from Irish Gaelic. The word is the same, f-e-a-r, and meant, faithful or honourable man, faithful, honourable bloodshed or slaughter. This is the true original meaning of fear, and like many other words, the meaning has been reversed.

Fear comes from 2 ancient Irish Gaelic words Fe, meaning faith, bravery or belief and then Ar, meaning for, on, bloodshed or slaughter.

So how did fear come be a thing that paralyses us today?

From the 12th century wave after wave of mercenaries were sent in to Ireland, to destroy, poison and defeat the Irish. They were faced with Irish warriors that would die to the last man. They were experts at a form of warfare called berserk, which is to be in the state of a crazy man with the energy of 10 men. Known as the Berserkers, who were said to have acquired that state via drugs, alcohol or mushrooms, again that is cheating and a dance with the dark, when that state can be achieved from within and using your own abilities, once you have developed the self enough. Cheating is a weakness not a strength. Hence, the word fear acquired the concerns and perceptions of the mercenaries, who were paid killers with no honour or virtue, as they faced warriors of honour and virtue defending their homeland and families. So the invaders came to interpret a word meaning honourable, brave man and honourable slaughter, to mean, calamity, sudden death, peril, as that is what the mercenaries experienced.

Now we know the original meaning of the word fear, we can say that if we stand in truth, honour and integrity we truly are fearful, men and women of bravery and honour. Hence true fear reflects energy harmonically spinning out of love, not in opposition to love.

Now we have taken back the power of fear and it no longer has power over us.

What Did They Do?

They say possession is 9/10ths of the law, but what about the remaining 1/10th? The Romans instituted a system called Occupatio, which means occupation, whereby they created Provinces (areas of military occupation). Occupation conveniently has two meanings, although only one intention. Occupation means nowadays for job title, occupation also means to inhabit or host, so to occupy something. They then devised an idea called legal title, they created Rolls (scrolls) and listed the names of everyone in a Province. Once a name was entered into the Roll, the name became the property of the Romans. Latin words for name are nomen, familia,(name, family name) which are both slave names. The fact that these names are in their system, makes you a slave.

A Register, pages of the Rolls extracted and bound in book form, was then created and a Certificate of Title created, an extract from the Register, as proof of claim of ownership of title, the nomen and familia. Register means you came under the reign of the King, regis mean king and regina means queen.

People were allowed to occupy the land as tenants or slaves, and ownership of title/name was claimed by the Roman over lords. Thus, all became slaves losing all rights of ownership. Property became equity, right of use, whilst ownership of the title/name was claimed by the over lords. They claimed ownership from the name, familia, whilst the people were left with the right of use of the body but never the legal title or ownership of the name. Why did they do this? Expediency, they could not take everything militarily, so they instituted a system whereby they took ownership and could influence the mind.

Just as today we might borrow a friend's car, we have temporary right of use but do not have legal title and can lose the right of use at any time.

This is a key understanding to what they did to perfect claims of ownership and control in the present time.

We will now jump ahead a few hundred years to summarize how they perfected these control mechanisms, and created the systems that underpin the modern world.

In the 14th to 15th Centuries, the Vatican issued 3 Papal Bulls. First was Unnum Sanctum claiming they were God's appointed Trustee, through Apostolic succession from Jesus Christ. As Trustee they claimed legal title of the World giving them ownership of everything and every Soul on it. Unnum Sanctum was an Express Trust. In other words, it had been expressed, but there was no legal mechanism to pass on title to the heirs and successors of the Pope. It was also a Living Trust and could be challenged.

Next, they created the Papal Bull Romanus Pontifex. This Trust created the legal mechanisms to pass on ownership to the Pope's heirs & successors indefinitely. It enclosed the Office of the Vicar of Christ in a Testamentary Trust, becoming the first Cestui Que Vie Trust. It also created the first Franchise mechanisms, making it legal to do things that otherwise would be illegal or unlawful. This is when they also claimed ownership of the physical body of all human beings.

Lastly came the Papal Bull Aeterni Regis, claiming ownership of the mind under the eternal crown. This created the 2nd Cestui Que Vie Trust, the 3rd Cestui Que Vie is created when they sell the Birth Certificate to the Bank, more on that later.

No one rebutted their claims, and a maxim of Law states that a claim un-rebutted stands. This comes under the stealth tactic they have often used of, implied consent. At some point they will have announced it, but as often in the modern day it is wrapped into lengthy bills and people don't bother to read them. That has to change going forward, as all bills should be transparent, and more importantly easier to understand, and not the legalese waffle they issue today. This is one way that they used True Rule of Law against us, and why they need us to remain ignorant of the Law.

These 3 Bulls are known as the Triple Crown of the Vatican. The Financial and Legal arm of the Triple Crown started to move to the City of London in the 16th Century during the reign of Henry VIII. After the Fire of London in 1666 they were in full control. Today it is the mile square Crown Corporation of the City of London, and contains the Inner, Middle and Outer Temples, the Bank of England and is the Legal and Financial centre of the World.

For those new listening to this, the City Mile is not part of England, it is a separate principality that even the Queen requires permission to enter.

What Are the Control Mechanisms?

A Testamentary Trust is a Trust created to administer the property of a dead person. When someone dies, their last Will and Testament is a Testamentary Trust. An Executor is nominated by the Testator, the creator of the Trust, and they have full authority to manage the property in the Trust, to see that the Will (mind) of the deceased person is carried out.

In the 16th and 17th Centuries the Cestui Que Vie Statutes were created by the English Parliament. A Cestui Que Vie is a Testamentary Trust. What a Cestui Que Vie does is convey legal title, ownership of property, into an Estate that is managed by an Administrator/Executor. The property is known as the Trust Corpus, which is the body of the Trust or Corporation, and the policies of the Trust are the rules. These are the private statutes by which the Corporation/Body of the Trust is administered. The important things to note are that, only the legal title of ownership of the property is conveyed into the Cestui Que Vie Trusts, and it is a secret, private Trust as the Will and Testament were never published and made Public.

Right of Use, or Equity, is also property, this is not conveyed into the Cestui Que Vie Trust. As a Testamentary Trust is created for a dead person, a dead person cannot challenge any claims or claim right of use. You are confirming you are a dead person every time you write your name in capital letters. This means that the Equity, Right of Use of property remains in dispute. When the property of a Trust is in dispute, it is called intestate and goes into probate, which means the Crown or Government claims ownership, and administers the right of use until the Living Flesh person shows up to claim his or her property. Well, as the person is dead, this claim can never be challenged, and this is one process they use to claim ownership of every Mind, Body and Soul.

How and Why Do They Claim We Are Dead?

In the 11th or 12th centuries the Venetian/Khazars' took over the Universal Catholic Church created by the Carolingian Franks (think Charlemagne's forbears).

The Carolingians created the Universal (Catholic) Church around 700AD, in a dispute with Byzantine Christian Church created by Emperor Constantine around the 300AD era. The Carolingians set up their head office in what was Rome, they claimed apostolic succession from Jesus Christ, and created the first Vicar of Christ, Pope, seated in Rome. They created the Sacre Loi, Sacred Law, that still forms the bedrock of Ecclesiastical Law to this day, only their Laws and Sacraments have been twisted and reversed to control us rather than protect and free us. The Universal (Catholic) Church was usurped around the 11th Century by the Venetian/Magyars and Cult of Mithra which now holds office in the Vatican.

The Carolingians had seven sacraments, which are processes unique to everyone. They were replaced by the Vatican with seven sacraments pledging our souls to their church, or god, which originates from the Persian word gad for Satan. Gad is also a Slavic word and it means reptile. Oh my. The Carolingian sacraments were: Hoenstus (Honesty) – Honour Fedelis (Trustworthy) – Integrity, having merit Virtus (Courage) – Heart Iustus (Justice) – Remedy Penitus (Penance) – Self-examination Caritus (Charity) – Love Clementis (Forgiveness) - Release

The Roman Vatican Cult reversed these sacraments, for example, Penitus (Penance) became about sin, confession and punishment rather than the healthy self-examination required to correct our ways. We will focus on two Sacraments twisted by the Roman Vatican Cult to highlight some key control mechanisms. The Sacraments of Penance and Baptism: When the Carolingians created the Universal Catholic Church, the Frankish knights re-established law and order across Europe and promoted Shadow Work. Penitus meant honest self-examination and Purgare meant letting go. From the 13th century the Vatican corrupted Penance by replacing self-learning, knowledge and honesty with pain, punishment and subjugation. Purgo+Tormentum is cleaning, purging and purification through torment and torture. Hence the need for Original Sin emerged. The abhorrent doctrine of Original Sin was invented by the Jesuits in the 16th Century, as a key doctrine of their twisted religion. Sin is a fictional concept within the fictional framework of Morality. Sin, created in the 16th Century, forms a commercial element of control and is claimed to be inheritable as the Original Sin. The lawyers of the Roman Cult designed this concept, to mean all people are born bankrupt and in debt, therefore, without traditional Rights. This concept is a complete aberration of the True Rule of Law, which

states that sins/debts cannot be inherited from our forebears, as the accounts are balanced at death.

The word Bank means from 2 Egyptian words: Ba meaning the soul Ank(h) is the symbol of Isis, who became Venus, Luciferia, Lucifer, Cybele, Mari. The meaning of seat or bench for Bank was a 14th to 16th Century addition. Hence the original and true meaning of the word Ba-Ank(h) is the Soul of Lucifer, which became the seat for the soul of Lucifer. Lucifer was associated with Satan/Moloch in the 14th to 16th Centuries. Hence today a Bank is the seat for Satan's soul. Bankruptcy is to become ruptured from Lucifer/Moloch/Satan's soul, hence we are lost at birth and need to be salvaged. The word salvation comes from the Latin root salvus, meaning to make safe and secure possession without violating the law. Hence the salvation of the soul, is the claimed securing possession of property without violating Divine Law, as the soul is bankrupt at birth, ruptured from the soul of Satan and needs salvaging. Salvation is deliberately and falsely compared to the concept of Redemption, whereby a person is capable of reforming previous behaviour of character. Instead, Salvation depends upon the promotion of the concept of Original Sin and is a commercial Claim of Right, think Salvage of property lost at sea, dressed up as a religious dogma. The receipt of goods and payment received by the Roman Cult for Salvaging Souls under the dogma of Salvation, is the right to control the monetization of Sin, which is the essential concept of underpinning debt and almost all money systems of the world today. Original Sin also means we are lawfully slaves until the debt inherited at birth is settled. By granting the Roman Cult the right to salvage and then monetize these debts in the form of money, individuals are then freed from the debt & granted minimal rights, under the control of the Roman Cult who then control the energy of the World. Thus, the need for the Sacrament of Penance as we are born in Sin and need to suffer pain, punishment and torture to purge our Sin, and the Sacrament of Baptism, to save salvage our souls. ONLY MY SOUL

The Financial System is underwritten by Indulgences. An Indulgence is basically a certificate issued by a Scrivener Notary, to those who could afford to pay them to create the Indulgence. The Indulgence was created to monetize sin, by creating a way to pay the debt and earn Grace, forgiveness for our sin, for those who could afford it. In time the Indulgence Certificates were given a value, monetized and became Negotiable Instruments. A Negotiable Instrument is a bond, a promise to pay. The value is underwritten by an individual's promise and reliability. For many, our word is our bond,

we keep our commitments and pay what we owe, and it is this reliability that underwrites the Indulgence Certificate, Negotiable Instrument. A Negotiable Instrument is a note put in Trust that has some performance obligations, and can be traded by 3rd parties to the original agreement. These form the Bonds, Bailments, Securities and Annuities that underpin the Financial System today. It is our work, and our energy that creates the value, and our promise to give a percentage of the value we create to repay the debt, to balance the books and earn Gods' grace that underwrites all money today. Simply put, a debt is a promise, obligation to pay something to someone. And if we default or don't pay, we are in dishonour and all our property can be seized. So, whether we honour our bind or not, they get paid.

The binding agreement plays out in other fields, Covenant and Testament are both binding us to the story. The wedding ring placed on the 4th finger of the left hand, binds the heart. It is the hidden contract game they have played on us, we tracted with the con, tract also means a body of water, and the water terms plays heavily into this. The Holy Sea, curren-sea, banks of a river and deposits on the banks, the birth canal, your waters breaking, the court dock and serving you doc(k)uments all plays into this. Even your computer with ports, all of them shipping and or water terms. We consented to it without knowing, they sent the con, and we consented, whether implied or not. But the water aspect plays into the next piece.

So, where does Baptism fit in? Because being born in sin/debt means we are born bankrupt, in debt with no rights, the Vatican creates a fiction persona (person), and grants minimal rights/privileges to the fiction persona, the property they create and own.

To do this, they save/salvage the soul so it can be born again as a legal fiction.

This is done through the Ritual of Baptism, which is another abhorrent doctrine, reinstated by the Jesuits in the 16th century, whereby they decided a baby could consent to an agreement, and also by tricking the parents into conveying rights of ownership of the baby's name, to the Crown through the Live Birth Registration process.

Baptism comes from Baptismo (from 4 Latin words):

Ba = Soul (Egyptian and one of the oldest names for the Soul)

Apto = Prepare, make ready (Latin)

Is = for (Latin)

Mo = Moloch, Ba'al, today known as Satan

So, Baptism is to prepare the Soul for Moloch/Satan. Moloch was the Mithraic entity the Persians then Romans sacrificed babies to through fire and cannibalism, and the seat of Satan is a Ba-Ank(h), Bank.

In Roman doctrine they allowed baptisms to occur outside of the Church out of necessity, such as if death is imminent, and as ritual only. As long as the ritual takes place, you are baptized and your Soul is Salvaged. This enabled them to move the Sacrament of Baptism to a Hospital, to be performed by a licensed person such as a Registered Nurse or Mid-Wife.

How is this done?

The pain of birth is the Mothers' penance for her sin, the baby is washed in water, baptized.

The baby's eyes and mouth are wiped clean with Silver Nitrate. Why Silver Nitrate? Because this is Silver that has had the gold atoms removed, gold represents the Soul to the Vatican. An ancient death rite was to cover each eye of the deceased with a coin and place one coin in the mouth. These coins were to pay the Ferryman to salvage the soul, as he ferried souls across the River Styx to the Underworld. So the gold atoms that have been removed from the Silver Nitrate that is used to wipe the baby's eyes and mouth, represent the payment to the ferryman to salvage the soul of the baby, then the paperwork is processed to create a new slave bond.

So, in the birth process we have the Sacrament of Penance, the Sacrament of Baptism to prepare the soul for Satan, and the Death Ritual to salvage the soul because it was born bankrupt, ruptured from Satan, in sin/debt and is born again in the underworld as a legal fiction.

The baby's footprint is imprinted in ink (an ancient form of signature) on the Live Birth Record, or they use a drop of blood, and the parent's signature as legal guardian. This conveys ownership, legal title of the name to the Crown. The baby is then weighed, and the birth weight is transferred into the value of gold that day, and a trust account is created in the babies name with the value of the gold in weight. In today's terms a 7lb baby equals 116 ounces, gold at \$1800 an ounce, equals \$208,800 into the trust. Of course no one is aware of this, and so after 7 years, when the child doesn't claim the account, they are declared lost at sea, and the State claim the account.

The Birth Certificate is also a Death Certificate and a Certificate of Baptism. It is also used to create an Indulgence binding the baby to pay the debt, created by the Original Sin it has inherited, this is the slave bond.

Grace, or Divine Grace is a dogma introduced in the 14th Century, and assigns Grace as an attribute of God bestowing undeserved and overflowing love and mercy to those, willing to be salvaged through Salvation of the Roman Cult. Grace comes from the Latin gracilis meaning slight, meagre and poor. In order to promote a system of deprivation of rights and slavery, the concept of Grace was developed whereby adherents would be told that, if they accepted their lot in life and the authority of the church, then God would grant them an undeserved state of peace, tranquility and inner joy, called Grace, and that through Salvation (salvage) they will enter Heaven. Thus, Grace has been a powerful Mind Influence Tool in promoting voluntary servitude, also known as slavery.

Amazing, that grace, and how benevolent to honor us as such!!

Incidentally, enslavement is a term used to define the process of making one subservient, by stripping them of certain rights and replacing them with privileges. Sound familiar Americans? driving is declared a privilege in America not a right. The term was invented in the 17th Century, during the refinement of the voluntary system of servitude known as common law, oops. So, common law is a system of servitude? oh dear that will not please the army of common law people around the alternative media.

Enslavement means (from 3 Latin words):

"en" meaning make, put in

"slav" meaning servant, bondsman of a Khazar overlord

"ment" meaning mind

Hence, the original and true meaning of the word enslavement is, to create the mind of a servant to the Khazarian overlords. It was the Ashkenazi and Khazarian diaspora who are known as the Jews today, linking back to the Hebrew/Anunnaki, and the Mithraic mysteries form the basis of the Talmud.

The Sacrament of Baptism is also eternal, there is no process to undo the bind, until we realize it was fraudulent ab initio, which means from the beginning and we learn how to Annul it.

Last but not least, it is the Mother that gets discharged from the hospital, the baby does not. The baby is never discharged and our Medicare Cards, NHS or Social Security Numbers are proof of this, and these are the only IDs we carry from birth to death. Which leads into the next layer of control.

What Happened in 1871: In the 1800s lunatics that were patients in a mental hospital were called Residents.

In 1871 the Local Government models were created. Town councils were created, the Acts of Settlement, Vital Statistics and Births and Registrations we enacted in the UK and other countries. Keep in mind Vital Statistics are a subsidiary to Health. So, Poor Laws, Health, Councils, Local Government and the Cestui Que Vie Acts and Trusts were merged in 1871, all under the banner of Health.

In 1871 that year was the last year for the Original American Constitution, and the last year we had an American Government, all that followed were an American corporation company called USA Inc, registered in Delaware. It adds a whole new meaning to the crossing of the Delaware river. River is a body of water, currencies, deposits, bank, baptism and birthing are all based on water terms, all ran by the Holy Sea, SEA not capital C. They crossed the river can be seen as symbolic of the crossover into Maritime Law. What is a Council? Well, a council is a committee and comes from Latin Comitare. Originally a Council was a committee that administered an institution, established in trust, instituted for the care of minors, lunatics, infirm or incompetent, who have been admitted to care in a hospital. Patients were called Residents, what is the meaning behind that? Residing somewhere, could be described as being kept in house, as a resident of the House with a capital H, the House of. Late 14c., dwelling, residing, having an abode in a place for a continuance of time. From early 15c. as stay in a place in discharge of some duty, remember the piece earlier, the mother is discharged not the baby? what is or was the baby under duty for? It will come to no surprise to our regular listeners that, this word originally was ecclesiastical, meaning of the church. Yet, again showing the role of the church in a range of anti human activities. Residency in a hospital sense was introduced in 1924.

Under the Council model, a unit becomes a ward, a patient is called a Resident. A ward is a Hospital Ward, a Hospital is a military institution and a County is a military company, the same as an occupied territory.

A Council is the administration of Residents in voters wards, as outpatients of a Mental Hospital, which is why they call it seeking asylum. They essentially declared themselves as our wardens, wardens, the ones who watch out or guard for, which is why the prison guards are called wardens. It is the same system of control, whether you are free, in jail, in hospital or mental facilities, we are guarded by wardens. As Residents we are legally infirm, incompetent, idiots, lunatics, children, thus need a Guardian and Custodian with full Powers of Attorney to become our mind, just as a parent is the legal guardian and mind for their children.

Legally we are defined as idiots, meaning we have no mind, and are happy to live life happily believing life is lovely, and allowed to keep just enough to get by on. In other words enough to exist on, but never enough to live on, just enough to keep the batteries flowing, so they can harvest our life force energy. Alternatively, if we show signs of competence, we are legally considered Lunatics, who demonstrate some competence but will ultimately fail, say there is no remedy and fall back to being an idiot.

Clearly there is much more to discover however, what I have described are two foundational layers of the Mind Influence System. There is remedy, more on that later.

True Rule of Law: Now let us summarize a couple of the thinking and mind influence mechanisms put in place since the 16th Century, that underpin the Financial and Legal

Systems and enable the powers that be to maintain control, and how they use our Honour and Free Will against us when they keep us unbalanced through Fear.

Of all the forces within the Universe, the greatest is the action of Free Will and Choice. For the very existence of existence itself, depends upon the Free Will and Choice of the Ultimate Creator to wish to exist. All forms of mechanistic or chaotic or random models concerning the ultimate Universe and Creation itself, are fatally flawed in the absence of such elementary reasoning.

All conscious entities possess the absolute right of free will or volition and choice, and every being capable of consciousness and discerning their own thoughts, is ultimately responsible for their own actions and obligations.

When a higher life form binds themselves to an Office by Oath or Vow or claim Divine Authority to Office, they also bind themselves to the obligations of such Office to uphold the True Rule of Law & Justice. They duped us all when giving us an illusion of choice, using binary terms and programs of choice, but those choices were not our choices, it was only the systems choices. The classic example of this is at election time, the candidates put forward where not the peoples choice, that was their choice, and by voting we are negating our own choice and only accepting their choices. The other example is in the Matrix series, they offer blue or red pills, and because of mind control many accepted the red pill, when if you chose triality and not binary, the choice to make was, neither pill. I hear people often when speaking of common law and sovereignty, yet how many people claiming about sovereignty use the triality choice, which is their own. How many whining for sovereignty and then negated that when voting for Trump? Sovereignty in inherent to us all, does not require pieces of paper to say so, it just requires you to make your own choices in life, whilst operating under the Golden Rule. When an Officer is culpable of delinquency, perfidy, tyranny or impiety, their authority is temporarily suspended as is their right of free will, and choice to bind themselves to such Office. When this occurs, we are empowered to restore liberty and impose fair and just penalty, as such action does not break the Universal Law of Free Will and Choice.

No Spirit living or deceased has the right to usurp Free Will and Choice of another, notwithstanding impediments, by virtue of delinquency and dishonour that suspends such rights. It is a grave transgression against all Creation and all Existence, for a living or

deceased Spirit to usurp the Free Will and Choice, of honourable and virtuous living Spirits.

It is important to understand this, as the mind influence mechanisms put in place work through our consent. In other words, the mind influence mechanisms that have been put in place, to trick us into exercising our Free Will and Choice to make bad choices that put us in dishonour. This is used to prove we are incompetent, and have no mind; therefore, provides the ethical and legal justification for the controllers, to take ownership of our mind and treat us like children, lunatics, animals without the capacity to think for ourselves. This is one method of mind influence which they claim, does not violate the Universal Law of Free Will and Choice. After all, if we choose to be incompetent, dishonourable, we get what we deserve.

This is how certain controllers dance right on the edge of Cosmic or Universal Law, it is our acceptance of their measures, our silence which is compliance, and laziness to not correct blatant wrongs in society. They keep giving us their choices, and we keep accepting them, largely because we the people have never created our own voice or platform as a viable alternative to them. Until now, as that is what The Peoples Club was created for, a viable alternative to the old world control system, ran for and by the people producing better solutions for most people on the planet. The TPC moves us away from the binary, into the trinary and our choices, from a child like species to an adult level species. In order to understand what is the True Rule of Law and to become competent in legal matters, it is important to know who and what we are. Competence is the key as without it, we prove their presumption that we have no mind, and enable them to implement powers of control they have already put in place.

Why is this so important? because if we ever have to walk into a court or deal with the current legal system, we need to realize what they are doing and how they operate. If we do not realize that fact, that one of their tricks is to claim that you are separated, and that they believe they can sever by spell, your soul from your mind and your body, we cannot survive in their system. They view them as separate through the prism of a trinity of mind, body and spirit.

Knowing about the Universal Law of Free Will and Choice and who you are is crucial, as how you handle yourself. Whether you use the words we or I, whether you can rebut their claims or not, denotes to them whether or not you know exactly who and what you are, and that no one in their courts or system can continue the pretence that, you are a separate entity or trick you into consenting to their claims.

In order to know who and what we are, we need to know a little about what is life, the Universe and everything.

Life is a dream that exists according to rules. In our flesh we exist according to those rules in the dream, but we are also a part of and represent the dreamer. They want us to believe that there is no concept of a synergy between awareness and matter. Objects are matter/flesh of the dream in motion. They want us to believe that awareness can be separated from the physical. Physical is awareness, everything you see is an idea in motion, so their model is absurd. You cannot sell your soul, you cannot separate your soul, they cannot take your soul, unless you allow it. Awareness in motion with intention.

We are the Divine choosing to experience this life in this flesh, and we may experience many lives or journeys before and after this one.

We are Divine immortal spirits expressed in flesh. They can never take our soul or heart, because soul and heart are one. They can kill our flesh they cannot kill us.

Their model of the world, their societies and history are a horrible corruption of an incredible dream.

So, what are some mechanisms of mind influence? The foundation, base of all Law and Finance is Ecclesiastical Law. On top of that is layered Trust Law, to administer the property in the Trusts they create. On top of that are the private Statutes, Policies, Commerce (UCC), Admiralty, Common and other man made laws, used to manage things in the Estates (Corporations, Property) held in the Trusts they create.

They have basically created a fiction world, Monopoly board game, and claimed to own everything in the fiction as they created it. If we consent to this fiction, they have not violated the Universal Law of Free Will and Choice, when controlling us as we have agreed to be their property.

Summary:

We are fighting in a Spiritual War, a war of bad ideas versus good ideas, no military force in the world can defeat an idea. A battle of the light versus dark in essence. This is why the Jesuit system has been so successful for the last 400 to 500 years. In the 16th century they reconstituted the world under the Roman concept of Occuptio and created Provinces across the world. Their idea was a Spiritual Army has conquered the world, and their missions and posts were the posts of occupation. This is a spiritual and conceptual idea first, and a temporal and implemented idea second, and why no one has defeated their system.

The real power is the idea connected to the spirit. We need many of us to stand up and say, I am immortal and no one stands between me and the Divine, this is an unbreakable bond, and from that point things will change.

The enemy we are dealing with is a bad idea, fraud and stupidity. It's a philosophy of creating an entirely fictitious world, justifying lying, and now the people in power actually believe their own lies, so has become a mental illness.

It is up to each and every one of us to become competent, know who and what we are, stand in truth, honour and integrity. Create bigger and better ideas that will consume all the bad ideas, and empower ourselves to restore liberty and the True Rule of Law being:

This be the First Law of Truth: There is, there was, there has only ever been One Law. All law is equal that no one is above it, all law is measured that all may learn and know it, all law is standard that it may always be applied the same.

A law be a rule given by divine instruction, this being the highest law, no lesser law may contradict it.

A law be an edict, given by a great council of wise elders and agreed by all tribes, this being the second highest law, no lesser law may contradict it.

A law be custom and ceremony over time, this being the third highest law.

A rule that is secret cannot be a law, a rule that is unclear in meaning cannot be a law. A rule that cannot be applied cannot be a law.

A rule may be written by sign or symbol, but only when spoken at a place of law is it law.

A law may be spoken, but only when it is comprehended and agreed is it justice.

All people of the same community, are subject to the same rule of law. All men and women of a community, are bound to live by the rule of law of the community.

No one may be accused except by rule of law, no one may be punished except by rule of law, where there is no justice, there is no law. Where there is no honor, there is no law. A man or woman who are not taught how to comprehend a law, cannot be bound by it.

Any law that is against such truth cannot be law.

Conclusion:

The Golden Rule of Law: No one is above the law and all are equal before it, and no one stands between you and the Divine, and no one may claim your body, mind and spirit, nor may they steal your energy.

Free Will & Choice: The action of Free Will & Choice are the greatest forces in the Universe. The very existence of existence itself depends upon the Free Will & Choice of the ultimate Creator to wish to exist. We are an immortal spirit/mind having a temporary experience in flesh & blood, we are each a single unit of the Divine and no one can stand between us and the Divine, and no one can usurp our Free Will without our consent.

It is now clear that there has been no Rule of Law in Western Civilization and most of the world for at least or over 400 years. That the English Language is an occult language created as the language of legalese to occult the truth, confuse and implemented as part of the Mind Influence System of Common Law and Government created in England from the 16th Century.

The English language has been used against us via the double and sometimes triple meaning of words. But, the real language of law is Latin, which was not native to here, and the use of legalese which means babble and so not understandable. Babble derives from Babel and the Tower of, and gives a pointer to who created it.

Systems of Mind Influence which is govern-ment, who rule through fear, fraud and force. Their power is derived from the consent of a population being kept in ignorance, and who's minds have been conditioned to accept a fictional world, flourishing within ones' mind/imagination, which is en-viron-ment.

So, what is the way out of this maze of distortion and mirrors, and how do we restore the True Rule of Law? To know this, we must learn a little about the nature of our mind.

Only one Mind is permitted to be connected to one Body during its' life experience, however, an unlawful occupation of a 2nd Mind may occur, when a Mind has departed its' own Body and taken residence in the host. Ego & the Mind Virus:

A Mind Virus agent program is constructed, 1st from facts that can be considered to be true, then deliberate false claims, presented as the 2nd fact, which when presented together sound credible, this brings into play logic, but logic is not fact or truth. Lastly a deliberately false conclusion connected to the deliberately false fact is the core falsity.

The word Ego originates from ancient Latin ego meaning I. The Ego is a very ancient reptilian Mind Virus program and is not the same as Self. Ego is a Mind Virus that seeks to usurp the higher functions of Divine Mind, and assume itself as the supreme and singular I. In essence the ego is external of the self, when balanced ego is internal. Which brings us to a meme of the show, when on the external the I which is ego, becomes the we, and when on the internal the we, dual hemispheres becomes the I, then you are on the path to self mastery.

The prime directive of Ego is to keep the Lower, Higher and Divine Minds separate from each other, and the separate from the Unique Collective Awareness. In short, its' prime directive is to divide and conquer.

It does this by creating the Lower Ego (Id in psychology), the Higher Ego known as intellectual Ego that presents itself as the voice of rational reason, self-justification and plausible deniability. - 3. To honor the true Rule of Law;
- 4. To protect the Rule of Law and Justice and Due Process;
- 5. To defend the memory and legacy of our ancestors and founders;
- 6. And to restore the Rule of Law where it has been taken from us.
- 7. Therefore, let all who come before Ucadia,
- 8. And all who seek to engage or transact or bring issue to us,
- 9. Know then that this be our Creed and our Confession,
- 10. Whereby we shall resolve any and all controversy of Law,
- 11. And whereby we shall serve with integrity the needs of our community:
- 12. There is, there was, there has only ever been One Law.
- 13. All law is equal that no one is above it,
- 14. All law is measured that all may learn and know it,
- 15. All law is standard that it may always be applied the same.
- 16. A law is a rule that prohibits or permits certain acts.
- 17. A rule is a norm, bar, maxim, measure or standard.
- 18. A rule may be derived by instruction, discovery, custom or consent.
- 19. The highest law is Divine being a rule given by divine instruction,

- 20. As nothing may contradict such a rule.
- 21. The second highest law be the reason of Mind,
- 22.Being an edict given by a great council of wise elders or jurists,
- 23.As nothing absurd and without good reason may be considered law.
- 24. The third highest law be the law of the people,
- 25.As the consent and will of the people is the source of true authority.
- 26. The weakest rule is that of a tyrant,
- 27.As any rule without authority or right of heaven but merely by force,
- 28.Cannot be sustained and the people shall eventually overcome,
- 29.And render such unjust rule and unjust laws as dust.
- 30. This be the law of all great civilizations from the beginning of time,
- 31.And no king or assembly or city has sustained in ignorance to such foundation.
- 32. These then be the foundations of Rule of Law:
- 33.All law be spoken as it is the spirit of the word that carries the authority.
- 34. Therefore all action under law be by word of mouth,
- 35.And writing be only for memory and trade and never be the law.
- 36.All are equal under the law,
- 37.All are accountable and answerable under the law,

- 38.All are without blemish until proven culpable,
- 39. Where there is a law there must be a cause,
- 40.Where there is a law there must be a penalty,
- 41.Where there is a law there must be a remedy.
- 42.An action in law cannot proceed without first a cause.
- 43.An action is not granted to one who is not injured.
- 44. The action of a valid law can do no harm (injury).
- 45.An action decided in law must reflect cause of such action.
- 46.No injury to the law means no valid cause for action by law.
- 47.No action through law can arise from a fraud before heaven and earth.
- 48.No action through law can arise in bad faith or prejudice.
- 49.An act does not make one culpable unless there be intent to do wrong,
- 50.For no one may suffer punishment by valid law for mere intent.
- 51.No one is punished for the transgression of an ancestor or another.
- 52.No one can derive an advantage in law from his own wrong,
- 53.For what is invalid from the beginning does not become valid over time.
- 54.No one is accused of the same exact cause twice.
- 55.No man be a judge over his own matter,

56.Nor a man possess the authority of heaven to be both judge and executioner.

- 57.No penalty may exist without a valid law.
- 58. The immediate cause and not the remote cause be the subject of law.
- 59. These be the foundations of Rule of Law.
- 60.As to justice it be the maxim that Justice never contradicts the rule of law,

61.For Justice be the lawful right of use of all that has been defined by law,

- 62. And Justice be the rights to adjudicate the law itself before heaven and earth,
- 63.And Justice be a judge under sacred oath and trust granted such rights,
- 64.As a right being a power or authority or privilege or benefit recognized by law.
- 65.Divine Law is the law that defines the Divine and all creation,

66.And demonstrates the spirit and mind and instruction of the Divine,

67. And the operation of the will of the Divine Creator through existence.

68. Therefore all valid rights and Justice is derived from Divine Law.

69.Natural Law is the law that defines the operation of the will of the Divine,

70. Through the existence of form and sky and earth and physical rules.

71. Thus Natural Law governs the operation of what we can see and name.

72. The laws of People are those rules enacted by men having proper authority,

73.For the good governance of a society under the Rule of Law.

- 74. The laws of People are always inherited from Natural Law.
- 75.A law of People cannot abrogate or usurp a Natural Law,
- 76.Nor is it possible for a Natural Law to usurp Divine Law.
- 77. These then be the foundations of Justice:
- 78.All possess the Right to be heard even if such speech be controversial,
- 79.All possess the Right of free will to choose our actions and destiny,
- 80.All possess the Right of reason that distinguishes them from lesser animals,
- 81.All possess the Right to informed consent or withdraw consent,
- 82.All possess the Right over their body that none may claim our flesh,
- 83.All possess the Right of our divine self that none may claim our soul.
- 84. Thus no man can make a blood oath on their flesh or vow on their soul,
- 85.Nor may any man claim servitude or obligation under such an abomination,
- 86.For such Rights are granted solely by heaven to all people,
- 87. And no man or body of jurists have the authority to usurp heaven or the gods.
- 88. Verily all true authority and power to rule is inherited from heaven,
- 89. And to only those men in good faith and good character and good conscience,
- 90. Who then make a sacred oath in trust and form an office,
- 91.Into which such Divine Rights are conveyed for only so long,

- 92.As they honor their oath and obligations to serve the people.
- 93.For whenever a man who makes an oath to form a sacred trust of office,
- 94. Then breaks such an oath through prejudice or unclean hands or bad faith,
- 95.Then all such authority and power ceases from them,
- 96.As the cord between heaven and earth is severed and the trust dissolved.
- 97.Verily no man may serve the people unless under sacred oath,
- 98.Nor may any man serve heaven unless under solemn vow.
- 99. Therefore guard your behavior and actions of office,
- 100. That though the heavens appear to fall, let justice always be done.
- 101. These be the foundations of Justice.
- 102.As to the administration of Justice these be the foundations of Due Process:
- 103.No valid action in law proceeds without first a valid cause,
- 104.And no valid cause exists until such claim is first tested.
- 105. Thus the birth of all action in law must begin with the claim.
- 106.If a claim be not proven as a valid cause then the accused has nothing to answer.
- 107. Yet if the claim be proved to have merit as a cause,
- 108. Then all valid causes in law must be resolved.
- 109. Thus, he who first brings the claim must first prove its merit,

110.As the burden of the proof lies upon him who accuses not he who denies.

- 111.A heavy obligation then on one who first brings the controversy.
- 112.For one who brings false accusation is the gravest of transgressors,
- 113. That it injures not one law, but all heaven and all law.
- 114. Thus a valid claim in part is one in which an accuser makes a complaint,
- 115.Bringing two witnesses as proof and petitions a forum of law for remedy.
- 116.If merit of a cause be proved, the one accused must appear to answer.
- 117. The one accused and any witnesses appear by summons.
- 118. When anyone be summonsed, he must immediately appear without hesitation.
- 119.If a man summonsed does not appear or refuses to appear to answer,
- 120. Then let him be seized by force to come and attend.
- 121. When anyone who has been summonsed seeks to evade, or attempts to flee,
- 122.Let the one who summons lay hands on them to prevent their escape.
- 123.One who flees fair judgment confesses his culpability.
- 124. The accused cannot be judged until after the accusations be spoken,
- 125.And then after the accused exercises or declines their free rights to defense,
- 126. The first being Prolocution and the right to speak as a matter of law,
- 127. And why the complaint and investigation should not continue,

128. The second being Collocution as to why the complaint and accusation is false,

- 129.And upon such proof why the burden should now be placed on the accuser,
- 130.And the third being Adlocution being a final speech in defense,
- 131. Against a complaint or accusation having been heard.
- 132.If illness or old age hinder the appearance of the one summonsed,
- 133.Let the one who made the summons provide a basic means of transport.
- 134. When men wish to settle their dispute among themselves,
- 135. Then they shall have the right to make peace.
- 136.If a dispute cannot be settled before seeking a judge,
- 137. Then both the accused and the accuser must be granted equal hearing.
- 138.An accused cannot be found culpable unless three pieces of evidence may be attributed.
- 139.Judges are bound to explain the reason of their judgment.
- 140. The setting of the sun shall be the extreme limit of time within,
- 141. Which a judge must render his decision.
- 142. These be the foundations of Due Process.
- 143. These be the foundations of Rule of Law and Justice.
- 144. Any law that is against such truth, cannot be law.

SAVE YOURSELF

There is no short cut, only by living in Virtue, living in Truth, Honor and Integrity with full competence can we defeat the Mind Virus. To see through the fraud and fear programs and create a flourishing world of better ideas within our mind, in order to cocreate a world of need not greed, caring and sharing founded on the living True Rule of Law. To do this we need proper knowledge as this is the only true remedy.
